RESOLUTION No. 9 OF 1996

TRANSFORMATION OF POSTS IN THE OCCUPATIONAL CLASS: EDUCATION SYSTEMS OFFICER TO EDUCATOR POSTS

- 1. The parties to the Education Labour Relations Council note the following:
 - 1.1 The occupational class: Education Systems Officer was created in the Department of Education for purposes of appointing officials with an educational background to assist the Minister of Education with that part of his portfolio which is concerned with education matters at national level. Appointments to these posts are made in terms of the Public Service Act and the conditions of service are determined in terms of an applicable PAS. The present incumbents of these posts are mostly former CS educators, University and Technikon educators and former officials from NGO's.
 - 1.2 Due to problems which occur frequently with respect to the conditions of service of these personnel in comparison with post level 7 educators (new post level 5) the Minister of Education, after obtaining the approval of the Department of Public Service and Administration, intends to transform these posts to educator posts.
 - 1.3 Transformation of these posts to educator posts will imply that the salaries and other conditions of service of educators will become applicable to them.
 - 1.4 Requests were received for educators in some cases not to be required to be in possession of a teacher qualification, for example in the Higher Education component of the Department of Education.
- 2. The parties therefore agree in terms of section 12 of the Educators' Employment Act, 1993 (Act No. 146 of 1993) that:
 - 2.1 Resolution 6 of 1996 be augmented by adding the following paragraph to the exceptions under Paragraph F.2: Minimum Requirements for Appointment: Academic qualifications:

Educator posts outside education institutions:

The Minister may determine that the above-mentioned qualifications do not include teacher training in cases where teacher training is not a prerequisite to perform the duties attached to the specific educator post. The Minister shall approve this relaxation of entry requirements in respect of each individual and the number of relaxations may, in total not exceed 100 educators without negotiating further relaxations in the Council: Provided that when the Minister makes use of this discretion he tables information on the number or persons who have been awarded relaxation and the details of their posts in the ELRC. Where possible and all things being equal, preference should be given to persons with teacher qualifications for appointment in this type of posts.

- 2.2 The salaries of the staff involved be adjusted with effect from 1 July 1996, as indicated in Annexure A.
- 2.3 The Minister be requested to extend the agreement in terms of section 12 (6) of Act No. 146 of 1993 and to make it applicable to and binding to all employers and employees as defined in the Act.
