PROVISION OF CERTAIN LAND FOR SETTLEMENT ACT, 1993

DESIGNATION OF CERTAIN LAND SITUATED IN THE DISTRICT OF VRYHEID, PROVINCE OF KWAZULU-NATAL

Under sections 2 (1) (c) and 2 (3) of the Provision of Certain Land for Settlement Act, 1993 (Act No. 126 of 1993), read with President's Minute No. 13 of 10 June 1994, I, Derek Andre Hanekom, Minister of Land Affairs, hereby designate Portion 3 of the farm Rietfontein 212 and Portion 1 of the farm Beroofd 107, situated in the District of Vryheid, Province of KwaZulu-Natal, for the purposes of settlement; and hereby impose the following conditions for the use of the designated land:

- (i) The land shall be held by a legal entity that can be registered in terms of the Communal Property Association Act, No. 28 of 1996 for the benefit of not more than 53 identified families.
- (ii) Due to the urgent nature of project, settlement may occur immediately. A development plan must be submitted to the Director-General: Land Affairs for approval by 31 July 1996 in terms of which further settlement and development will take place. This plan shall indicate the support of the relevant provincial or local authorities and legal entity.
- (iii) The Conservation of Agricultural Resources Act, 1983 (Act No. 43 of 1983), shall apply to the utilisation of the land.
- (iv) In order to prevent the pollution of public water, the legal entity must ensure that the conditions of the Water Act, 1956 (Act No. 54 of 1956), are applied.

- (iv) Ten einde die besoedeling van openbare water te voorkom, moet die Trust verseker dat die bepalings van die Waterwet, 1956 (Wet No. 54 van 1956), nagekom word.

NOTICE 1097 OF 1996
SOUTH AFRICAN LAW COMMISSION

The South African Law Commission has published a discussion paper on **unconscionable stipulations** in contracts for general information and comment. Contracts are daily concluded in the expectation that they will satisfy the needs and aspirations of the contracting parties. It may only subsequently be realised that, in practical application, the contract or some of its terms are unjust or unconscionable. The question considered in this discussion paper is whether the courts should be able to grant relief in these circumstances by either setting aside the contract or modifying its terms. There is concern that any tampering with the binding force or sanctity of contracts will destroy legal and commercial certainty, because contracting parties will not know whether or not their agreements will be modified to the detriment of one or the other. It is alleged further that the consequences of giving such a power to the courts will be counter-productive as far as the weak, the uneducated and the economically disadvantaged are concerned, since nobody will be prepared to conclude contracts with them. It is also argued that such a power of review is unnecessary since such persons are sufficiently protected by the rules relating to justifiable mistake, duress, undue influence and fraudulent, negligent and innocent misrepresentations, and by the provisions of the laws relating to usury, credit agreements, etc.

With the rise of the movement for consumer protection in the early seventies, it became the generally accepted view in most first world countries that legislative action was required to deal with contractual unconscionability. The South African proponents of granting such a power of review to the courts support legislation that will introduce the doctrine of unconscionability and the concomitant review power of the courts. They consider it necessary to define the scope and extent of such a power, however. Furthermore, the question is being asked whether the "unconscionability" or the "good faith" approach should be followed. In the end, the two approaches may be thought to lead to the same result. When considering the historical background of the South African law, and taking into account the general use of the unconscionability approach by the legal systems close to our own, the unconscionability criterion is considered advisable.

Some argue that, whether one approaches the matter from the viewpoint of unconscionability or good faith, the courts will need guidelines to limit their powers of intervention but also to indicate the ambit of the intended doctrine. The Commission is opposed to the enactment of any guidelines. It believes that the laying down of guidelines by legislation may result in the courts considering themselves bound exclusively by those guidelines. The next question is whether the review power of the courts should extend to all types of contracts, to non-consumer transactions, to international agreements or to standard term contracts only. The Commission believes that no exceptions should be made to the provisions relating to good faith. It therefore proposes that the provisions of the Bill proposed in this paper should apply to all contracts concluded after the commencement of the Bill and, furthermore, that the Bill should be binding upon the State. Finally, there is the problem of waiver of the benefits of the Bill. The Commission is of the view that to allow the waiver of the provisions of the Bill would neutralise the efficacy of the Bill. It proposes that any agreement or contractual term purporting to exclude the provisions of the Bill or to limit its application should be void.

This issue and other options for the improvement of the law need to be debated thoroughly. Based on the outcome of such discussions legislation in respect of unconscionable contractual terms will be proposed to the Minister of Justice. The comments of all parties who feel that they have an interest in this topic or who may be affected by the type of measures discussed in this paper are therefore of vital importance to the Commission. All respondents are invited to indicate whether there are any other issues and/or options that they feel should be explored. **All interested parties likely to be affected by possible legislation should participate in this debate.**

Die Suid-Afrikaanse Regskommissie het 'n besprekingstuk oor **onbillike kontrakbedinge** vir algemene inligting en kommentaar vrygestel. Kontrakte word daagliks gesluit in die verwagting dat hulle aan die behoeftes en strewes van die kontrakterende partye sal voldoen. Daar word moontlik eers later beseft dat die kontrak of sommige van die bedinge, wanneer dit in die praktyk toegepas word, onregverdig of onbillik is. Die vraag wat in die besprekingstuk oorweeg word, is of die houe in staat moet wees om in hierdie omstandighede hulp te verleen deur óf die kontrak tersyde te stel óf die bedinge te wysig. Daar is kommer dat enige inmenging in die bindende krag of onskendbaarheid van kontrakte regs- en handelsekerheid sal vernietig aangesien kontrakterende partye nie sal weet nie of hulle ooreenkomste tot nadeel van die een of die ander gewysig sal word al dan nie. Daar word verder beweer dat die gevolge daarvan om sodanige bevoegdheid aan die houe te verleen, teenproduktief sal wees sover dit die magteloses, die ongeskooldes en die ekonomies agtergeblewendes raak, aangesien niemand bereid sal wees om kontrakte met hulle te sluit nie. Daar word ook geargumenteer dat sodanige hersieningsbevoegdheid onnodig is aangesien sulke persone voldoende beskerm word deur die reëls ten opsigte van regverdigbare dwaling, dwang, onbehoorlike beïnvloeding en bedrieglike, nalatige en onopsetlike wanvoorstelling, en deur die regsreëls ten opsigte van woekerrente, kredietooreenkomste, ens.

Met die opkoms van die verbruikerbeskermingsbeweging in die vroeë sewentigerjare het dit die algemeen aanvaarde siening in die meeste eerswêreldlande geword dat statutêre optrede teen kontraktuele onbillikheid nodig is. Die Suid-Afrikaanse voorstanders van die verlening van sodanige hersieningsbevoegdheid aan die houe steun wetgewing wat die leerstuk van onbillikheid en die gepaardgaande hersieningsbevoegdheid van die houe sal invoer. Hulle beskou dit egter as noodsaaklik dat die bestek en omvang van sodanige bevoegdheid omskryf moet word. Die vraag word verder gevra of 'n benadering van *onbillikheid* of van *goeie trou* gevolg moet word. Uiteindelik kan gemeen word dat die twee benaderings tot dieselfde resultaat sal lei. Wanneer die historiese agtergrond van die Suid-Afrikaanse reg en die algemene gebruik van die onbillikheidsbenadering deur regstelsels wat nou verwant aan ons eie in ag geneem word, word die onbillikheidsmaatstaf as aanbevelenswaardig beskou.

Sommige persone redeneer dat, of 'n mens nou die aangeleentheid uit die oogpunt van onbillikheid dan wel van goeie trou benader, die howe riglyne sal nodig hê om hulle ingrypingsbevoegdhede te beperk maar ook om die trefwydte van die voorgestelde leerstuk aan te dui. Die Kommissie is teen die neerlê van enige riglyne gekant. Die Kommissie meen dat die neerlê van riglyne daartoe kan lei dat die howe hulle uitsluitlik aan daardie riglyne gebonde sal ag. Die volgende vraag is of die hersieningsbevoegdheid van die howe vir alle tipes kontrakte, vir nie-verbruikerstransaksies, vir internasionale ooreenkomste of net vir standaardkontrakte moet geld. Die Kommissie meen dat geen uitsonderings op die bepalinge betreffende goeie trou gemaak moet word nie. Die Kommissie stel gevolglik voor dat die bepalinge van die wetsontwerp wat in die besprekingstuk voorgestel word, op alle kontrakte gesluit na die inwerkingtreding van die wetsontwerp van toepassing moet wees en verder dat die wetsontwerp ook die staat moet bind. Ten slotte is daar die probleem van die afstanddoening van die beskerming van die wetsontwerp. Die Kommissie meen dat die doeltreffendheid van die wetsontwerp geneutraliseer sou word indien afstanddoening van die bepalinge van die wetsontwerp toegelaat sou word. Die Kommissie stel voor dat enige ooreenkoms of kontraktuele beding waardeur voorgegee word dat die bepalinge van die wetsontwerp uitgesluit word of beperk word, nietig moet wees.

Daar moet deeglik oor hierdie aangeleentheid en ander moontlikhede vir die verbetering van die reg debat gevoer word. Op grond van die resultaat van sulke besprekings sal wetgewing met betrekking tot onbillike kontrakbedinge aan die Minister van Justisie voorgestel word. Die kommentaar van alle partye wat meen dat hulle 'n belang by die onderwerp het of dat hulle geraak sal word deur die soort maatreëls wat in die dokument bespreek word, is van deurslaggewende belang vir die Kommissie.
