### NOTICE 1466 OF 1996

#### DEPARTMENT OF AGRICULTURE

#### NOMINATION OF CANDIDATES FOR APPOINTMENT TO THE NATIONAL AGRICULTURAL MARKETING COUNCIL

The current Marketing Act, 1968 (Act No. 59 of 1968), is being replaced by the **Marketing of Agricultural Products Act, 1996 (Act No. 47 of 1996)**. The new Act makes *inter alia* provision for the revised composition of a National Agricultural Marketing Council.

The functions of the National Agricultural Marketing Council, as fully set out in the Act, include investigations and advice to the Minister regarding agricultural marketing policy and its application. The Minister for Agriculture and Land Affairs hereby invites persons and interested parties to submit to him names of nominees to be considered for appointment as members of the National Agricultural Marketing Council.

The nominees will be considered for appointment by virtue of their practical knowledge and experience of one or more of the following, namely—

- (a) the commercial production of agricultural products;
- (b) agricultural product-related trade and industry;
- (c) agricultural economics, including agricultural marketing and international agricultural trade;
- (d) consumer issues relating to agricultural products, including issues relating to previously disadvantaged communities; and
- (e) the production and marketing of agricultural products by small-scale and previously disadvantaged farmers.

Members of the Council will be appointed for a period not exceeding four years. Compensation will be payable on a full-time or part-time basis, depending on the case.

Each nomination must be accompanied by the following:

- (1) A *curriculum vitae* with two independent references; and
- (2) a written acceptance of the nomination by the nominee.
- (3) The nominee must give an indication if he/she is available for a permanent or a part-time appointment.

**KENNISGEWING 1466 VAN 1996**

**DEPARTEMENT VAN LANDBOU**

**NOMINERING VAN KANDIDATE VIR AANSTELLING OP DIE  
NASIONALE LANDBOUBEMARKINGSRAAD**

Die huidige Bemerkingswet, 1968 (Wet No. 59 van 1968), word vervang met die **Wet op die Bemaking van Landbouprodukte, 1996 (Wet No. 47 van 1996)**. Die nuwe Wet maak onder andere voorsiening vir 'n hersiene samestelling van die Nasionale Landbouemarkingsraad.

Die funksies van die Nasionale Landbouemarkingsraad, wat volledig in die Wet uiteengesit is, sluit in ondersoek en advies aan die Minister aangaande landbouemarkingsbeleid en die toepassing daarvan. Die Minister vir Landbou en Grondsake nooi hiermee persone en belanghebbendes uit om die name van genomineerdes aan hom voor te lê wat oorweeg kan word vir aanstelling as lede van die Nasionale Landbouemarkingsraad.

Die genomineerdes sal oorweeg word vir aanstelling op grond van hulle praktiese kennis en ervaring van een of meer van die volgende, naamlik—

- (a) die kommersiële produksie van landbouprodukte;
- (b) landbouprodukverwante handel en nywerheid;
- (c) landbou-ekonomie, met inbegrip van landbouemarking en internasionale landbouhandel;
- (d) verbruikersaangeleenthede met betrekking tot landbouprodukte, met inbegrip van aangeleenthede met betrekking tot voorheen benadeelde gemeenskappe; en
- (e) die produksie en bemaking van landbouprodukte deur kleinmaat- en voorheen benadeelde boere.

Lede van die Raad word aangestel vir 'n tydperk van hoogstens vier jaar. 'n Vergoedingstoelaag is op 'n voltydse of deeltydse basis betaalbaar, na gelang van die geval.

Elke nominasie moet vergesel wees van die volgende:

- (1) 'n *Curriculum vitae* met twee onafhanklike referente; en
- (2) 'n skriftelike aanvaarding van die nominasie deur die genomineerde.
- (3) Die genomineerde moet aandui of hy/sy in 'n heeltydse of deeltydse hoedanigheid aangestel wil word.

Nominasies moet die adres wat hieronder verskyn, nie later as 1 November 1996 bereik nie.



