# ACT

To provide for the extension of the application of certain laws relating to agricultural matters to certain territories which form part of the national territory of the Republic of South Africa; the repeal of certain laws which apply in those territories; and for matters connected therewith.

*(Afrikaans text signed by the President.)  
(Assented to 12 November 1996.)*

**B**E IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

## Definitions

1. In this Act, unless the context otherwise indicates—  
“affected area” means the national territories of the former Transkei, Bophuthatswana, 5  
Venda and Ciskei, and the territories of the former self-governing territories of  
Gazankulu, KaNgwane, KwaNdebele, KwaZulu, Lebowa and Qwaqwa, as they existed  
immediately prior to the commencement of the Constitution of the Republic of South  
Africa, 1993 (Act No. 200 of 1993);  
“Minister” means the Minister of Agriculture. 10

## Extension of laws

2. The laws mentioned in Schedule 1 are hereby made applicable to the extent specified in the third column thereof, to every area which immediately prior to 27 April 1994 formed part of the affected area.

## Repeal of laws 15

3. The laws mentioned in Schedule 2 are hereby repealed to the extent indicated in the third column thereof.

## Regulations and notices

4. All regulations and notices promulgated or issued by the Minister in terms of any law mentioned in Schedule I shall apply also in the affected area. 20

## Savings in respect of pending proceedings

5. (1) Nothing in this Act shall affect any legal proceedings which are pending at the commencement of this Act, and such proceedings shall be continued and concluded as if this Act had not been passed.

(2) In the application of subsection (1) legal proceedings shall be deemed to be 25  
pending at the commencement of this Act—

- (a) in the case of civil proceedings, if a summons has been issued but judgment has not been given; and
- (b) in the case of criminal proceedings, if the accused has pleaded but judgment and sentence have not been given and imposed. 30

# WET

**D**AAR WORD BEPAAL deur die Parlement van die Republiek van Suid-Afrika soos volg:—

## Woordomskrywing

1. In hierdie Wet, tensy uit die samehang anders blyk, beteken—
- 5 “geaffekteerde gebied” die nasionale gebiede van die voormalige Transkei, Bophuthatswana, Venda en Ciskei, en die gebiede van die voormalige selfregerende gebiede Gazankulu, KaNgwane, KwaNdebele, KwaZulu, Lebowa en QwaQwa, soos hulle onmiddellik voor die inwerkingtreding van die Grondwet van die Republiek van Suid-Afrika, 1993 (Wet No. 200 van 1993), bestaan het;
- 10 “Minister” die Minister van Landbou.

## Uitbreiding van wette

2. Die wette in Bylae 1 vermeld, word hierby van toepassing gemaak, in die mate in die derde kolom daarvan aangedui, op elke gebied wat onmiddellik voor 27 April 1994 deel van die geaffekteerde gebied uitgemaak het.

## 15 Herroeping van wette

3. Die wette in Bylae 2 vermeld, word hierby herroep in die mate in die derde kolom daarvan aangedui.

## Regulasies en kennisgewings

4. Alle regulasies en kennisgewings deur die Minister uitgevaardig of gegee
- 20 ingevolge enige wet in Bylae 1 vermeld, is ook in die geaffekteerde gebied van toepassing.

## Voorbehoud ten opsigte van hangende verrigtinge

5. (1) Niks in hierdie Wet beïnvloed enige regsverrigtinge wat by die inwerkingtreding van hierdie Wet hangende is nie, en sodanige verrigtinge word voortgesit en
- 25 afgehandel asof hierdie Wet nie aangeneem is nie.

(2) By die toepassing van subartikel (1) word regsverrigtinge geag hangend te wees by die inwerkingtreding van hierdie Wet—

- (a) in die geval van siviele verrigtinge, indien 'n dagvaarding uitgereik is, maar uitspraak nog nie gelewer is nie; en
- 30 (b) in die geval van strafregtelike verrigtinge, indien die beskuldigde gepleit het, maar uitspraak en vonnis nog nie gelewer en gevel is nie.

**Saving****6. (1) Nothing in this Act shall—**

- (a) affect the previous operation of any law made applicable by section 2 or repealed by section 3 or anything duly done or suffered under any law so made applicable or repealed; 5
- (b) affect any right, privilege, obligation or liability acquired, accrued or incurred under any law so made applicable or repealed;
- (c) affect any penalty, forfeiture or punishment imposed or incurred in respect of any offence committed in terms of any law so made applicable or repealed;
- (d) affect any appointment to any office made in terms of any law repealed by this Act, if a corresponding law mentioned in Schedule 1 also provides for such an appointment, and anything done in connection with or by virtue of any such appointment shall be deemed to have been done under such corresponding law. 10

(2) A co-operative, co-operative society or co-operative company which has been registered in terms of any law repealed by section 3, shall be deemed to be a co-operative which has been registered in terms of the Co-operatives Act, 1981 (Act No. 91 of 1981), made applicable by section 2. 15

**Short title**

7. This Act shall be called the Agriculture Laws Extension Act, 1996. 20
