PUBLICATIONS ACT, 1974

FILM

A Committee of Publications under section 25 (3) of the Publications Act, 1974, as amended, has decided that the undermentioned film is not undesirable within the meaning of section 47 (2) of the Act by stipulating—

- (a) that it may not be exhibited to persons under 18 years of age; and
- (b) that the distributor issue a warning to viewers, indicating that it is a film for adults with nudity, violence and crude language as indicated by the letters NVL.
