#### CORRECTION NOTICE

Government Notice No. R. 189 of 31 January 1997, published in *Government Gazette* No. 17767 of 31 January 1997, is hereby amended by adding the following area to the area defined in the Schedule thereto:

##### "UMZIMKULU

Kraal and Langgewacht, Konings Fontein (G.E.Q. 817), Woodlands (G.E.Q. 637), Ben Cairnie (G.E.Q. 810), Olifants Hoek (G.E.Q. 626), Uitkomst (G.E.Q. 625), Waterfall (G.E.Q. 1819), Poortje (G.E.Q. 819) and New Wales (G.E.Q. 87), to its northernmost beacon common to it and Arnolds (G.E.Q. 1022); thence along the boundaries of the said Arnolds and Snowdon (G.E.Q. 1028) to its northernmost beacon common to it and Glengyle (G.E.Q. 446) so as to exclude them from this area; thence along the boundaries of the following properties so as to include them within this area: The said Glengyle, Milton (G.E.Q. 442) and Mount Pleasant (G.E.Q. 441) to the beacon first named.”

#### **1. Introduction**

The Business Practices Committee was established in terms of section 2 of the Harmful Business Practices Act, 1988 (Act No. 71 of 1988) (the Act). The purpose of the Act is to provide for the prohibition or control of harmful business practices. A "harmful business practice" is defined in the Act as any business practice which, directly or indirectly, has or is likely to have the effect of harming the relations between businesses and consumers; unreasonably prejudicing any consumer or deceiving any consumer.

#### **2. The preliminary investigation**

The Committee received a request during August 1995 to investigate the business practices of Ultracare Medical (Pty) Limited (Ultracare).

On 29 August 1995 a subcommittee of the Committee resolved to institute a preliminary investigation in terms of section 4 (1) (c) of the Act into the business practices of Ultracare and any of its directors, employees, agents and/or representatives.

Investigating officers (officers) of the Committee visited the office of Ultracare on 6 September, 19 October and 16 November 1995. The directors of Ultracare are Mr R. A. Vermaak, Ms E. M. Vermaak and Mr B. D. G. S. Geddes. Ultracare is conducting its business from a house in the new residential area of Rynfield Extension 10, Benoni.

Ultracare states in its brochures that its mission is "to strive to remain experts in the health care management market, operated by the administrators for the sole benefit of the applicants through the provision of agreed benefits and resources necessary to enable members quality health care".

In its brochures and membership application form Ultracare stresses that it is not a medical aid scheme but a marketer and administrator of medical health care. Ultracare has approximately 205 members.

Ultracare markets two medical hospitalisation benefit plans and one minor medical day-to-day "savings" plan. The contributions for the three plans can vary according to the age, number of dependants and needs of each individual member. The investigating officers were told that a member can make use of the "savings" plan and that it is not compulsory for a member to subscribe to any of the hospitalisation cover plans. In the application forms members agree to pay Ultracare an once-off subscription fee equivalent to a month's contribution. Members furthermore agree to the deduction of an administration fee of 10 per cent of the monthly contribution. After deducting the portion to be paid over to the two hospitalisation plans, the remainder went as a credit balance to the "savings" plan of the member.

### **3. Hospitalisation plans**

The one hospitalisation benefit plan is a limited cover scheme where the medical aid cover for hospitalisation benefits is limited to an amount of R10 000. This scheme includes the payment for doctors and medicine while the member is hospitalised. This plan is administered by Protea Medical Aid Society ("Protea").

The other hospitalisation benefit plan is a major medical expense scheme plan ("M M E") where the medical aid cover for hospitalisation is in excess of R10 000 but not exceeding R500 000. This scheme is underwritten by underwriters of Lloyd's of London and administered by General & Medical Administrators (Pty) Limited. The benefits are also payable only while the member is hospitalised.

### **4. Ultracare's minor out of hospital "savings" plan**

This "savings" plan for minor claims provides for the occasional payment of medical claims not covered by the above hospitalisation plans. When a member is not hospitalised he/she can claim for medicine expenses incurred and consultation fees. A member thus entrusts monthly to Ultracare an amount of money to be utilized for incidental or occasional day to day medical claims while not in hospital. The amount to be paid into the "savings" plan depends on the member's needs and his/her available finance. It is not a predetermined amount for all members. A member can increase or reduce the monthly contribution to the "savings" plan. The amount to be paid out from this "savings" plan depends on the extent of the credit accrued to the member from time to time in the books of Ultracare. If inadequate credit is available in a member's account, then a partial payment towards the claim will be made until sufficient funds have been received to pay out the balance of the claim.

Concern was voiced about the security of the funds paid by members into the "savings" plan account. This latter plan forms the basis of the investigation.

### **5. vi The formal investigation**

On 20 September 1995 the Committee resolved to institute a formal investigation in terms of section 8 (1) (a) of the Act into the business practices of Ultracare Medical (Pty) Limited, Mr R. A. Vermaak, Ms E. M. Vermaak, Mr B. D. G. S. Geddes, and any employee, agent or representative of the said concern. Notice of this investigation was given in *Government Gazette* No. 16683 of 29 September 1995. The Chairman of the Committee also issued a press release about the investigation published in the *Government Gazette*.

The Committee did not receive any oral or written complaints against Ultracare from members of the public after publication of the notice of the investigation. The findings and conclusions contained in this report therefore are based on the information that was obtained by the investigating officers.

### **6. Financial and accounting system**

Ultracare uses a manual bookkeeping system and intends to use a commercial accounting computer programme in the future. Each member has two files, an underwriter file and a minor day-to-day incidents file. In the latter file all correspondence relating to claims of the "savings" plan are recorded.

A general cash book as well as an individual ledger account for each member are kept. The cash book is divided into the following columns and the contributions are allocated accordingly:

- (i) Total contribution received.
- (ii) M M E plan.
- (iii) Protea plan.
- (iv) "Savings" plan.
- (v) 10 per cent administration fee.
- (vi) R20 overrider fee.

The ledger account reflects the amounts received for the "savings" plan, the payments made and the credit balance of each member's "savings" account. It is the credit balances which are utilized by Ultracare to pay the incidental out-of-hospital claims by members.

Ultracare makes use of a number 1 and a number 2 cheque account. The contributions received for the hospitalisation plans and the "savings" plan are deposited in Account No. 1. The contributions include the 10 per cent monthly administration fee and an overrider fee of R20 payable to consultants and agents.

All payments relating to the administration of the hospitalisation and "savings" plans are made by cheque from Account No. 1. Cheques for claims from the "savings" plan are made payable to the members and not to third parties. A cheque is drawn from Account No. 1 for the 10 per cent administration and overrider fee and is deposited into Account No. 2.

Account No. 2 is used by Ultracare to pay for normal business expenses such as salaries, water and lights, rates and taxes, entertainment, instalment payments for equipment and rental. The initial subscription fee is also deposited into Account No. 2.

Ultracare acts as an insurance broker and receives short-term insurance premiums on behalf of M M E and Protea. Ultracare is obliged in terms of section 20bis (2) and (3) of the Insurance Act, 1943 (Act No. 27 of 1943), to furnish security for the premiums collected. The Insurance Act, 1943, requires that the security should be in the form of a guarantee. The amount of the guarantee has to be equal to 20 per cent of the premiums which become due. The amount of the guarantee may not be less than R10 000 and not more than R50 million. Ultracare obtained the required guarantee from Intermediaries Guarantee Facility Limited, a registered insurer.

According to the definition in section 20bis of the Insurance Act, 1943, the funds that are allocated to the "savings" plan of members do not constitute premiums and therefore are not covered in terms of the guarantee issued.

## 7. The harmful business practice

The investigation reveals that there are no safeguards in place to protect the "savings" plan funds of the members. This fact constitutes a potential harmful practice which is likely to have the effect of harming the relations between the members and Ultracare and can result in harm to members.

## 8. Conclusion and recommendation

The Committee is of the opinion that the method of holding funds as practised by Ultracare can result in serious harm to the members. It is also the Committee's view that the member's funds in the "savings" plan ought to be secured either by depositing the funds in a trust account with an attorney or taking out some form of fidelity or guarantee insurance with a registered insurer. The directors of Ultracare were invited to meet the Committee on two occasions. Mr Geddes could not attend the meeting of 30 November 1995 due to an unforeseeable hospitalisation. The other directors did not attend the meeting or render any apology. A further meeting between Mr Geddes and the Committee was arranged for 29 January 1996. Mr Geddes did not turn up and no explanation was received from him. A letter was faxed to Ultracare explaining that the directors non-attendance of the meeting were prejudicing their case. Ultracare was furthermore informed that the Committee intends to proceed in the normal manner and will make a recommendation to the Minister of Trade and Industry regarding the business practices as applied by Ultracare. No reply was received from any of the directors of Ultracare since the letter was forwarded by fax and posted to Ultracare on 16 February 1996.

The Committee thereafter directed the investigating officers to approach the officials of Ultracare and to present them with the Committee's view that they should take out some form of fidelity or guarantee insurance to safeguard the interest of members in the "savings" plan account. The meeting took place and Ultracare indicated their willingness to take out insurance.

Ultracare, subsequently provided proof that the necessary guarantee in the form of a fidelity guarantee and errors and omissions insurance were taken out with a registered insurance company.

It is the Committee's view, that as the "savings" plan funds are now secured by fidelity or guarantee insurance, the said "savings" plan can result in no harm to the members provided that the necessary insurance remains in place.

*In view of the above, the Committee recommends that the Minister takes no steps in terms of section 12 of the Act.*

**INVESTIGATION IN TERMS OF SECTION 10 (1) OF THE MAINTENANCE AND PROMOTION OF COMPETITION ACT, 1979 (ACT NO. 96 OF 1979)**

The relationship between a number of video store owners and two of the principal distributors of films on video tape, namely Ster-Kinekor Video (Pty) Ltd and Nu Metro Video (Pty) Ltd, has in recent times been characterised by dissent and recrimination. Disputes between dealers and distributors are, of course, not a new phenomenon in the home video industry. For example, in 1989–90 the Board was obliged to intervene when it became apparent that certain distributors were engaging in restrictive practices. Following an investigation certain restrictive practices were declared unlawful by the Minister (Notice No. 2882 Government Gazette No. 12876 of 7 December 1990).

The complexities and the competition law implications of the relevant issues raised by the latest round of allegations and counter allegations, coupled with the irreconcilable differences of opinion between the distributors and dealers on those issues, requires a formal investigation.

The Competition Board accordingly hereby gives notice that it is undertaking an investigation in terms of section 10 (1) (a) of the Maintenance and Promotion of Competition Act, 1979 (Act No. 96 of 1979) (the Act), to determine whether—

- (a) the current pricing policies of Ster-Kinekor Video (Pty) Ltd and Nu Metro Video (Pty) Ltd, including the discounts allowed for the volume and range of product purchased, and
