RATE OF INTEREST ON GOVERNMENT LOANS

It is hereby notified that the Minister of Finance has, in terms of section 26 (1) of the Exchequer Act, 1975 (Act No. 66 of 1975), fixed the standard interest rate applicable from 1 April 1997 and until further notice, to loans granted by the State out of the State Revenue Fund, at fifteen comma five nil per cent (15,50%) per annum.





The petition was lodged by Mondi Cartonboard, which is the sole manufacturer of the white lined coated paperboard in reels and sheets in the Republic of South Africa. The petitioner alleges that it cannot compete with the low prices charged by the importers and that they are causing material injury. The petitioner submitted sufficient evidence to enable the Board to arrive at a reasonable conclusion that an investigation should be initiated on the basis of dumping, material injury and causality.

The product

The product allegedly being dumped is white lined coated paperboard in reels or sheets, classifiable under tariff subheadings 4810.12, 4810.29, 4810.91 and 4810.99, imported from or originating in Spain, Austria, Germany and The Netherlands.

The allegation of dumping

The allegation of dumping is based on the comparison between the normal value in The Netherlands, Germany, Spain and Austria, and the f.o.b. prices for export to South Africa of like products. On this basis the estimated dumping margins are not insignificant.

The allegation of material injury

With regard to material injury the petitioner alleges and submitted sufficient evidence to show that the imports in question are suppressing its selling prices and are gaining market share at the expense of the petitioner. It is further alleged that the prices at which these imports are sold in South Africa significantly undercut the already suppressed prices of the South African producer, resulting in lower profit margins.

Procedure

Having decided that there is sufficient evidence to justify the initiation of an investigation, the Board has begun an investigation in terms of section 4 of the Board on Tariffs and Trade Act, 1986. In order to obtain the information it deems necessary for its investigation, the Board will send questionnaires to all known importers and exporters, and known representative associations. The trade representative of the exporting country will also be notified. Importers, exporters and interested parties are invited to contact the Board as soon as possible in order to determine whether they have been listed and sent a questionnaire. If not they should request a copy of the questionnaire as soon as possible. It has to be completed, and any other representations must be made, within the time limit set out below.







DRAFT**ORGANISED LOCAL GOVERNMENT BILL**

To provide for the recognition of national and provincial organisations representing municipalities; to determine procedures by which local government may designate representatives to participate in the National Council of Provinces; to determine procedures by which local government may nominate persons to the Financial and Fiscal Commission; and to provide for matters incidental thereto

BE IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

Definitions

1. In this Act, unless the context otherwise indicates—

- (i) "MEC" means the member of the executive council responsible for local government in the province concerned;

- (ii) "**Minister**" means the Minister for Provincial Affairs and Constitutional Development;
- (iii) "**municipality**" means a municipality as defined in section 10B of the Local Government Transition Act, 1993 (Act No. 209 of 1993);
- (iv) "**national organisation**" means the organisation recognised in terms of section 2 (1);
- (v) "**provincial organisation**" means the organisation recognised in terms of section 2 (2).

Recognition of national and provincial organisations

2. (1) The Minister may subject to subsection (3), by notice in the *Gazette*, recognise one national organisation representing the majority of provincial organisations referred to in subsection (2).

(2) The Minister may, with the concurrence of the MEC, and subject to subsection (3), by notice in the *Gazette*, recognise one organisation in each province, representing the majority of municipalities in that province.

(3) The Minister shall by notice in the *Gazette*, determine criteria for the recognition of the organisation referred to in subsection (1) and the organisations referred to in subsection (2).

(4) (a) The Minister may, if he or she is of the opinion that an organisation recognised in terms of subsections (1) or (2) does not comply with the criteria referred to in subsection (3), and after giving the organisation concerned 30 days notice of his or her intention to do so, subject to paragraph (b), withdraw the recognition of such organisation.

(b) In the case of an organisation contemplated in subsection (2), the Minister must act in concurrence with the MEC.

Designation of representatives to participate in the National Council of Provinces

3. (1) For the purposes of section 67 of the Constitution of the Republic of South Africa, 1996, and subject to subsection (2), local government may designate 10 representatives to participate in the National Council of Provinces by way of decisions of the national organisation made in terms of procedures determined by internal rules of that organisation.

(2) Of the 10 representatives designated in terms of subsection (1) two shall be members of each of the categories of municipalities referred to in paragraphs (a), (b) and (c) of section 155 (1) of the Constitution of the Republic of South Africa, 1996.

(3) Designations may be withdrawn and vacancies filled in accordance with subsection (1).

(4) The head of the administration of the national organisation shall inform the Secretary of the National Council of Provinces in writing of any designation made or withdrawn and of any vacancies that may occur.

(5) Whenever the recognition of an organisation is withdrawn in terms of section 2 (4) any designations made by that organisation will lapse.

Nomination of persons to the Financial and Fiscal Commission

4. (1) Subject to the provisions of section 243 (5) and the Act contemplated in section 220 of the Constitution of the Republic of South Africa, 1996, the national organisation shall whenever necessary nominate two persons for appointment by the President as members of the Financial and Fiscal Commission in terms of section 221 of the Constitution of the Republic of South Africa, 1996.

(2) (a) The nomination contemplated in subsection (1) shall be done by way of decisions of the national organisation made in terms of procedures determined by internal rules of that organisation.

Repeal of laws and transitional arrangements

5. (1) Subject to subsection (2), section 10F of the Local Government Transition Act, 1993 (Act No. 209 of 1993), is hereby repealed.

(2) The organisations which have, on the date immediately prior to the date of the coming into operation of this Act, been recognised under section 10F of the Local Government Transition Act, 1993, shall be deemed to have been recognised in terms of section 2 of this Act.

Short title

6. This Act shall be called the Organised Local Government Act, 1997.

EXPLANATORY MEMORANDUM ON THE OBJECTS OF THE ORGANISED LOCAL GOVERNMENT BILL, 1997

Section 163 of the Constitution of the Republic of South Africa, 1996, determines that an Act of Parliament must provide for the recognition of national and provincial organisations representing municipalities, and to determine procedures by which organised local government may designate representatives to the National Council of Provinces (NCOP) and nominate persons to the Financial and Fiscal Commission (FFC).

In order to comply with the provisions of section 163 of the Constitution of the Republic of South Africa, 1996, provision is made in clause 2 of the Bill for the recognition of a national and nine provincial local government organisations representing municipalities.

Clause 3 of the Bill provides for the designation by the national organisation of representatives to participate when necessary in proceedings of the NCOP. Local Government's participation in the NCOP is important as this will ensure that local government will for the first time participate in the law making process when local government issues are at stake.

Clause 4 provides for the nomination of two persons by the national organisation for appointment by the President as members of the FFC in terms of section 221 of the Constitution of the Republic of South Africa, 1996. Municipalities are dependent on sufficient funds to exercise and perform their powers and duties. The participation of local government in the FFC is therefore of utmost importance as the Commission is *inter alia* responsible for making recommendations to Parliament in respect of the equitable division of revenue raised nationally among the national, provincial and local spheres of government.
