Any objections or representations should be submitted, in writing, to the Registrar of the Security Officers' Board, Private Bag X817, Pretoria, 0001.


# NOTICE WITH REGARD TO APPLICATION FOR RECOGNITION OF GRADING

- 1. A person who renders a security service and any employee of such a person, in any part of the Republic to which the Act has been extended in terms of the Security Officers' Amendment Act, 1996 (Act No. 64 of 1996), and who is registered at the Security Officers' Board on or before 4 August 1997 as a security officer, and whose registration is still in force on 4 August 1977, can apply to the Security Officers' Board for recognition of grading of Grades E to A. Such application must be submitted by the employer of such security officer in the form of a sworn statement in which it is certified that the level of competency of such security officer is in accordance with the applicable grades which recognition of grading is being applied for.
- 2. Security Officers not compelled to register in terms of section 1 (1) (b) of the Security Officers' Act, 1987 (Act No. 92 of 1987) (i.e. employees who render a security service on behalf of their employers), but who voluntarily register can, in a similar manner as stipulated in paragraph 1 above, make application for recognition of grading.
