Draft Regulations for National Standards Bodies (NSBs) to be established in terms of section 5(1)(b)(i) of the South African Qualifications Authority Act (Act 58 of 1995) are hereby published for comment by interested parties, prior to recommendations for their acceptance being submitted for Ministerial approval.
2. Comment is invited on the acceptability of the Draft Regulations and the appendices attached thereto.
3. In making comment consideration should be given to the need for the Draft Regulations to be:
 - a. framed in a manner conducive to their understanding and implementation by members of National Standards Bodies, Standards Generating Bodies and Education Training Quality Assurance bodies;
 - b. applicable to the development of the National Qualifications Framework, and
 - c. able to be implemented in practice.
4. For the information of those wishing to make comment, the following aspects are relevant:
 - a. twelve (12) National Standards Bodies are to be formed, one in each of the fields identified by name in the tables below;
 - b. National Standards Bodies will *inter alia* be required to recommend the registration of unit standards and qualifications on the National Qualifications Framework to the South African Qualifications Authority;
 - c. at the time of preparation of these regulations the South African Qualifications Authority is in the process of developing the National Qualifications Framework and its infrastructure. In order to enable the South African Qualifications Authority to proceed with the creation of a national qualifications framework certain decisions were taken or proposed, affecting the elements of the National Qualifications Framework and its application. These decisions, which affect the functioning of National Standards Bodies, Standards Generating Bodies and Education Training Quality Assurance bodies are reflected in the Draft Regulations and are to be applied by such bodies, on the understanding that the National Qualifications Framework is in the process of development and that these decisions will be revised from time-to-time.

SOUTH AFRICAN QUALIFICATIONS AUTHORITY: DRAFT REGULATIONS GOVERNING THE ACTIVITIES OF NATIONAL STANDARDS BODIES (NSBs)

(Scope: These regulations, which are a part of a series of regulations covering the activities of the sub-structures of the SA Qualifications Authority, are applicable to the activities of National Standards Bodies and should be read in conjunction with regulations applicable to Standards Generating Bodies and Education Training Quality Assurance bodies).

DEFINITIONS

1. In these Regulations, unless the context otherwise indicates-

“Act” means the SA Qualifications Authority Act, No 58 of 1995;

“Authority” means the SA Qualifications Authority (SAQA) established in terms of Section 3 of the Act;

“Applied competence” means the ability to put into practice in the relevant context the learning outcomes acquired in obtaining a qualification;

“Chairperson” means the Chairperson of the Authority;

“Committee” means any committee of the Authority referred to in section 7(1) of the Act;

“Core learning” of “Core” means that compulsory learning required in situations contextually relevant to the particular qualification;

“Critical Interest Group” means that organisation whose presence is essential to the success of the activities of the National Standards Body under consideration;

“Department” means the Department of Education and/or Labour

“Education Training Quality Assurance body” (ETQA) means a body established in terms of section 5(1)(a)(ii) of the Act, responsible for monitoring and auditing achievements in terms of national standards and qualifications, and to which specific functions relating to the monitoring and auditing of national standards and qualifications have been assigned in terms of section 5(1)(b)(i) of the Act;

“Elective learning” or Elective” means a selection of additional credits at the level

of the NQF specified, from which a choice may be made to ensure that the purpose(s) of the qualification is achieved;

“Executive Committee” means a committee established in terms of section 7(1) of the Act to carry out certain designated functions on behalf of the Authority;

“Executive Officer” means the person appointed by the Authority with the concurrence of the Minister to perform the functions designated in Section 6 of the Act;

“Field” or “Field of learning” means a particular area of learning used as an organising mechanism for the National Qualifications Framework;

“Fundamental learning” of “fundamental” means that learning which forms the grounding or basis needed to undertake the education, training or further learning required in the obtaining of a qualification;

“Integrated assessment” means that form of assessment which permits the learner to demonstrate applied competence and which uses a range of formative and summative assessment methods;

“Level Descriptor” means that statement describing a particular level of the eight levels of the National Qualifications Framework;

“Member” means a member of the Authority appointed by the Minister in terms of Section 4 of the Act;

“Minister” means the Minister of Education and, for the purposes of sections 4(2), 4(3), 4(4), 4(5), 4(6), 5(1)(c), 11, 13(2), 14 and 15(2), the Minister of Education in consultation with the Minister of Labour;

“National Standards Body” (NSB) means a body registered in terms of section 5(1)(a)(ii) of the Act, responsible for establishing education and training standards or qualifications, and to which specific functions relating to the registration of national standards and qualifications have been assigned in terms of section 5(1)(b)(i) of the Act;

“Qualification” means a planned combination of learning outcomes which has a defined purpose or purposes, and which is intended to provide qualifying learners with applied competence and a basis for further learning;

“Qualifying learner” shall mean a learner who has obtained a qualification;

“Recognition of Prior Learning” means the comparison of the previous learning and experience of a learner howsoever obtained against the learning outcomes

required for a specified qualification, and the acceptance for purposes of qualification of that which meets the requirements;

“Resolution” means a decision of the authority;

“Secretariat” means officers of the Department designated for this purpose to the Authority in terms of section 6(2) of the Act;

“Specialised learning” or “Specialisation” means that specialised theoretical knowledge which underpins application in the area of specialisation, and

“Standards Generating Body” (SGB) means a body registered in terms of section 5(1)(a)(ii) of the Act, responsible for establishing education and training standards or qualifications, and to which specific functions relating to the establishing of national standards and qualifications have been assigned in terms of section 5(1)(b)(i) of the Act.

INTRODUCTION

ESTABLISHMENT OF THE SOUTH AFRICAN QUALIFICATIONS AUTHORITY (SAQA)

2. The South African Qualifications Authority (SAQA, the Authority) was established in terms of the SAQA Act (Act 58 of 1995)(the Act) in October 1995 to “provide for the development and implementation of a National Qualifications Framework... and to provide for matters connected therewith”. A Chairperson and members were appointed in terms of Government Gazette No. 913 of 31 May 1996, with one seat for a discretionary appointment being left vacant. With this exception, SAQA as a body is representative of the key stakeholders in education and training.

3. The vision towards which SAQA strives is:

“Reconstructed and re-developed education and training which reflects the objectives of the National Qualifications Framework (NQF), which are to:

- create an integrated national framework for learning achievements;
- facilitate access to, and mobility and progression within education, training and career paths;
- enhance the quality of education and training;
- accelerate the redress of past unfair discrimination in education, training and employment opportunities; and thereby
- contribute to the full personal development of each learner and the social and economic development of the nation at large.”

MISSION

4. The mission, ie that which is to be done by the SAQA organisation in striving towards the vision is derived from the Act (Section 5) and is:

“To ensure the development and implementation of a National Qualifications Framework”.

FUNCTIONS OF THE AUTHORITY

5. The functions of the Authority (section 5 of the Act) derived from this mission and the Act are in essence to:

5.1 oversee the development of the National Qualifications Framework (NQF);

5.2 formulate and publish policies and criteria for -

- registration of bodies responsible for establishing education and training standards; and
- the accreditation of bodies responsible for monitoring and auditing achievements in terms of standards and qualifications;

5.3 oversee the implementation of the NQF, including -

- the registration of accreditation bodies and the assignment of functions to them;
- the registration of national standards and qualifications;
- ensuring compliance with the provisions for accreditation, and
- ensuring international comparability of standards and registered qualifications;

5.4 advise the Minister (of Education and of Labour) on registration of standards and qualifications; and

5.5 be responsible for the finances of SAQA.

PRINCIPLES

6. The principles, also derived from the Act, which guide the development and the functioning of SAQA are:

6.1 **Consult and Co-operate:** Pursue the objectives of the NQF and execute the functions of SAQA after consultation and in co-operation with specified bodies, and with due regard for Parliamentary and provincial powers.

- 6.2 **Needs of Learners and the Nation:** The NQF must contribute to the full development of each learner and to the social and economic development of the nation at large.

CORE STRATEGY

7. The core strategy, which is a simple concise statement of the essence of how SAQA intends to achieve its mission, is

“To develop and sustain policies, procedures and infrastructures for the NQF actively supported by the key stakeholders in education and training”.

8. This core strategy requires that:

- 8.1 key stakeholders be involved (and not merely be consulted and co-operated with) in the process of identifying, proposing, preparing, implementing and maintaining policies and procedures as well as the resulting infrastructures needed for the NQF;
- 8.2 in addition to its regulatory role, SAQA will guide, advise and support (financially, physically and morally) the process and its results when and where the key stakeholders require, and
- 8.3 will tailor its staffing, their development and the supporting infrastructure accordingly.

NATIONAL STANDARDS BODIES

AUTHORITY FOR ESTABLISHMENT OF NATIONAL STANDARDS BODIES(NSBs)

9. In terms of section 5 of the Act, SAQA may *inter alia* undertake the registration and accreditation of bodies responsible for establishing education and training standards or qualifications; the registration of national standards and qualifications, and the accreditation of bodies responsible for monitoring and auditing achievements in terms of such standards or qualifications.
10. NSBs are integrals part (sub-structures) of SAQA, reporting to SAQA with one NSB being established per field and registered by SAQA.
11. The establishment of twelve NSBs has been authorised, one in each of the following fields:
- 11.1 Field 01: Agriculture and Nature Conservation
 - 11.2 Field 02: Culture and Arts
 - 11.3 Field 03: Business, Commerce and Management Studies
 - 11.4 Field 04: Communication Studies and Language

- 11.5 Field 05: Education, Training and Development
- 11.6 Field 06: Manufacturing, Engineering and Technology
- 11.7 Field 07: Human and Social Studies
- 11.8 Field 08: Law, Military Science and Security
- 11.9 Field 09: Health Sciences and Social Services
- 11.10 Field 10: Physical, Mathematical, Computer and Life Sciences
- 11.11 Field 11: Services
- 11.12 Field 12: Physical Planning and Construction

REGISTRATION OF NSBs

- 12. Each NSB upon establishment and appointment of its members shall be issued with a certificate of registration by SAQA which certificate shall be valid for a period of three years from the date of establishment.
- 13. Each NSB shall, at the beginning of the third year after registration, apply for re-registration stating the reasons why such re-registration should be granted, and indicating the results achieved by the NSB during the previous two years.

DE-REGISTRATION OF NSBs

- 14. An NSB may be de-registered if, in the opinion of SAQA it fails to perform its functions satisfactorily.

MEMBERSHIP OF NATIONAL STANDARDS BODIES

- 15. Organisations, which shall be national stakeholder bodies with a key interest in the field and which shall fall into one or more of the six categories of stakeholders set out below, shall be invited to nominate members to serve on NSBs. Such members shall be appointed by SAQA after consultation and in co-operation with the bodies concerned, and with due regard for Parliamentary and provincial powers, the need for representativeness and equity, redress and relevant expertise in terms of the work of NSBs.
- 16. The names of those persons nominated to serve as members of NSBs and of their national stakeholder bodies shall be published timeously in the relevant Government Gazette and comment invited with respect to the acceptability of the nominees and the representativeness of the national stakeholder bodies with key interests in the field.
- 17. On acceptance, formal certificates of appointments shall be issued by SAQA to each of the successful nominees.

NOMINATION OF MEMBERS TO NSBs

18. **Guidelines for Nominations:** Organisations proposing to nominate persons to National Standards Bodies (NSBs) should be sensitive to the need for equity and redress, and nominate persons who:

- will be able to consider issues of productivity, fairness, public interest and international comparability as related to education and training;
- enjoy credibility in the various parts of the constituency in question ie who enjoy respect; have the necessary expertise and experience in the field; are well-versed in the strategies and policies of the organisation nominating, and have the support or backing of the organisation;
- are able to advocate and mediate the needs and interests of all levels within the field covered by the NSB;
- are able to exercise critical judgement at a high level, and
- are committed to a two-way communication process between the NSB and the constituency.

19. **Representation of Organisations:** Organisations wishing to be represented on NSBs should be guided in their submissions for representations by the following:

19.1 Categories: Each NSB shall be composed of six categories of organisations ie State Departments; organised Business and Labour; Providers of Education and Training; Critical Interest Groups, and Community/Learner.

19.2 Number of Representatives: Each category of organisation shall be entitled to a maximum of six representatives. The maximum number of representatives forming an NSB shall be thirty-six (36) unless SAQA deems otherwise.

19.3 Selection of Representatives: In addition to the guidelines given above, it is considered desirable that :

- State representatives should include the Departments of Education and Labour and, where desirable, other state departments, representatives of the provinces and of schools;
- organised Business and Labour should each have three representatives, with one representative each being versed in policy and evaluation, and the others being actively involved in the field of the NSB through eg being involved in an industry training board or similar organisation;
- providers of education and training should be representative of the General Education and Training band, the Further Education and Training Band and the Higher Education and Training Band;
- the Chairperson of SAQA or a nominated member of SAQA shall be ex-officio a member of each NSB;
- the Executive Officer of SAQA or a nominee shall also be an ex-officio member of each NSB, and
- other members of SAQA may attend meetings of an NSB by prior arrangement with the Chairperson of the relevant NSB.

20. **Reference Grouping:** As certain aspects of the activities of all NSBs affect certain groups of organisations such as those involved in for example youth activities, gender sensitivity and learners with special needs, a Reference Grouping of such organisations has been created. Such Reference Grouping will be:

- accessed by a special mailing list;
- entitled to make submissions both at the level of SGBs and NSBs concerning their activities and the applicability of standards to their particular needs;
- entitled to request the withholding of registration of standards unless submissions made have been considered and replied to formally ie no unit standard will be registered unless it has been considered by the relevant Reference Grouping.

FUNCTIONS OF NSBs

21. NSBs shall perform the following functions:

- 21.1 define and recommend to SAQA the boundaries of the discrete field for which constituted, by the value added by the field eg process, product or service, related to other fields;
- 21.2 define and recommend to SAQA a framework of sub-fields to be used as a guide for the recognition and/or establishment of SGBs;
- 21.3 recognise and/or establish SGBs within the framework of sub-fields, or withdraw or rescind such recognition or establishment;
- 21.4 ensure that the work of SGBs meets the SAQA requirements for the registration of unit standards and qualifications as indicated in Appendix B to these regulations;
- 21.5 recommend the registration of unit standards on the NQF to SAQA;
- 21.6 recommend qualifications to SAQA;
- 21.7 define requirements and mechanisms of moderation to be applied across ETQAs,
- 21.8 appoint office-bearers, such committees and members of committees as required to carry out the functions designated, in consultation with SAQA, and
- 21.9 such other functions as may from time-to-time be delegated by SAQA.

22. In performing these functions NSBs shall:

- 22.1 abide by the decisions and proposed decisions of SAQA contained in Appendix B to these regulations;

- 22.2 in terms of the functions indicated in paragraphs 21.1 to 21.7 above, consult with experts in the defined field concerning the accuracy and acceptability of the results of such activities;
- 22.3 subject the results of such activities to the wider scrutiny of the general public prior to submission to SAQA, and
- 22.4 ensure that the results of such activities are subjected to the scrutiny of the Reference Grouping defined in paragraph 20 above, prior to submission to SAQA.

STANDARDS GENERATING BODIES (SGBs)

AUTHORITY FOR THE ESTABLISHMENT OF SGBs

23. Each NSB may, should it deem it necessary, recognise or establish such Standards Generating Bodies (SGBs) in its own defined fields as are required by the framework of sub-fields recommended to and accepted by SAQA.
24. In recognising or establishing Standards Generating Bodies (SGBs) the National Standards Body (NSB) concerned shall first apply the steps outlined in Appendix A to these Regulations (or an acceptable similar process) to its own structure and functioning and then apply the same process to bodies desirous of recognition or considered necessary to be established.

RECOGNITION OF SGBs

25. Each SGB upon recognition or establishment shall be issued with a certificate of recognition by the NSB, which certificate shall be valid for a period of three years from the date of establishment.
26. Each SGB shall, at the beginning of the third year after recognition, re-apply for recognition stating the reasons why such recognition should be granted, and indicating the results achieved by them during the previous two years.

WITHDRAWAL OR RESCINDING OF RECOGNITION OF SGBs

27. An SGB may have its recognition withdrawn if, in the opinion of the NSB as confirmed by SAQA it fails to perform its functions satisfactorily, or on the demise of the defined sub-field.
28. An SGB may similarly request that its recognition be rescinded if it so desires.

MEMBERSHIP OF SGBs

29. Organisations, which shall be key education and training stakeholder interest groups in the sub-field, shall be invited to nominate members drawn from these interest

groups and specialists to serve on SGBs. Such members shall be appointed by the NSB representing the field after consultation and in co-operation with the bodies concerned, and with due regard for Parliamentary and provincial powers, the need for representativeness and equity, redress and relevant expertise in terms of the work of SGBs.

30. The names of those persons nominated to serve as members of SGBs and of their key education and training stakeholder interest groups shall be published timeously in the relevant Government Gazette and comment invited with respect to the acceptability of the nominees and the representativeness of the key education and training stakeholder interest groups.
31. On acceptance, formal certificates of appointment shall be issued by the NSB to each of the successful nominees.
32. **Representation of Organisations:** Organisations wishing to be represented on SGBs should be guided in their submissions for representation by the following:
 - 32.1 **Categories:** Each SGB shall be composed categories of organisations representing the full sub-field and should where possible include representatives of State Departments; organised Business and Labour; Providers of Education and Training; Critical Interest Groups, and Community/Learner.
 - 32.2 **Number of Representatives:** The maximum number of representatives forming an SGB shall be defined in consultation with the NSB but shall not ordinarily exceed twenty-five (25) unless SAQA deems otherwise.
 - 32.3 **SAQA Representative:** The Chairperson or a nominated representative shall *ex officio* be a member of the SGB.

NOMINATION OF MEMBERS TO SGBs

33. **Guidelines for Nominations:** Organisations proposing to nominate persons to SGBs should be sensitive to the need for equity and redress, and nominate persons who:
 - will be able to consider issues of productivity, fairness, public interest and international comparability as related to education and training in the sub-field;
 - enjoy credibility in the sub-field in question ie who enjoy respect; have the necessary expertise and experience in the sub-field and have the support or backing of the nominating body;
 - are able to advocate and mediate the needs and interests of all levels within the sub-field covered by the SGB;
 - are able to exercise critical judgement at a high level, and

are committed to a communication process between the SGB, the NSB and the constituency.

FUNCTIONS OF SGBs

34. SGBs shall perform the following functions:

- 34.1 generate unit standards and qualifications in accordance with SAQA requirements in identified sub-fields and levels;
- 34.2 update and review standards;
- 34.3 recommend unit standards and qualifications to NSBs, and
- 34.4 such other functions as may from time-to-time be delegated by SAQA.

RULES OF PROCEDURE

35. The activities and functioning of NSBs shall be governed by the Rules of Procedure set out in Appendix C to these Regulations.

FINANCING THE ACTIVITIES OF NSBs AND SGBs

36. **Business Plan:** Each NSB shall, upon establishment and annually thereafter to coincide with the financial planning cycle of the Authority, produce a business plan indicating the objectives to be achieved in the period under review which shall normally be three years, and which shall include a financial budget. The financial plan shall be formulated in a manner agreed to by the Authority and shall be submitted to the Authority for authorisation.
37. **Remuneration of Members of NSBs:** Members of NSBs receive compensation for their activities related to the functioning of NSBs in accordance with the regulations pertaining to the Public Service as amended by Authority, which compensation shall normally consist of but not be restricted to an allowance for attendance of meetings, subsistence and transport allowance and related costs.
38. **Remuneration of Members of Committees of NSBs:** Members of committees of NSBs who are not members of NSBs appointed by the Authority, may receive the same compensation as members of NSBs for their activities related to the functioning of NSBs, provided that their membership of such committees has received the prior approval of the Authority.
39. **Funding of SGBs:** SAQA shall fund the agreed activities of specified SGBs where such requirement exists, subject to the availability of funds and a method of financing developed in conjunction with the relevant SGB.

APPENDIX A TO REGULATIONS FOR NSBs

GUIDELINES FOR THE RECOGNITION OR ESTABLISHMENT OF STANDARDS GENERATING BODIES (SGBs)

INTRODUCTION

1. In recognising or establishing Standards Generating Bodies (SGBs) the National Standards Body (NSB) concerned should take cognizance of the process outlined below and its applicability to bodies desirous of recognition or considered necessary to be established

FIELD AND SUB-FIELD DEFINITION

2. It is recommended that the boundaries of the discrete field for which the NSB is constituted be defined by the value added by the field eg process, product or service, related to other fields; and that a framework of sub-fields to be used as a guide for the recognition and/or establishment of SGBs also be defined. In doing this it is suggested that the NSB:
 - 2.1 Determine the purpose of the definition of the field and analyse its contents.
 - 2.2 Define the boundaries of discrete fields by the value added by the field eg process, product or service related to other fields.
 - 2.3 Identify traditional and non-traditional areas of study, occupational categories, technology and environment associated with the field.
 - 2.4 Project or forecast the linkage between the field and the national economy 3, 5 and 10 years hence, ie predict whether the field is likely to grow, shrink or become obsolete, what its importance to the economy is likely to be and in what way it is likely to change.
 - 2.5 Attempt to ensure by independent assessment, that the field as defined is complete.
 - 2.6 Identify discrete sub-fields by analysing the value-added component.
 - 2.7 Identify the impact of existing and proposed legislation on fields, sub-fields and levels, and amend accordingly.
 - 2.8 Prepare a business plan for developing the NSB which includes outcomes, communication and marketing strategy, budget and time-line.
3. In considering an application for registration as an SGB is recommended that the applicant should:
 - 3.1 describe the consultation/ negotiation process used in making the application and in ensuring that other potential applicants in the sub-field have been

involved and support the submission or are willing to become co-applicants for recognition;

3.2 provide supporting documentation supporting the application and the definition of the sub-field for which application is made, and

3.3 indicate the acceptance of the SAQA decision as final and binding, after the appeal process has (if necessary) been applied.

RECOGNITION OF SGB

4. On completion of the process, the SGB should be issued with a certificate of recognition as indicated in the regulations.

APPENDIX B TO REGULATIONS FOR NSBs

THE NATIONAL QUALIFICATIONS FRAMEWORK: DECISIONS AFFECTING LEVELS, BANDS, QUALIFICATIONS, UNIT STANDARDS AND CRITICAL OUTCOMES

INTRODUCTION

1. At the time of preparation of these regulations the South African Qualifications Authority (SAQA) is in the process of developing the National Qualifications framework (NQF) and its infrastructure. In order to enable SAQA to proceed with the creation of an NQF certain decisions were taken affecting the elements of the NQF and its application. These decisions, which affect the functioning of National Standards Bodies (NSBs), Standards Generating Bodies (SGBs) and Education Training Quality Assurance bodies (ETQAs) are reflected below and are to be applied by such bodies, on the understanding that the NQF is in the process of development and that these decisions will be revised from time-to-time.

DECISIONS

2. **Levels:** Decision SAQA 0202/96: In order to enable SAQA to proceed with the creation of an NQF, SAQA adopts an eight-level framework, with Levels 1 and 8 respectively being regarded as open-ended. Level 1 accommodates three Adult Basic Education and Training (ABET) certification levels.
3. **Bands:** Decision SAQA 0203/96: SAQA recognises General Education and Training (covering Level 1 and below), Further Education and Training (covering Levels 2 to 4), and Higher Education and Training (covering Level 5 and above) as descriptive terms encapsulating levels of education and training in South Africa.
4. **Fields:** Decision SAQA 0206/96: In order to enable SAQA to proceed with the creation of an NQF, the following twelve fields be adopted by SAQA as the organising fields of the NQF:
 - 01 Agriculture and Nature Conservation
 - 02 Culture and Arts
 - 03 Business, Commerce and Management Studies
 - 04 Communication Studies and Language
 - 05 Education, Training and Development
 - 06 Manufacturing, Engineering and Technology
 - 07 Human and Social Studies
 - 08 Law, Military Science and Security
 - 09 Health Sciences and Social Services

10 Physical, Mathematical, Computer and Life Sciences

11 Services

12 Physical Planning and Construction

5. **Unit Standards:** Decision: SAQA 0208/96 (amended 8 November 1996: Decision 0302/96)

The purpose of a Unit Standard is to provide:

- an assessor document;
- a learner's guide and
- an educator's guide for the preparation of learning material

A Unit Standard should consist of:

1. a unit standard title
2. a SAQA approval logo
3. a unit standard number
4. a unit standard level on the NQF
5. the credit attached to the unit standard
6. the field and sub-field of the unit standard
7. the issue date
8. the review date
9. purpose of the unit standard
10. learning assumed to be in place before this unit standard is commenced
11. specific outcomes to be assessed
12. assessment criteria, including essential embedded knowledge
13. accreditation process (including moderation) for the unit standard
14. range statements as a general guide for the scope, context, and level being used for this unit standard
15. a "notes" category which:
 - 15.1 must include critical cross-field outcomes supported by the unit standard;
 - 15.2 should include references to essential embedded knowledge if not addressed under Assessment Criteria (Item 12), and
 - 15.3 may include other supplementary information on the unit standard.

6. **Critical Outcomes:** Decision SAQA 0204/96: It was decided that the term "Critical Cross-Field Education and Training Outcomes " (Short Title: Critical Outcomes) would be adopted instead of "Essential Outcomes", and that these (as described) would be applied in a specified context.

The following are Critical Outcomes that can successfully be embedded with unit standards:

1. Identify and solve problems in which responses display that responsible decisions using critical and creative thinking have been made.
2. Work effectively with others as a member of a team, group, organisation, community.
3. Organise and manage oneself and one's activities responsibly and effectively.
4. Collect, analyse, organise and critically evaluate information.
5. Communicate effectively using visual, mathematical and/or language skills in the modes of oral and/or written persuasion.
6. Use science and technology effectively and critically, showing responsibility towards the environment and health of others.
7. Demonstrate an understanding of the world as a set of related systems by recognising that problem-solving contexts do not exist in isolation.

In order to contribute to the full personal development of each learner and the social and economic development of the society at large, it must be the intention underlying any programme of learning to make an individual aware of the importance of:

1. Reflecting on and exploring a variety of strategies to learn more effectively;
2. participating as responsible citizens in the life of local, national and global communities;
3. being culturally and aesthetically sensitive across a range of social contexts;
4. exploring education and career opportunities, and
5. developing entrepreneurial opportunities."

7. **Qualifications and Level Descriptors:** Decisions SAQA 0205/96 and 0207/96 as amended by Decision Excom 1201/97: Proposed decision on qualifications and level descriptors:

"It is proposed that the following be accepted in order to proceed with the development of the NQF:

CRITERIA FOR THE REGISTRATION OF QUALIFICATIONS

In order to be registered as a National Qualification, a qualification shall meet the following requirements:

1. **Composition of Qualifications:** A qualification shall:
 - 1.1 represent a planned combination of learning outcomes which has a defined purpose or purposes, and which is intended to provide qualifying learners with applied competence and a basis for further learning;

- 1.2 add significant value to the qualifying learner in terms of enrichment of the person; provision of status, recognition, credentials and licensing; enhancement of marketability and employability; opening-up of access routes to additional education and training;
- 1.3 provide benefits to society and the economy through enhancing citizenship; increasing social and economic productivity; providing specifically skilled/professional people; transforming and redressing legacies of inequity;
- 1.4 comply with the objectives of the NQF including the enhancement of learner access, mobility and progression, and the provision of quality education and training;
- 1.5 have both specific and critical cross-field outcomes which promote life-long learning, and
- 1.6 be internationally comparable, where applicable.

2. **Credits and Qualifications:** A total of 120 (one hundred and twenty) or more credits shall be required normally for registration at levels 1 to 8, with a minimum of 72 (seventy-two) credits being obtained at or above the level at which the qualification is registered. The number and levels of credits constituting the balance (of twenty-two) shall also be specified. Qualifications consisting of less than 120 credits may be considered if they:

- 2.1 meet the requirements in paragraph 1 above; and
- 2.2 enable learners to progress within the NQF as in paragraph 1.4 above.

3. **Types, levels and titles of Qualifications:** The type and level of qualification shall be determined on the basis of the total number and levels of credits required in accordance with the following criteria:

- 3.1 National Certificate: A minimum of 120 (one hundred and twenty) credits with 72 (seventy-two) credits at or above the level at which the certificate is registered. Where SAQA has considered and found that a qualification consisting of less than the minimum number of credits met the requirements stated in paragraphs 2.1 and 2.2 above, the foregoing requirement is waived and the qualification registered as a National Certificate.
- 3.2 National First Diploma: A minimum of 240 (two hundred and forty) credits, of which a minimum of 72 (seventy-two) shall be at level 5 or above on the NQF.

- 3.3 National First Degree: A minimum of 360 (three hundred and sixty) credits of which a minimum of 72 (seventy-two) shall be at level 6 or above on the NQF.
- 3.4 Titles of Qualifications: Qualifications shall be distinguished by type, NQF level, number of credits and title. The title should describe the primary purpose of the qualification.
4. **Fundamental, Core and Elective learning for National Certificates at NQF levels 1 to 4**: An adequate level of applied competence acquired through general and further education and training shall be ensured at these levels. For this reason the following criteria apply:
 - 4.1 Credits: The minimum of 72 (seventy-two) credits required at or above the level at which the certificate is awarded, shall be divided into the following categories:
 - 4.1.1 Fundamental learning

A minimum of 20 (twenty) credits from the field of Communication Studies and Language, and in addition;

a minimum of 16 (sixteen) credits from the sub-field of Mathematics (which includes numeracy) in the case of certificates at level 1, or

a minimum of 16 (sixteen) credits from the field of Physical, Mathematical, Computer and Life Sciences in the case of certificates at levels 2 to 4.
 - 4.1.2 Core and Elective Learning

A minimum of 36 (thirty-six) credits which shall be divided between the Core and Elective categories, with each qualification specifying the distribution of credits required in these categories; provided that the range of additional credits shall be broad enough to enable learners to pursue some of their own learning interests.
 - 4.2 Integrated assessment shall be incorporated appropriately to ensure that the purpose(s) of the qualification is achieved. Such assessment shall use a range of formative and summative assessment methods such as portfolios, simulations, in situ work-place assessments, written and oral examinations.
5. **Fundamental, Core and Elective learning for Qualifications at NQF levels 5 to 8**: More flexible rules of combination in terms of credits for

Fundamental, Core and Elective learning may be applied at these levels, providing that the requirements of paragraphs 1 and 4.2 above are met.

6. **Recognition of Prior Learning:** In the rules governing the award of qualifications shall be indicated that qualifications may be achieved in whole or in part through the recognition of prior learning (RPL), which concept includes learning outcomes achieved through formal, informal and non-formal learning and work experience.

7. **Assignment of Levels to Unit Standards and Qualifications:** The assignment of levels to unit standards, other components of qualifications and qualifications shall occur as follows:

7.1 **Unit Standards:** The "community" of SGBs and the NSB in each field will be required to reach agreement on the level of each unit standard on a scale of eight levels (as in the NQF), taking into account the way in which both the breadth and the depth of knowledge, skills and values in a specific sub-field have been advanced by learning, and the way in which one or more of the critical cross-field outcomes is seen to be a distinctive although contextual part of the prescribed outcome of the unit standard concerned.

7.2 **Qualifications:**

7.2.1 The proposers of unit standards-based programmes will be required to construct, through appropriate rules of combination of selected unit standards registered at different levels, qualifications which have exit levels that are a function both of the particular component unit standards used, and a process of integrating the overall outcome, again considered as reflecting the extent (on a scale of 1 to 8) to which knowledge, skills and values in a sub-field have been acquired and the critical cross-field outcomes incorporated, into the assessable performance.

7.2.2 The proposers of qualifications not based on unit standards will be required to construct combinations of learning outcomes which have exit levels that are a function of the most advanced outcomes included and of a process of integrating the overall outcome, considered as reflecting the extent (on a scale of 1 to 8), to which knowledge, skills and values in a sub-field have been acquired and the critical sub-field outcomes incorporated into the assessable performance as a whole.

- 7.3 **Level Descriptors:** NSBs will be required to engage with their SGBs to produce level descriptors (or descriptions of each of the eight levels of the NQF), with exemplars, which will explain their process of assigning levels to unit standards, other components of qualifications and qualifications. SAQA will engage with the NSBs and their SGBs to develop guidelines on level descriptors in order to ensure coherence across fields and to facilitate the assessment of international comparability of unit standards and qualifications.

REGISTRATION AND INTERIM REGISTRATION OF UNIT STANDARDS AND QUALIFICATIONS

8. **Registration:** Unit Standards and Qualifications which meet the criteria contained in these regulations, shall be registered for a period of five years, after which application shall be made for re-registration.

Interim Registration: For a transitional period, interim registration shall be granted to qualifications which have been approved in the past by an agency recognised by SAQA, provided that:

- 8.1 each qualification has been submitted to SAQA in its present form before 31 December 1997, for recording;
- 8.2 such qualification, so recorded is submitted to one or more NSBs for processing, within two years from 1 January 1998;
- 8.3 such qualification contains as a minimum the details specified below:
 - 8.3.1 purpose(s) of the qualification;
 - 8.3.2 assumptions of learning already in place before the programme leading to the qualification is commenced;
 - 8.3.3 exit level outcomes as indicated in paragraph 7.2 above;
 - 8.3.4 total credits required;
 - 8.3.5 minimum (and sometimes maximum) credits required at specific levels;
 - 8.3.6 integrated assessment appropriately incorporated to ensure that the purpose(s) of the qualification is achieved;
 - 8.3.7 articulation possibilities with related qualifications (either generic or specific arrangements for articulation); and
 - 8.3.8 moderation options;
- 8.4 such qualification meets the requirements stated in paragraph 1 above.

9. **Transitional Period:** A transitional period of five years (ie from 1 January 1998 to 31 December 2003) is set for the interim registration of qualifications on the NQF. This transitional period allows existing qualifications which meet

the minimum criteria set out in paragraph 8 above, continually to be phased-out and to be replaced with new versions. New qualifications may be submitted for interim registration in the same format during this period, or may if they meet the requirements, be submitted for registration. Interim registration shall cease at the end of the transitional period, and all interim registrations shall expire."

8. **Credit:** Decision SAQA 0209/96: SAQA accept a credit system on the basis of 1 credit equalling 10 notional hours of learning, motivated in context in each case.

APPENDIX C TO
NSB REGULATIONS

NATIONAL STANDARDS BODIES (NSBs): RULES OF PROCEDURE

DEFINITIONS

9. In these Rules, unless the context otherwise indicates-

“Act” means the SA Qualifications Authority Act, No 58 of 1995;

“Authority” means the SA Qualifications Authority established in terms of Section 3 of the Act;

“Chairperson” means the Chairperson of the NSB;

“Committee” means any committee of the NSB established in terms of the Regulations;

“Department” means the Department of Education and/or Labour

“Executive Committee” means a committee established in terms of the Regulations to carry out certain designated functions on behalf of the NSB;

“Member” means a member of the NSB appointed by SAQA in terms of the Regulations;

“Minister” means the Minister of Education and, for the purposes of sections 4(2), 4(3), 4(4), 4(5), 4(6), 5(1)(c), 11, 13(2), 14 and 15(2), the Minister of Education in consultation with the Minister of Labour;

“Resolution” means a decision of the NSB.

“Secretary” means a member of the NSB designated for this purpose by the NSB in terms of the Regulations.

MEMBERS OF THE NSB

2. The NSB shall, subject to the provisions of the Act, consist of a Chairperson, a Deputy Chairperson, a Secretary and the other members appointed by SAQA in terms of the Regulations for National Standards Bodies (the Regulations), subject to the requirement that the Chairperson shall first be elected by the members of the NSB either from among their members or from other sources.

PRESIDING OFFICERS

3. The Chairperson of the NSB or of a committee shall preside at meetings of the NSB or the Committee as the case may be. If the Chairperson is absent from any meeting Deputy Chairperson shall preside. In the absence of both, the members present may elect from among themselves a chairperson to act at the meeting.

MEETINGS OF THE NSB

4. The NSB shall meet at such places and at such times as may be decided by resolution from time to time.

5. Special meetings may be called at the discretion of the Chairperson, or at the substantiated request of not less than one-third of the members in which event the meeting shall be held at a time and place determined by the Secretary, as soon as practicable after the receipt of such a request.

6. The Chairperson after having consulted with the Executive Committee shall have the right to postpone any meeting of the NSB if the business on the agenda appears not to warrant calling such a meeting, with the proviso that members shall be advised of such postponement at least one week before the date on which the NSB is due to meet, and with the further proviso that meetings may not to be cancelled or postponed due to accountable events or considerations beyond the control of the NSB unless two-thirds of the members agree to this.

7. Any person whose presence is required for the purpose of a meeting may be invited by the NSB to attend any meeting of the NSB.

8. All documentation dispatched to members shall be labelled in a manner appropriate to the nature and status of the contents, with the understanding that it is incumbent upon members to ensure that such documentation is dealt with in accordance with that labelling.

NOTICE OF MEETINGS

9. Notice of any meeting of the NSB which shall include an agenda of the matters to be considered there, shall be forwarded by the Secretariat to each member and such other persons required to attend at least 14 days before the scheduled date of the meeting to the address registered with the Secretary, provided that in the case of special meetings such shorter written notice as may be decided by the Chairperson, but not less than three working days, may be given.

10. The non-receipt of any notice, duly sent to the registered address of any member, shall not affect or invalidate the proceedings of any meeting.

ATTENDANCE REGISTER

10. Every member present at a meeting of the NSB shall sign the attendance register which shall be available for that purpose.

QUORUM

11. One half of the members, excluding the Chairperson, shall form a quorum at all ordinary meetings of the NSB. At special meetings one third of the members of the NSB, excluding the Chairperson, shall constitute a quorum.

12. When the number of members present at the time and place fixed for a meeting is insufficient to form a quorum, the meeting shall continue, with the proviso that any decisions reached shall be considered to be draft decisions and shall be circulated to the NSB for further discussion and comment prior to ratification.

PRESS STATEMENTS

13. Where it is deemed necessary to issue press statements concerning aspects relevant to the activities and meetings of the NSB, they shall be issued by the Chairperson of the NSB with the concurrence of the Chairperson of the Authority.

MINUTES

14. Minutes of each meeting shall be compiled and submitted for confirmation at the following meeting. The Secretary shall circulate the minutes to members at the same time as the notice convening the next meeting.

15. Minutes shall not reflect verbatim the proceedings of meetings, but shall be a summarised recording of the proceedings, resolutions and actions required, with the provision that any member shall have the right to request that his or her particular view be reflected in the minutes.

DEBATES OF THE NSB AND VOTING

16. In the conduct of any meeting of the NSB the ordinary rules of debate shall apply.

17. Decision-making shall be by consensus with the proviso that where consensus cannot be reached a vote may be taken. Where voting is deemed necessary it shall be by show of hands unless a ballot be requested by any member, when a secret ballot shall be held.

18. The Chairperson, when presiding shall not have a deliberative vote, but a casting vote.

19. In the absence of the Chairperson the acting Chairperson (be it the Deputy Chairperson or another) shall not have a casting vote, but a deliberative vote.

20. It is incumbent upon a member of the NSB to declare any pecuniary interest in a matter being debated by the NSB and to offer to recuse himself or herself from the debate, provided that such member shall be recused when a decision on such matter is being made by the NSB.

21. Save as otherwise provided in these rules the decision of the majority of the members present at a meeting of the NSB shall be the decision of the NSB. Minority viewpoints may be recorded at the request of such members.

22. Notwithstanding the provisions of any of these rules, if any matter arises between ordinary meetings which requires a decision of the NSB and which in the opinion of the Chairperson should not be delayed until the next ordinary meeting of the NSB, the Chairperson may authorise the Secretary to prepare and dispatch by registered post or courier to each member a notice reflecting the matter in question and seeking a postal vote upon which a decision may be made. The notice shall specify the period in which a postal vote may be lodged, which shall not be less than 10 (ten) days from the date of dispatch of the notice. The decision of the majority of the NSB shall be deemed to be the NSB's decision. The result of each such ballot shall be made known at the next meeting of the NSB.

ESTABLISHMENT OF COMMITTEES

23. The NSB may establish committees, including an Executive Committee in terms of the Regulations for NSBs.

EXECUTIVE COMMITTEE

24. An Executive Committee established in terms of the Regulations shall consist wholly of members of the NSB and be appointed by it. It shall consist of the Chairperson and such other number of members as determined and nominated by the NSB, provided that:

24.1 such Executive Committee shall, subject to the directions of the NSB, conduct the affairs of the NSB between meetings, provided that all decisions relating to matters of principle shall be the prerogative of the NSB;

24.2 the Chairperson, or in absence of the Chairperson, the acting Chairperson elected by the members shall preside at all meetings of the executive committee;

24.3 the Chairperson shall report on the work of the Executive Committee at each ordinary meeting of the NSB, and

24.4 a quorum of the Executive Committee shall consist of the Chairperson plus one half of the members of that Committee.

OTHER COMMITTEES

25. A committee shall consist of such number of members of the NSB or of persons other than members of the NSB or of members of the NSB as well as other persons, as the NSB may determine, appointed for such period of time as determined by the NSB.

25.1 The NSB shall designate any member of any such committee as chairperson of the committee.

25.2 A committee may, with the approval of the NSB, establish one or more working groups to perform under the directions of the committee such functions of the committee as the NSB may determine or to inquire into such matters falling within the functions and powers of the committee.

25.3 Any committee, other than the Executive Committee, may, with the consent of the Executive Committee, co-opt one or more persons as members of the committee for a specific period or a particular purpose.

25.4 The NSB may, subject to such conditions as it may deem fit, either generally or in relation to any particular matter, assign to any committee any power conferred or duty imposed upon it in terms of the Regulations.

25.5 The NSB may at any time withdraw, extend or modify any terms of reference to a committee, but any proposal to do so shall first be referred to that committee for consideration and comment.

25.6 A member of a committee who without prior apology fails to attend three consecutive meetings of such committee shall cease to be a member thereof.

25.7 A member of a committee may resign from such committee by notice in writing

25.8 Where a vacancy occurs on a committee the Chairperson of such a committee shall inform the NSB in writing at the first subsequent meeting of the NSB, which shall undertake to fill the vacancy..

26. REPORTING BY COMMITTEES

The Chairperson of each committee shall submit a report on the activities of the committee at each ordinary meeting of the NSB.

27. MEETINGS OF COMMITTEES

The provisions of paragraphs 7 to 20 shall mutatis mutandis apply to any committee of the NSB, provided that for the purposes of this clause, reference to the "NSB",

“Chairperson” or “Secretary” shall be construed as a reference to the Committee”,
“Chairperson of the Committee” or “Secretary of the Committee”, respectively;

28. **ADDITIONAL MEMBERS**

Additional members appointed to committees in terms of the Regulations shall have all the powers of a member at any meeting, including the right to vote.

ROLE OF SECRETARY

29. The secretarial work incidental to the performance by the NSB of its functions, shall be performed, subject to the directions of the Chairperson of the NSB, shall be performed by the Secretary.

30. The role of the secretary is to assist the NSB through:

- 30.1 providing a secretarial function
- 30.2 advising on administrative matters
- 30.3 effective administration service
- 30.4 assistance in managing projects
- 30.5 executing such other tasks as the NSB may from time to time require.

AMENDMENT OF THE RULES

31. These rules may be added to or amended at any meeting of the NSB with the concurrence of the Authority, by a simple majority of the members present, provided that such amendment forms a specific item on the agenda, the text whereof was circulated to members with the agenda and provided that no fewer than half of its members are present at the meeting.

REVIEWING DECISIONS OF THE NSB

32. Each decision taken at a meeting of the NSB is to be allocated a unique NSB Decision number and is seen as an NSB decision. A member wishing to have a decision reviewed is required to submit written notice of such a requirement with full reasons for the desired review to the Secretariat at least 14 days prior to a meeting of the NSB. Should the NSB amend the decision, such amendment will be recorded in the minutes of the meeting, the necessary amendments to documentation made and revised versions of documentation issued.

NOTICE 753 OF 1997**BOARD ON TARIFFS AND TRADE****REVIEW OF THE ANTI-DUMPING DUTY ON CALCIUM ACETATE, ORIGINATING IN OR IMPORTED FROM THE NETHERLANDS: PRELIMINARY DETERMINATION**

The Board on Tariffs and Trade gave public notice of the review of the anti-dumping duty on calcium acetate, originating in or imported from The Netherlands, in Notice No. 1037, published in the *Government Gazette* on 26 July 1996.

While there was not sufficient evidence to show that there was no material injury or threat of material injury (if the duty were withdrawn), the Board found that the price disadvantage was now smaller than at the time of the imposition of the duty. The Board therefore made a preliminary finding that the anti-dumping duty on calcium acetate originating in or imported from The Netherlands should be reduced from 95c/kg to 31c/kg.

All interested parties have 30 days from the date of publication of this notice to respond to the Board's preliminary determination. A report containing the Board's decision and the basis for its decision is available on request.

The Board will make a final recommendation on the basis of the facts at its disposal after the time limit specified above. The current anti-dumping duty will remain in place until that time.

SCHEDULE

DIRECTIVE BZ OF THE JOHANNESBURG STOCK EXCHANGE

JET System

1. Definitions

For the purposes of this directive, the following definitions shall apply -

"after hours" means any time outside the pre-opening and continuous trading session;

"arbitrage transaction" shall have a meaning as defined in the Stock Exchanges Control Act, 1985 (Act No. 1 of 1985);

"at market" means an order to be transacted immediately against the best opposite order in the order book at the time of making such entry;

"corporate finance transaction" means a transaction which is entered into in writing and requires public notification in the press in terms of the listings requirements of the JSE or is an 'asset swap' which complies with all the requirements of the South African Reserve Bank in respect of 'asset swaps';

"fill or kill" (FK) means the full order must be immediately executed or otherwise cancelled;

"hit and take" (HAT) means a facility to initiate entry of a counter order which will match against an advertised order in the order book;

"immediate or cancel" (IOC) means the full order must be immediately executed to the extent possible and any remainder cancelled;

"inter-dealer transaction" means a single transaction of a value of not less than R200 000 and where a member trades from his own account with another member without a client or local counterparty being involved in the transaction;

"limit order" means an order which may only be effected at prices equal to or better than the price on the order;

"liquid or illiquid securities" means securities so designated from time to time by the Committee for the purpose of tick sizes and bear sales;

"local counterparty transaction" means a transaction where a member trades as a principal with a person in South Africa other than a member;

"lot size" means the standard unit of trade -

in all equities : one round lot;
in Krugerrands : one coin;
in debentures : R100 nominal value;

"market maker" means a member which negotiates dealings in blocks of securities;

"odd lot" means any quantity which is less than a round lot;

"round lot" means in all equities, 100 shares;

"sellers option time bargain" means a transaction which has been executed on the condition that such transaction shall be settled in the thirteenth settlement period after the contract is made, or such earlier period as may be specified by the seller;

"spread" means the differential between a bid and an offer price;

"tick size" means the specified parameter or its multiple by which the price of a security may vary when trading at a different price from the last price, whether the movement is up or down from the last price.

2. Trading Capacity and Market Structure

2.1 Subject to the provisions of rule 3.30.2, the JET system shall operate continuously from 09h30 to 16h00 Mondays to Fridays (excluding public holidays) and the following trading sessions shall be applicable -

pre-opening	08h45 to 09h30
opening	09h30
continuous trading	09h30 to 16h00.

2.2 No trading shall take place during the pre-opening session, whether through or outside the JET system.

2.3 A member may trade through the JET system as any of -

an agent; or
a principal with a local or foreign counterparty; or
a voluntary market maker; or
an inter-dealer principal with another member.

2.4 A member shall nominate the account to which each order and its associated trade or trades will be booked.

2.5 No member shall manage an order of another member.

2.6 No member may trade as an agent or as a principal in securities unless the member has first entered an order in the central order book except -

2.6.1 when trading in an inter-dealer transaction; or

2.6.2 when acting as a market maker; or

2.6.3 when trading after hours for its own account with another member also trading for its own account; or

2.6.4 in respect of arbitrage or corporate finance transactions.

2.7 Market-making will be permitted in all securities and debentures, including Krugerrands.

2.8 The best bid and offer in each security will be published. Except where the Committee may from time to time decide otherwise, sales prices and the volumes of individual transactions will be published.

2.9 No member shall disseminate to a client or to any other party, by electronic means, any data contained within the JET system, except such data which the Committee from time to time determines may be so disseminated.

2.10 Tick sizes shall be -

2.10.1 in respect of liquid securities:

- 1 cent for a share priced between 1 cent and 500 cents
- 2 cents for a share priced between 501 cents and 1000 cents
- 5 cents for a share priced between 1001 cents and 5000 cents
- 25 cents for a share priced above 5000 cents;

2.10.2 in respect of illiquid securities:

- 1 cent for a share priced between 1 cent and 100 cents
- 2 cents for a share priced between 101 cents and 300 cents
- 5 cents for a share priced between 301 cents and 1000 cents
- 10 cents for a share priced between 1001 cents and 3500 cents
- 20 cents for a share priced between 3501 cents and 5000 cents
- 25 cents for a share priced between 5001 cents and 10 000 cents
- 50 cents for a share priced over 10 000 cents.

2.11 All orders executed through the JET system order book except transactions for immediate settlement and sellers option time bargains shall be for settlement during the next settlement period.

3. Investor Protection (Mandates and Orders)

3.1 A member shall ensure that the capacity in which a client is prepared to trade with that member i.e. either as agent or as principal or as either agent or principal is indicated on the order in the P/A field. Such capacity shall be designated as -

- 'A' agent only
- 'E' either principal or agent
- 'P' own account of member or principal only.

3.2 Orders shall be recorded in price and then time priority by the member upon receipt thereof and by the JET system upon the entry of such order. Orders from clients shall always be given time priority over a member's own account orders except where a member had already entered own account orders into the JET system at the time that a client order was received by such member.

3.3 Orders which are received by a member after hours shall have the time priority of entry of the order into the JET system.

3.4 An agency only order of a member may not be matched by the JET system with an opposite principal order of the same member.

3.5 Orders entered individually shall carry their own time priority.

3.6 A member may bulk client orders where it believes, on reasonable grounds, that this practice is in the overall best interests of clients and provided that -

3.6.1 bulking takes place prior to entry into the order book;

3.6.2 bulking is restricted to like categories of orders i.e. agent only (A),

principal or agent (E) or own account of the member (P). No bulking of different categories of orders shall be permitted;

- 3.6.3 a member shall be responsible for the time priority in which the allocations of the transactions in respect of which orders have been bulked, is made to clients;
- 3.6.4 where a member bulks individual orders received from a branch office or bulks individual orders received for a new listing, the orders will have the time priority of the bulked order;
- 3.6.5 a member has disclosed to clients beforehand that their orders may be bulked and that the effect of bulking may in certain circumstances operate to their advantage or disadvantage; and
- 3.6.6 where a bulked order is partially executed, the allocation of such order to clients shall be on the basis of the time priority of the individual orders.
- 3.7 Orders which are 'at market' may not be entered into the order book where there are no contra-side limit orders in the book and may not be entered into the order book during the pre-opening session. The balance of any such orders remaining after execution, shall be cancelled by the system.
- 3.8 A member shall, when reporting transactions to clients, confirm in respect of each transaction the capacity in which the member traded, i.e. either as an agent on behalf of the client or as a principal with the client.
- 3.9 A transaction may only be cancelled by an equal and opposite transaction.
- 3.10 Where a member has a conflict of interest in a transaction on behalf of a client, the member shall disclose the conflict of interest to that client. A trade on behalf of a client with an interested party shall constitute a conflict of interest. Interested parties include the following -
 - 3.10.1 the sole proprietor of the member;
 - 3.10.2 a partner of the member;
 - 3.10.3 a director of the corporation which trades as the member;
 - 3.10.4 a shareholder of an unlisted corporate entity which trades as a member;
 - 3.10.5 a controlling shareholder of a listed corporate entity which trades as a member;
 - 3.10.6 a fellow subsidiary of a corporate entity which trades as a member;
 - 3.10.7 members of staff or officers of the member, the spouse or minor children of any of the foregoing persons;
 - 3.10.8 any partnership or joint venture in which any of the foregoing parties is a partner;
 - 3.10.9 a will or inter vivos trust where any of the foregoing persons controls and/or has a sole discretion to operate the trust and/or is a beneficiary of the trust;
 - 3.10.10 any pension or provident fund of which any of the foregoing persons are members; and
 - 3.10.11 an unlisted company or a close corporation in which any of the

aforegoing has a beneficial interest either directly or indirectly.

4. Bear Sales

4.1 Bear sales in liquid securities may take place at any market price subject only to tick size.

4.2 The undernoted definitions of indicators shall apply to bear sales in illiquid securities -

zero tick - the current sale is at the same price as the last sale

minus tick - the current sale is at the down tick or ticks from the last sale

zero minus tick - the price trend is on the down tick and the current sale is at the same price as the last or preceding sales

plus tick - the current sale is at the up tick or ticks from the last sale

zero plus tick - the price trend is up and the current sale is at the same price as the last or preceding sale.

4.3 Where there is no opening transaction, a zero tick indicator shall apply. The first transaction of a trading day shall carry a tick indicator depending on the previous close price.

4.4 Orders for bear sales in illiquid securities shall be entered only with limit prices.

4.5 Where the market in an illiquid security -

4.5.1 is at the zero tick or at the minus tick or at the zero minus tick, an order for a bear sale may be entered and a trade may take place only at a price higher than the last sale price; or

4.5.2 is at the plus tick or the zero plus tick, a bear sale order may be entered and a trade may take place only at a price equal to or higher than the last sale price.

4.6 Prior to an order being entered into the order book for a bear sale, a member shall ensure that arrangements are in place for the full quantity of securities which are the subject of the bear sale to be covered under a securities borrowing agreement so as to facilitate settlement. The brokers note shall, in addition to the information detailed in rule 5.160, confirm that a securities borrowing arrangement is in place.

4.7 The JSE shall have the right to confirm the borrowing arrangements.

4.8 A client or a counterparty, other than a foreign dealer, shall disclose to the member an intention to sell securities by means of a bear sale.

4.9 A member shall enter into the JET system its intention to sell by means of a bear sale by marking the order 'BS'.

5. Put-throughs

5.1 Where a member has an order to buy and an order to sell the same security both at the same price on behalf of different clients such a transaction shall be

classified as a put-through transaction in respect of which the member shall have the same fiduciary duty to both the buying client and the selling client.

5.2 Put-through transactions, other than those relating to the restructuring of a listed company and where the transaction is categorised as a corporate finance transaction, shall be concluded as follows -

5.2.1 when there are orders on both sides of the order book including those of the member, the member shall -

5.2.1.1 first clear the orders where the prices are better than the put-through price;

5.2.1.2 then clear the orders which have time priority at the same price as the proposed put-through; and

5.2.1.3 then the balance of both the buying and selling orders may be entered at the put-through price to conclude the put-through;

5.2.2 when there are only orders of other members on both sides of the order book which are not better than the proposed put-through price, the put-through may be concluded by entering both the buying and selling orders at the put-through price provided the spread of the order book is not greater than five ticks;

5.2.3 when there are no orders in the order book, or when there -

5.2.3.1 are orders only on one side of the order book; or

5.2.3.2 is a spread wider than five ticks in the order book; or

5.2.3.3 is a spread of less than five ticks in the order book which spread was created by the member wishing to conclude the put-through -

the member shall test the market by creating a spread at or within five ticks by entering both a buying and a selling order or by entering a buy or sell client order against a contra order of another member. If there is no trading against either order within 30 seconds for liquid securities and five minutes for illiquid securities and the spread is not more than five ticks, the member may conclude the put-through by entering both the buying and selling orders at a price either at or between the spread of the market.

5.3 If the market trades against one or both of the test orders, the member shall alter (or re-enter) its price or prices until no further trading occurs for a period of 30 seconds for liquid securities and for a period of 90 seconds for illiquid securities after which the member may conclude the put-through by entering both the buying and selling orders at a price either at or between the spread of the market subject to the spread not being more than five ticks.

5.4 If in the process of testing the market, transactions take place, the member may put through a quantity equal to or less than the quantity of the transactions at the same price as those transactions by entering the transaction as a 'PT' on the "report only" trade screen.

5.5 Orders entered within 30 seconds of the market close for liquid securities and five minutes for illiquid securities shall not constitute a valid testing of the market.

5.6 Where a member is acting on behalf of a client or clients in a put-through transaction relating to the restructuring of a listed company and where the

transaction is categorised as a corporate finance transaction, the transaction shall be reported to the JET system without having to follow the procedures set out in 5.2

6. Odd Lots

6.1 The JET system shall maintain a separate order book for trading odd lot orders.

6.2 The Committee shall appoint a member as a specialist to maintain a market in odd lots in securities.

6.3 Except as provided in 6.6.3, members may trade in odd lots only as agents on behalf of clients. The following provisions shall apply -

6.3.1 only genuine odd lot orders may be entered into the odd lot order book. Members may not trade in the odd lot book to circumvent trading in the round lot order book;

6.3.2 'limit' and 'at market' orders may be entered;

6.3.3 'at market' orders shall not be shown individually in the order book but aggregated to show the total bid and offered quantities;

6.3.4 limit orders shall not be aggregated in the order book;

6.3.5 the specialist or any other member may 'hit and take' a limit order in the book. Time priority shall not apply;

6.3.6 odd lot orders shall trade on an 'all or nothing' basis i.e. there shall be no partial execution of an odd lot order; and

6.3.7 odd lot purchase transactions in respect of the illiquid securities satisfied by the odd lot specialists may not be called up against the odd lot specialist (the deliverer) in terms of rule 5.100.4.

6.4 An order which is an aggregate of an odd lot and round lot shall be split by the member and entered as two orders, one for the round lot amount and the other for the odd lot quantity.

6.5 Odd lots shall not be subject to the satisfaction rule.

6.6 Members may tender annually to act as the odd lot specialist. The specialist -

6.6.1 shall be responsible for maintaining the inventory of its book off-line and shall enter manually any round lot orders necessary to maintain the balances in its odd lot inventory or portfolio;

6.6.2 shall not be liable for any JET system service charges in respect of its odd lot trading; and

6.6.3 may trade as a principal with its clients in respect of any odd lot trade with the exception of those orders entered as agency only orders; and

6.6.4 shall not be required to enter into a securities borrowing agreement in respect of bear sale transactions arising out of the satisfaction of transactions from the odd lot order book.

7. After Hours Trading

7.1 No member shall execute a transaction after hours except -

- 7.1.1 a transaction relating to the restructuring of a listed company and where the transaction is categorised as a corporate finance transaction (designated 'CF' for recording purposes); or
- 7.1.2 in respect of transactions executed by the member for its own account with a foreign dealer (designated AT for reporting purposes) or with another member also dealing for its own account (designated ID for reporting purposes); or
- 7.1.3 a transaction executed by a member in respect of an order received after hours or in respect of the continuation of an order already entered into JET, (designated 'TX' for reporting purposes) provided -
 - 7.1.3.1 at least one party to the transaction is a non-resident; and
 - 7.1.3.2 at least one leg of the transaction is conducted on an agency basis; and
 - 7.1.3.3 the non-resident confirms to the Director : Surveillance by facsimile on the next business day, the date and time of placement of the transaction order.
- 7.2 After hours transactions shall be reported by the member to the JET system on the next business day within 30 minutes of the opening of continuous trading.
- 7.3 No transactions with local counterparties who are not members may be executed after hours.

8. Market Making

- 8.1 Members may act as market makers in negotiated dealings in blocks of securities.
- 8.2 Members may advertise on the auxiliary window in the JET system that they wish to buy or sell at firm bid or offer prices subject to -
 - 8.2.1 a member acting as a market maker installing a telephone recording system incorporating a time stamp feature with telephone recordings being retained or archived for a period of at least 3 months after the event; and
 - 8.2.2 no transactions being effected by a market maker during the pre-opening session nor after hours except in the latter instance where transactions are -
 - 8.2.2.1 for the own account of the market maker with a foreign dealer; and
 - 8.2.2.2 in an inter-dealer trade;
 - 8.2.3 the minimum obligation of each transaction being the greater of R200 000 or the value of the advertised quantity of shares.
- 8.3 A member may quote prices for a bid only, an offer only, or both. The member may stipulate the quantity involved in the transaction subject to the minimum trade size restriction.
- 8.4 A member or a counterparty may negotiate a price telephonically with the market maker to conclude a transaction, subject to compliance with the satisfaction rule as required in 8.7, 8.8 and 8.9.

- 8.5 The bids and offers of a market maker, despite being better than a negotiated transaction by another member, shall not participate automatically under the satisfaction rule unless the market maker has open orders in the order book in the JET system.
- 8.6 Where the prices of a market maker are better than the order book, members may negotiate with the market maker and may trade with the market maker, but only through the order book and subject to the satisfaction rule.
- 8.7 Orders in the order book which are at a better price than the price for a proposed negotiated trade shall be satisfied at their respective bid/offer price (not the negotiated price) by the market maker.
- 8.8 The market maker is not required to satisfy orders at the same price.
- 8.9 In order to meet the satisfaction rule:
- 8.9.1 the market maker, when approached by a counterparty, shall 'freeze' the order book for the purpose of quoting to the counterparty;
 - 8.9.2 the market maker shall register its quote to the counterparty in the JET system;
 - 8.9.3 any further orders entered after registering the proposed trade shall not be subject to the satisfaction rule, except that new orders at a better price than the frozen orders shall substitute to the extent of an equivalent value of orders in the frozen book on a time and price priority basis;
 - 8.9.4 orders present at the time may continue to be cleared by the market and the market maker shall be relieved of any obligation thereto;
 - 8.9.5 within 30 seconds of causing the 'freeze', the market maker shall conclude his transactions as set forth in 8.10.
- 8.10 Upon registration by the market maker into the JET system of its price (either bid, offer or both) and the quantity to be traded with the counterparty:
- 8.10.1 the system will display to the market maker the obligation to be satisfied in the order book based on the quantity and price or prices which have been entered;
 - 8.10.2 the market maker may vary the information entered until satisfied with his commitment. On each occasion the system shall recalculate the obligation to the order book; and
 - 8.10.3 on being satisfied with his commitment, and within the 30 second period, the market maker shall cause the transactions to be executed by the system. Both the transactions with the counterparty and any transactions in terms of the obligation to the order book shall be automatically generated by the system.
- 8.11 Should the market maker fail to complete the transactions within the 30 second period, both the registered information and the associated 'frozen' obligation of the order book shall be cancelled by the JET system. The transaction with the counterparty may not proceed until the procedure in 8.12 is completed.
- 8.12 Should the market maker wish to continue in negotiation, it may do so by repeating the procedure but the current position of the order book at the time of recommencing negotiations shall form the basis of his satisfaction obligation.
- 8.13 No member shall report trades through the market making mechanism with the

12.3 Where an order is executed with a combination of agency and principal, separate brokers notes shall be issued for the agency and principal portions clearly indicating the capacity in each case.

12.4 A member shall not take a turn in an agency transaction and shall reflect the brokerage charged on the brokers note.

13. Special Terms Orders

13.1 Interest to trade in special terms shall be advertised through the special terms order book. This shall apply to -

13.1.1 non-standard delivery restricted to immediate settlement, sellers option time bargains and buying-in for settlement; and

13.1.2 ex dividend or ex interest trades.

13.2 Agency and principal orders may be entered into the special terms order book.

13.3 Transactions shall be executed by a member selecting another member's order in the book and indicating its acceptance thereof on a 'hit and take' basis.

13.4 A member may not trade an order entered by itself before 60 minutes has elapsed after entering that order. An agency order must at all times comply with the put-through rule.

13.5 The auxiliary window for the entry of special trade information shall be available during the pre-opening and continuous trading sessions.

13.6 No member shall report trades through the special terms order book with the intention to avoid the satisfaction rule.

14. Entitlements

Members shall be responsible for modifying orders in accordance with corporate actions.

15. Reserved

16. System Availability and Closure

16.1 The JSE will provide all members with reasonable access to the JET system except in the event of -

16.1.1 failure of a member's own network or power supply; or

16.1.2 failure of a member to connect JET terminals to more than one JSE token ring; or

16.1.3 failure of a network or network connection as a result of a member using hardware or software components that do not conform to published specifications; or

16.1.4 problems with access from any remote location outside the direct control of the technical staff of the JSE; or

16.1.5 computer system malfunction, the interruption or failure of communication links, power failure, the failure of or defect in any software or hardware, whether owned by, licenced or leased to the JSE and any loss or damage caused by natural disaster riot insurrection, acts of vandalism, sabotage or similar cause; or

- 16.1.6 equipment breakdown or the breakdown, interruption, suspension, termination or failure of or defect in any system, or any service owned or operated by or on behalf of the JSE; or
- 16.1.7 the termination, for any reason whatsoever, of any licence or other agreement to which the JSE is a party and which impacts on the JSE's ability to provide access to the JET system.
- 16.2 In the event of a member being unable to access the JET system the member shall contact the Business Support Department to assist in identifying the cause of the problem. Should the problem be identified -
 - 16.2.1 as a problem in a member's own office, the member, (provided that the member is situated in the greater Johannesburg area) should contact Business Support to arrange for the use of a JSE back-up site where "live" JET terminals and/or connections are available,
 - 16.2.2 as a general power failure in one or more buildings within the JSE token ring network or a JSE network failure, the member shall notify Business Support immediately.
- 16.3 The President or Acting President may -
 - 16.3.1 in the event of the JSE back-up sites not being able to accommodate members with a connectivity to the JET System, as a result of -
 - 16.3.1.1 a general power failure in one or more buildings within the JSE token ring; or
 - 16.3.1.2 a JSE network failure in one or more buildings within the JSE token ring,
 - 16.3.2 in the event of a general power failure in the Johannesburg Central Business District which has endured for more than thirty minutes;

decide that the market in securities be closed for such period as the President or Acting President may determine, in which event the rules applicable to after hours trading shall apply. Any re-opening of the market on that day shall be preceded by an intra-day pre-opening session unless any two of the Chairman, Deputy Chairman, the Executive President or any one of the aforementioned persons and a stockbroking member of the Trading Issues sub-Committee may decide otherwise.
- 16.4 In the event of members which are located in the Johannesburg Central Business District being unable to enter orders into or amend orders in the order book -
 - 16.4.1 during the pre-opening session, the Market Controller may decide to delay the opening of the market; and
 - 16.4.2 immediately after the opening of the market, for a limited period as the Market Controller may determine, the Market Controller may decide that the market should revert to a pre-opening session.
- 16.5 Members experiencing problems with the JET system may contact the Market Controller to suspend orders already in the system until such time as the member can utilise a JSE back-up site.

17 Adjudication Panel

- 17.1 Notwithstanding the provisions of rule 5.60, the Committee may appoint an Adjudication Panel ("the Panel"), consisting of at least three members of the JSE

Executive to adjudicate in any dispute between securities traders and/or members and related only to dealings or incidents arising out of dealings in securities effected through the JET system. The Panel shall be chaired by the President or, in his absence, his deputy or, in the absence of his deputy, a member of the Committee co-opted in terms of 4 below.

17.2 For the purposes of this Directive, "dispute" shall mean a difference of opinion between securities traders concerning a transaction or transactions where the Panel can, having due regard to the rules, directives and Committee decisions reasonably decide upon an award.

17.3 The Panel shall not adjudicate upon any dispute -

17.3.1 which is considered by the President or, in his absence, his deputy or, in the absence of his deputy, a member of the Committee, to be frivolous or which does not have material financial implications; or

17.3.2 unless a stockbroker, securities trader, or an employee of a member is involved; or

17.3.3 which, failing resolution between the parties, is not submitted forthwith in writing to the Market Controller.

17.4 The Panel -

17.4.1 may co-opt one or more members of the Committee to serve on it; and

17.4.2 shall be entitled, and in relevant cases obliged, to call for expert opinion.

17.5 A stockbroker, securities trader, or employee of a member shall have the right to appeal to the Committee against any finding of the Panel and shall be permitted to introduce new evidence at any subsequent hearing granted by the Committee. Any such appeal shall be lodged with the Market Controller by not later than such time as the Panel may decide.

17.6 The party afforded the right to appeal in terms of 5 shall be required to pay an adjudication fee of R2 000 and which, at the discretion of the Committee, may be refundable in whole or in part.

18. Sellers Option Time Bargains

No member shall execute a sellers option time bargain on behalf of a client or act as a principal with a counterparty in a sellers option time bargain unless the seller has, prior to the execution of the transaction, provided to the member independent proof, in writing, that he is unconditionally legally entitled to the securities to be sold.

19. System Access and Security

19.1 Written application for access to the JET system shall be lodged with the Market Controller and shall be authorised on behalf of a member by the compliance officer of the member.

19.2 The Market Controller will grant a member access to the JET system by the issue of a securities trader identification code subject to-

19.2.1 the member ensuring that at least every 30 days securities traders change their passwords to a different unique password for obtaining access to the system; and

19.2.2 the Market Controller being entitled at any time to restrict access to the system in the event of a system malfunction or where a member has

been allocated securities trader identification codes in excess of the number of its JET terminals.

- 19.3 A member shall be responsible for the due fulfilment of any transactions executed on a securities trader identity code issued to it.

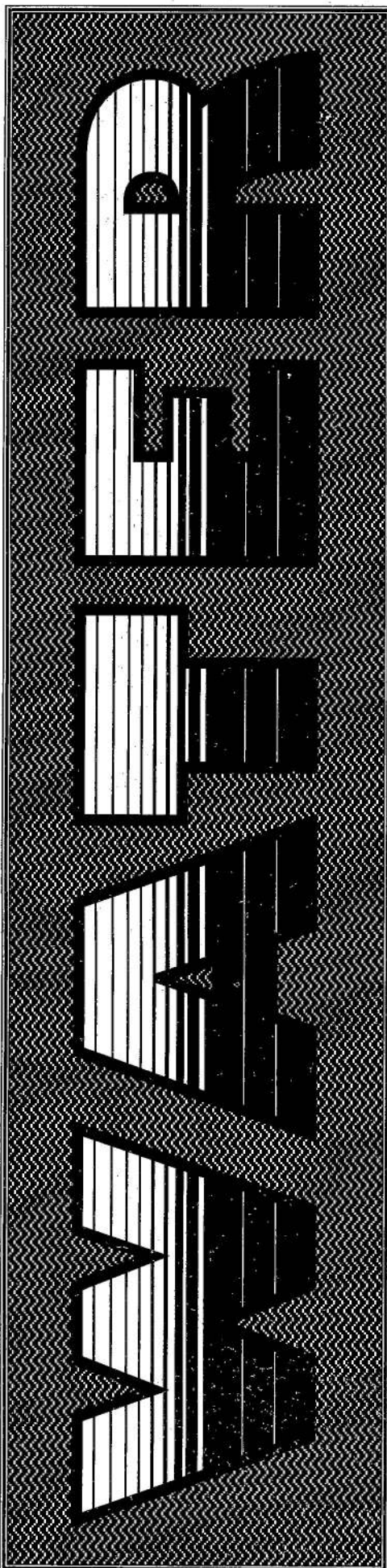
