CHOICE ON TERMINATION OF PREGNANCY ACT, 1996 (ACT NO. 92 OF 1996)

DESIGNATION OF FACILITIES FOR THE SURGICAL TERMINATION OF PREGNANCIES

I, Nkosazana Clarice Dlamini Zuma, Minister of Health, hereby designate, in terms of section 3 of the Choice on Termination of Pregnancy Act, 1996 (Act No. 92 of 1996), the institutions listed in the Schedule to be facilities where the surgical termination of pregnancies may take place in accordance with the said Act.

SCHEDULE**Definitions**

1. In this Schedule any word or expression to which a meaning has been assigned in the Act shall bear such meaning and, unless the context otherwise indicates—

“**access**” means access to resources without these necessarily having to be on-site at a facility;

“**operating theatre**” means an operating unit which is fully equipped to administer a local or general anaesthetic and to deal with any complication that may arise as a result of such an anaesthetic;

“**the Act**” means the Choice on Termination of Pregnancy Act, 1996 (Act No. 92 of 1996).

Requirements to be met by public health facilities and private health facilities in order to be designated facilities in terms of section 3 of the Act

2. Any public or private health facility must meet the following requirements in order to be designated in terms of section 3 of the Act as a facility where the surgical termination of pregnancies may take place:

- (a) Access to medical and nursing staff;
- (b) access to an operating theatre;
- (c) appropriate surgical equipment;
- (d) drugs for intravenous and intramuscular injection;
- (e) emergency resuscitation equipment and access to emergency referral centre or facility;
- (f) access to appropriate transport should the need arise for emergency transfer;
- (g) facilities and equipment for clinical observation and access to in-patient facilities;
- (h) appropriate infection control measures;
- (i) access to safe waste disposal infrastructure; and
- (j) telephonic means of communication.

AANWYSING VAN FASILITEITE VIR DIE CHIRURGIESE BEËINDIGING VAN SWANGERSKAP

Ek, Nkosazana Clarice Dlamini Zuma, Minister van Gesondheid, wys hierby kragtens artikel 3 van die Wet op Keuse oor die Beëindiging van Swangerskap, 1996 (Wet No. 92 van 1996), die inrigtings soos gelys in die Bylae aan as fasiliteite waar die chirurgiese beëindiging van swangerskappe kan plaasvind in ooreenstemming met genoemde Wet.

BYLAE**Woordomsrywings**

1. In hierdie Bylae het 'n woord of uitdrukking waaraan 'n betekenis in die Wet geheg is daardie betekenis en tensy uit die samehang anders blyk, beteken—

“toegang” toegang tot hulpbronne sonder dat dit noodwendig op die terrein by 'n fasiliteit hoef te wees;

“die Wet” die Wet op Keuse oor die Beëindiging van Swangerskap, 1996 (Wet No. 92 van 1996);

“operasietheater” 'n operasie-eenheid wat volledig toegerus is om 'n lokale of algemene narkose te verskaf en om enige komplikasie wat as gevolg van sodanige narkose mag ontstaan, te hanteer.

2. 'n Openbare gesondheidsfasiliteit en 'n privaat gesondheidsfasiliteit moet aan die volgende vereistes voldoen ten einde kragtens artikel 3 van die Wet aangewys te word as 'n fasiliteit waar die chirurgiese beëindiging van swangerskappe kan plaasvind:

- (a) Toegang tot mediese- en verpleegkundige personeel;
- (b) toegang tot 'n operasietheater;

- (c) toepaslike chirurgiese toerusting;
- (d) medisyne vir binnearse en intramuskulêre inspuiting;
- (e) noodresussiteringstoerusting en toegang tot noodverwysingsentrum of -fasiliteit;
- (f) toegang tot toepaslike vervoer wanneer behoefte ontstaan wat nood oorplasing vereis;
- (g) fasiliteite en toerusting vir kliniese observasie en toegang tot binnepasientfasiliteite;
- (h) toepaslike infeksiebeheermaatreëls;
- (i) toegang tot veilige afvalverwyderingsinfrastruktuur; en
- (j) telefoniese middele van kommunikasie.

DOORNDRAAI DAM CATCHMENT GOVERNMENT WATER CONTROL AREA, DISTRICTS OF POTGIETERSRUS AND WATERBERG, NORTHERN PROVINCE: NOTICE IN TERMS OF SECTION 62 (2D) (a) OF THE WATER ACT, 1956 (ACT No. 54 OF 1956): SURVEY OF EXISTING IRRIGATION DEVELOPMENT AND THE IRRIGABLE AREA ON EACH PIECE OF LAND WITHIN THE AREA RIPARIAN TO THE STERK RIVER AND ITS TRIBUTARIES

In this notice any expression to which a meaning has been assigned in the Water Act, 1956, shall bear the same meaning and, unless the context otherwise indicates—

“**irrigable area**” means the irrigable area of a piece of land situated in the Area within a distance of two kilometres horizontally from the river-banks and a static pumping height of 60 metres vertically above the bed of the Sterk River and its tributaries as measured at the nearest rectangular point opposite the public stream concerned and which is in the opinion of the Director-General: Water Affairs and Forestry suitable for the cultivation of crops under irrigation;

“**existing irrigation development**” means the Area comprising the portion of a piece of land within the Area which, on the date of its inclusion in the Area was registered in the office of the registrar of deeds concerned as a separate property and which, in the opinion of the Director-General: Water Affairs and Forestry was irrigated in whole or in part, whether lawfully or unlawfully, with public water at any time during the qualifying period applicable to the Area;

“**existing water work**” means a water work which was used for the abstraction, impoundment, storage or use of public water at any time during the qualifying period for the purpose of irrigating the whole or a portion of that piece of land;

“**date of inclusion**”, with regard to the inclusion of a piece of land in the Area, means 9 November 1984;

“**the Area**” means the Doorndraai Dam Catchment Government Water Control Area established by Proclamation No. 193 of 9 November 1984;

“**the Minister**” means the Minister of Water Affairs and Forestry or his delegate;

“**the Act**” means the Water Act, 1956 (Act No. 54 of 1956);

“**qualifying period**”, with regard to the Area, means the period of 12 months immediately preceding the date of inclusion of a piece of land in the Area;

“**piece of land**” means a piece of land which, on the date of inclusion thereof in the Area, was registered as a separate surveyed unit in the office of the registrar of deeds concerned;

“**piece of land with existing irrigation development**”, with regard to the Area, means a piece of land within the Area which—

- (a) was registered in the office of a registrar of deeds on the date of inclusion thereof in the Area;
- (b) was wholly or partially irrigated with public water, whether lawfully or unlawfully, at any time during the qualifying period;

“**permission**” means an authorisation issued in terms of section 62 (2B) (a) of the Act for the abstraction of public water for new irrigation development on the basis of the provisional determination as approved by the Minister and published by Government Notice No. 2432 of 9 November 1984 in terms of the said section; and

“**provisional right**” means the quantity of public water which may be abstracted, impounded, stored or used for irrigation purposes in terms of section 62 (2A) (a) of the Act in respect of the piece of land with existing irrigation development and which is in the opinion of the Director-General: Water Affairs and Forestry sufficient for the irrigation of the area indicated opposite each piece of land in the Schedule to this Notice.

1. I, Kader Asmal, Minister of Water Affairs and Forestry, acting under the powers vested in me by section 62 (2D) (a) of the Act, publish in the Schedule hereto a list of all the pieces of land in the Area riparian to the Sterk River and its tributaries, in respect of which the Director-General: Water Affairs and Forestry has made a determination in terms of section 62 (2C) (a) of the Act with regard to the irrigable area, as well as the existing irrigation development which was found during a survey in the Area.
2. Any person who feels aggrieved by the Director-General's determination with regard to the irrigable area or existing irrigation development on a piece of land as indicated in the Schedule hereto, or because no determination has been made in respect of any particular piece of land, may in terms of section 62 (2D) (a) of the Act submit an objection in writing within ninety (90) days from the date of publication of this Notice, together with the necessary evidence, charts, statements and proof to substantiate the objection, to the Director-General: Water Affairs and Forestry, Private Bag X313, Pretoria, 0001, for a decision on the objection by the Minister. Any person who feels aggrieved by the Minister's decision, may in terms of section 62 (2D) (c) of the Act, after written notice to the Minister, lodge an appeal to a Water Court against the decision within sixty (60) days from the date on which he was informed of the Minister's decision and the Water Court may, after any investigation which it deems necessary, confirm the Minister's decision or make such other order as the Court deems fit.
3. Any objection to the determination of the irrigable area as indicated in the Schedule in respect of a certain piece of land must be substantiated by a chart compiled according to scale on which the location and extent of any further alleged irrigable land is shown. Furthermore, a report by an approved agronomist is required with regard to the alleged irrigable areas which are shown on the chart, in which it is certified that such land is in fact irrigable.
4. Any objection to the determination of the existing irrigation development as indicated in the Schedule in respect of a certain piece of land must be substantiated by a chart compiled according to scale on which the location and extent of the alleged existing irrigation development is shown, as well as each pump and aqueduct which served such development and an indication of the size, capacity or carrying capacity thereof. The mere existence or presence of cultivated lands and water distribution works will not necessarily be accepted as conclusive evidence that such lands were in fact irrigated during the qualifying period. Each point of abstraction from a public stream must be indicated on the chart and, in respect of a pumping installation, full particulars are required of the pump, motor, delivery capacity, in- and outlets and pumping height. Any claim to existing irrigation development can only be acknowledged to the extent to which an existing water work was capable of serving the alleged existing irrigation development effectively and beneficially during the qualifying period. In a case where the evidence of another person or body is used to substantiate a claim or an objection, such person or body must not have been previously involved in a similar survey in the Area concerned. The right is reserved to request and to obtain any additional particulars and evidence for the verification and confirmation of any claim or objection.
5. After finalising any objection or appeal, the final allocation of water to each piece of land in the Area will be determined in terms of section 62 (2E) of the Act, on the basis of the quantity of public water available taking into account the irrigable areas and existing irrigation development as determined in terms of section 62 (2D) of the Act which allocation shall be published in the *Government Gazette* in terms of section 62 (2F) of the Act and shall replace all provisional rights and permissions previously granted.
6. If a piece of land was or is being or is to be subdivided after the date of inclusion thereof in the Area, the Minister may, in terms of section 62 (6) (b) (i) of the Act, authorise the respective owner(s) to determine at his/their discretion, or, if a portion of the said piece of land created in pursuance of any such subdivision has already been transferred, by agreement with the owner(s) of that portion, that part of the said quantity of public water which may in respect of each portion of the piece of land which was thus created, be abstracted, impounded, stored or used after such subdivision. Should the said owner(s) fail to reach such an agreement, the Minister may, in terms of section 62 (6) (bA) of the Act, direct such owner(s) in writing to make such a determination or, as the case may be, to reach such an agreement within a certain period. Should the owner(s) however, fail or be unable to reach such an agreement within the period so determined, the Minister may in writing direct such owner(s) to submit, within such further period as he may determine, the matter for settlement by arbitration or to a competent court. Should the owner(s) fail to comply with the direction, any provisional right, permission or allocation in respect of the said piece of land, shall, unless the Minister determines otherwise, be suspended until such time as the directive is complied with.
7. Attention is drawn to the fact that any provisional right or permission which resulted from the provisional determination in terms of section 62 (2B) (a) of the Act, shall remain in force until such time as it is replaced by a notice in terms of section 62 (2F) of the Act indicating the final allocation in respect of each piece of land in the Areas. In the meantime no new water work may be erected or any alteration made to an existing water work without first obtaining an authorisation in terms of section 62 (2H) (a) of the Act. SCHEDULE

1. The Council may register as a radiographer in one of the categories of diagnosis, nuclear medicine, therapy or ultrasound any applicant who has obtained after examination any of the following qualifications in radiography in the corresponding category: Provided that—

- (i) no qualification shall be accepted for the purpose of this rule unless the training therefore has extended over a minimum period of two years: Provided further that in the case of qualifications obtained subsequent to 31 December 1984 the period of two years shall be increased to three years;
- (ii) an applicant who is registered with the Council in any one of the categories and who subsequently has obtained by examination a further registrable qualification in an additional category may be registered in such additional category;
- (iii) every person who, prior to 6 March 1959, has been registered by the Council as a radiographer under the provisions of Government Notice No. 1554 of 22 September 1944, as amended, shall be deemed to be registered in the categories of diagnosis and therapy;
- (iv) every person who, prior to 16 September 1977 was registered by the Council as a diagnostic radiographer or a therapeutic radiographer or as both, shall be deemed to be registered in the category of diagnosis or therapy, or both, as the case may be;
- (v) every person who, prior to 1 January 1994 was registered by Council as a radiographer in the category diagnosis shall be deemed to be registered in the category of diagnosis or ultrasound, or both, as the case may be.

- (2) as a radiographer in the category of therapy, any person who, prior to 6 March 1959, obtained the certificate in radiography of the South African Medical and Dental Council, or the diploma in radiography of the University of Pretoria, or who obtained the above certificate or diploma having commenced a recognised course of training therefore prior to 6 March 1959: Provided that no such certificate or diploma obtained after 6 March 1962 shall be accepted for registration;
- (3) as a radiographer any person who has not fully complied with these rules, if the council, after due inquiry, is satisfied that such person is competent to practice as a radiographer.





