THE SITE OF THE AEOROPLANE ACCIDENT IN WHICH PRESIDENT SAMORA MACHEL DIED, NEAR THE MBUZINI SETTLEMENT, BARBERTON DISTRICT, MPUMALANGA PROVINCE

*Description*

The site of the three commemorative structures of brickwork which mark the approximate area of the aeroplane accident in which President Samora Machel of Mozambique and 34 other people died, together with a surrounding area of 500 (five hundred) square metres, situated on unregistered State land near the Mbuzini settlement in the Barberton District, Mpumalanga Province.


