NATIONAL BOARD ON FURTHER EDUCATION AND TRAINING (NBFET)

### CALL FOR NOMINATIONS FOR MEMBERS OF THE BOARD

The National Board for Further Education and Training (NBFET) is a major statutory body established to provide independent, strategic advice to the Minister of Education on matters relating to the transformation and development of further education and training in South Africa.

The NBFET may, on its own initiative, advise the Minister on any aspect of further education and training and must:

(a) advise the Minister on

- ◆ any aspect on further education and training at the request of the Minister;
- ◆ quality promotion and assurance in further education and training;
- ◆ the national further education and training policy, goals and priorities; and
- ◆ the norms and standards in further education and training, including funding norms and the terms, purpose and conditions of earmarked grants;

- (b) receive reports on further education and training from provincial advisory bodies;
- (c) monitor and report annually to the Minister on the goals and performance of the national further education and training system;
- (d) analyse and disseminate information about further education and training; and
- (e) perform any function assigned or delegated to it in terms of any applicable law.

The administrative functions of the NBFET and any of its committees shall be performed by officials of the department who are designated for that purpose by the Director-General.

The NBFET will consist of:

- ◆ a chairperson;
- ◆ ordinary members;
- ◆ co-opted members; and
- ◆ non-voting members.

The membership of the NBFET taken as whole should:

- ◆ be broadly representative of the further education and training system and related interests;
- ◆ have a thorough knowledge and understanding of further education and training;
- ◆ appreciate the role of the further education and training system in the reconstruction and development process; and
- ◆ have known and attested commitment to the interests of further education and training.

In addition to this, the NBFET should reflect representivity on such relevant grounds as race, gender and disability.

The members of the NBFET will be appointed in their personal capacities and will be expected to serve the interests of the whole sector.

The chairperson of the NBFET will hold office for a period of four years. Every ordinary member of the NBFET will hold office for a period of four years. Any co-opted member of the NBFET will hold office for a period determined by the NBFET. The chairperson and ordinary members of the NBFET may not serve for more than two consecutive terms of office.

Now, therefore, I, Sibusiso Mandlenkosi Emmanuel Bengu, Minister of Education, hereby request:

- (a) the public
- (b) national and provincial organisations representing students, academic employees, employees other than academic employees, university principals, technikon principals, principals of further education and training institutions, the further education and training sector, educators, teacher unions, organised business and organised labour; and
- (c) non-governmental organisations;

to submit to me, **before 30 September 1998**, names of persons who by virtue of their knowledge and experience, may be considered for appointment *as chairperson or ordinary members* of the aforesaid Board.

Nominations, accompanied by *a motivation, the Curriculum Vitae* of the nominee and a *letter of consent* indicating the availability of the nominee to serve on the National Board for Further Education and Training if selected, should be forwarded to:

(NRVOO)****UITNODIGING VIR NOMINASIES VIR LEDE VAN DIE RAAD**

Die Nasionale Raad vir Verdere Onderwys en Opleiding (NRVOO) is 'n vername statutêre liggaam wat in die lewe geroep word om onafhanklike strategiese advies aan die Minister van Onderwys te gee in verband met sake rakende die transformasie en ontwikkeling van verdere onderwys en opleiding in Suid-Afrika.

Die NRVOO mag op eie inisiatief die Minister adviseer oor enige aspek van voortgesette onderwys en opleiding en moet:

(a) Die Minister adviseer oor:

- ◆ enige aspek van verdere onderwys en opleiding op versoek van die Minister;
- ◆ die bevordering en versekering van die kwaliteit van verdere onderwys en opleiding;
- ◆ die nasionale beleid, doelstellings en prioriteite van verdere onderwys en opleiding; en
- ◆ norme en standarde in verdere onderwys en opleiding, insluitend die norme van befondsing en die voorwaardes, doel en riglyne van geoormerkte toekennings;

(b) verslae oor verdere onderwys en opleiding ontvang vanaf provinsiale adviserende liggeme;

(c) die doelstellings enlewering van die nasionale stelsel van verdere onderwys en opleiding moniteer en daaroor aan die Minister verslag lewer;

(d) inligting oor verdere onderwys en opleiding analyseer en dissemineer; en

(e) enige funksie uitvoer wat aan die raad toegewys is of na die raad gedelegeer is in terme van enige toepaslike wet.

Die administratiewe take van die NRVOO en enige van sy komitees sal verrig word deur beamptes van die departement wat vir daardie doel deur die Direkteur-Generaal aangewys is.

Die NRVOO sal uit die volgende lede bestaan:

- ◆ 'n Voorsitter;
- ◆ Gewone lede;
- ◆ Gekoöpteerde lede; en
- ◆ Nie-stemgeregtigde lede.

Die lede van die NRVOO moet in die geheel:

- ◆ verteenwoordigend wees van die stelsel van verdere onderwys en opleiding en verwante belang;
- ◆ beskik oor 'n grondige kennis en begrip van verdere onderwys en opleiding;
- ◆ die rol van verdere onderwys en opleiding in die heropbou- en ontwikkelingsproses na waarde ag; en
- ◆ oor 'n bewese toegewyheid aan die belang van verdere onderwys en opleiding beskik.

Daarbenewens moet die NRVOO verteenwoordigend wees ten opsigte van ras, geslag en gestremdheid.

Die lede van die NRVOO sal in hul persoonlike hoedanighede aangestel word. Daar sal van lede verwag word om die belang van die hele sektor te dien.

Die voorsitter van die NRVOO sal aangewys word vir 'n termyn van vier jaar. Elke gewone lid sal ook vir 'n termyn van vier jaar aangewys word. Enige gekoöpteerde lid van die NRVOO sal sy/haar posisie beklee vir die tydperk wat deur die NRVOO bepaal is. Die voorsitter en gewone lede van die NRVOO mag nie vir meer as twee opeenvolgende termyne in die Raad dien nie.

Daarom vra ek, Sibusiso Mandlenkosi Emmanuel Bengu, Minister van Onderwys, hiermee:

- a) die publiek;
- b) nasionale en provinsiale organisasies verteenwoordigend van studente, akademiese personeel, nie-akademiese personeel, universiteitshoofde, technikonhoofde, hoofde van instansies vir verdere onderwys en opleiding, die verdere onderwys- en opleiding-sektor, opvoeders, onderwysersunies, die georganiseerde sakewêreld en georganiseerde arbeid; en
- c) nie-regeringsorganisasies;

om voor 30 September 1998 die name van persone wie op grond van hul kennis en ervaringoorweeg kan word vir moontlike aanstelling as voorsitter of gewone lede van die voorafgenoemde Raad aan my voor te lê.

Nominasies moet vergesel word van 'n motivering, 'n *Curriculum Vitae* en 'n *toestemmingsbrief* van die genomineerde om aan te dui dat hy/sy beskikbaar is om op die Raad te dien. Nominasies moet gestuur word aan:





