1. Provincial Road No: P154/3, commencing at a point on the boundary between the farms Zeekoewater No: 311 – JS and Kromdraai No: 292 – JS, (Municipal Area of Witbank) proceeding in a general eastern direction up to the boundary between the farms Kromdraai No: 292 – JS and Elandspruit No: 291 – JS, (District of Witbank) also known as the Witbank/ Middelburg District Boundary and as declared per Administrator Notice No: 506 of April 30, 1980 and No: 557 of May 20, 1981; and
2. Provincial Road No: P154/3, commencing at a point on the boundary between the Witbank/ Middelburg District Boundary (at a point between the farms Kromdraai No: 292 – JS and Elandspruit No: 291 – JS) [District of Witbank] proceeding in a general north-eastern direction up to a point approximately 70 metres south - west of the junction between Church- and Hobson Street on the farm Middelburg Town and Townlands No: 287 – JS (Municipal Area of Middelburg) and as declared per Administrator Notice No: 385 of December 4, 1973.
