NOTICE OF INTENTION TO AMEND TRINITY BROADCASTING NETWORK (TBN) COMMUNITY TELEVISION LICENCE

The Independent Broadcasting Authority (the Authority) hereby gives notice in terms of section 52 (2)(a) of the Independent Authority Broadcasting Authority Act (the Act) 153 of 1993, as amended, that an application has been received in terms of section 52 (1)(c) for an amendment to Trinity Broadcasting Network (TBN) Community Television licence as stipulated hereinafter:

- to make provision for an increase in power in respect of the transmitter situated at Windy Ridge in the Amatola mountains from 5 kilowatt to 20 kilowatt, and/or
- 2) to make provision for the utilisation of channel 49 (625.25 MHz), currently reserved for Community Television, until the Authority is in a position to invite applications for licences for such category of licences. The channel will be used to service the area currently serviced by the Windy Ridge transmitter.

The Authority shall at the request of any person and on payment of such fees as prescribed furnish him/her with a certified copy of or extracts from any part of the application or representation.

The proposed amendment, if approved, will take effect on the date of gazetting of the decision of the Authority with regards thereto in terms of section 52 (4) of the Act.
