APPLICATION TO AMEND BROADCASTING LICENCE: PUNT MEDIA (PROPRIETARY) LIMITED

The Independent Broadcasting Authority hereby gives notice in accordance with section 52(2) (a) of the Independent Broadcasting Authority Act No. 153 of 1993, that an application has been received in terms of section 52 (1) (c) for an amendment to the Broadcasting Licence of Punt Media (Proprietary) Limited broadcasting as Punt Op Mediumgolf (Johannesburg) to make provision for the following changes to the frequency and consequential changes to the technical specifications of the licensee. Currently, the station transmits on 1332 kHz at 50 kW. The proposed change in the frequency transmission will be to 729 kHz at 50kW. In addition the licensee has applied to change from the present two transmitter sites to one new site in Grootfontein.
