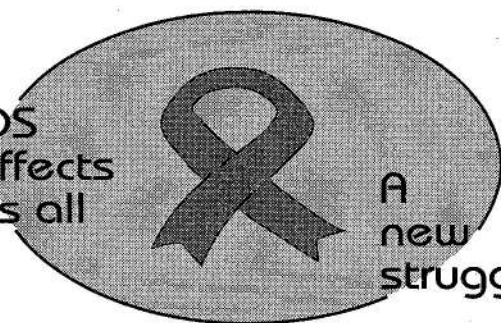

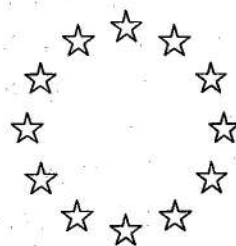

The Board on Tariffs and Trade (the Board) initiated on 4 December 1998 the review of the anti-dumping duties which were imposed on the Republic of India and the Republic of Singapore. The notice of initiation was published in *Government Gazette* No. 19772 dated 26 February 1999 (Notice No. 296).

No party except the SACU manufacturer responded. The SACU manufacturer alleged that it will be suffering material injury if the anti-dumping duties were terminated and therefore material injury to the SACU industry will be occurring as a result.

The Board subsequently made a preliminary determination not to terminate the anti-dumping duty against acetaminophenol originating in or imported from India on the grounds that it made a finding that there exist a threat of material injury if the duty was terminated. However, the Board made a preliminary determination to terminate the anti-dumping duty which was imposed on acetaminophenol originating in and imported from Singapore as the product is not manufactured in Singapore but merely transhipped from India via Singapore.

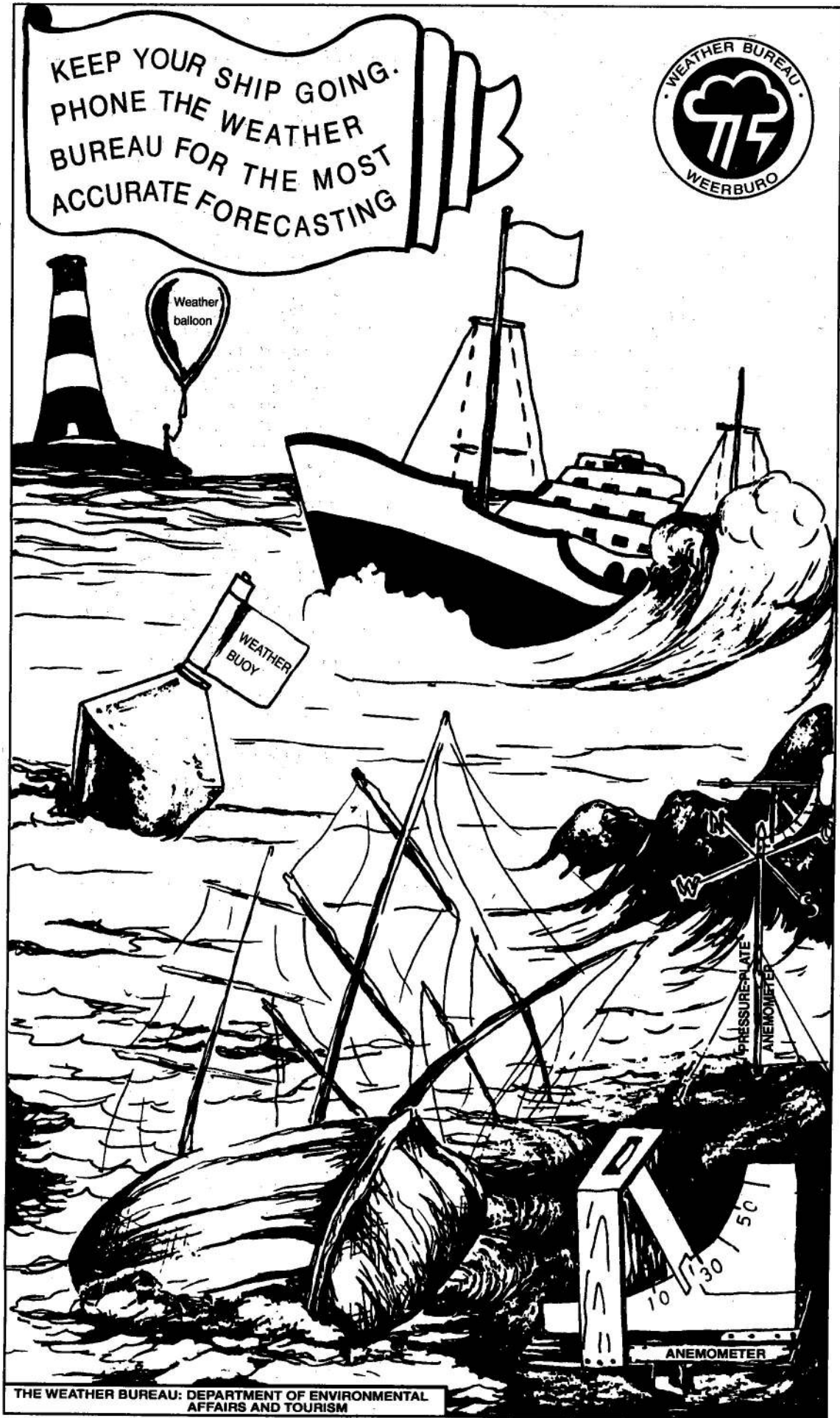
