



### COMPETITION COMMISSION

#### NOTIFICATION OF PROPOSED TRANSACTION BETWEEN MAWENZI RESOURCES LIMITED AND BRAIT ASSET MANAGERS (PROPRIETARY) LIMITED

The Competition Commission hereby gives notice in terms of Rule 26 (8) (a) (iii) that Mawenzi Resources Limited has filed a notification with the Competition Commission on 21 October 1999, in terms of section 13 of the Competition Act, 1998 (Act No. 89 of 1998), of the proposed acquisition, through its wholly owned subsidiary Mawenzi Financial Services Limited, of the entire issued share capital of Brait Asset Managers (Proprietary) Limited from Brait South Africa Limited, as well as the claims which Brait South Africa Limited has against Brait Asset Managers (Proprietary) Limited.
