## APPLICATION TO AMEND BROADCASTING LICENCE: RADIO ORANJE (PROPRIETARY) LIMITED

The Independent Broadcasting Authority hereby gives notice in accordance with section 52(2) (a) of the Independent Broadcasting Authority Act No. 153 of 1993, that an application has been received in terms of section 52 (1) (c) for an amendment to the Broadcasting Licence of Radio Oranje (Proprietary) Limited to amend its technical specifications in Schedule B2 of its licence. The amendment would result in Radio Oranje ceasing to use four (4) transmitters which are situated at De Aar, Springfontein, Boesmanskop and Witsieshoek respectively.

The effective date of the proposed amendment would be the date on which the Authority's decision on the application would be published.
