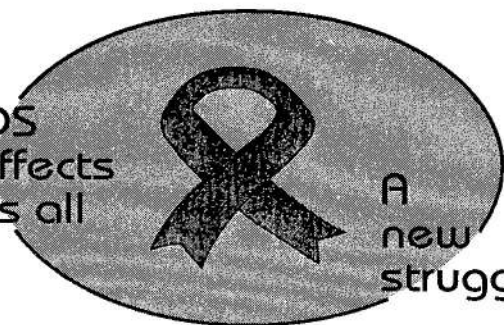

INDEPENDENT BROADCASTING AUTHORITY

APPLICATION TO AMEND BROADCASTING LICENCE: CAPE COMMUNITY FM

The Independent Broadcasting Authority hereby gives notice in accordance with section 52 (2) (a) of the Independent Broadcasting Authority Act No. 153 of 1993 as amended, that an application has been received from Cape Community FM (CCFM), in terms of section 52(1) (c) for an amendment of its Licence Conditions. CCFM is applying to increase its broadcasting hours from 12hours to 24hours per day from Monday to Sunday. CCFM is sharing frequency 104 fm with Radio Tygerberg. CCFM proposes that Radio Tygerberg should be moved from frequency 104 fm and be relocated to frequency 89.5 fm, such that it (Radio Tygerberg) shares frequency 89.5 fm with Bush Radio. This application, if approved, would result in CCFM being the only broadcaster on frequency 104 fm; alternatively that CCFM should be relocated to frequency 89.5fm and Bush Radio should be relocated to frequency 104 fm. This application, if granted, would result in CCFM being the only station broadcasting on frequency 89.5 fm.

The application, the relevant Schedules and any written representations received pursuant thereto are available for inspection by any interested parties during office hours of the Authority.

The effective date of the proposed amendment, if granted, would be the date on which the Authority's decision on the application would be published.
