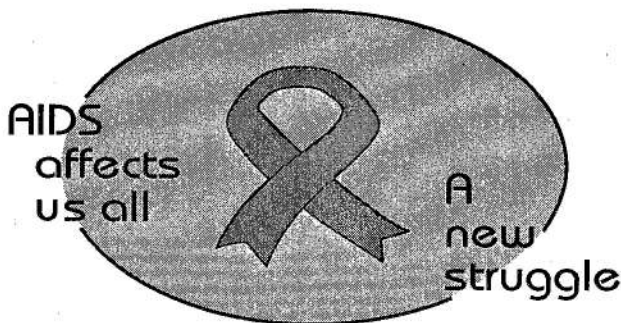

SECTION 69 (7) OF THE BANKS ACT, 1990 (ACT No. 94 OF 1990)

WITHDRAWAL OF CURATORSHIP: NEW REPUBLIC BANK LIMITED (UNDER CURATORSHIP)

With reference to Government Notice No. 134 of 2 February 1999, it is hereby notified, for general information, that whereas an arrangement referred to in Chapter XII of the Companies Act, 1973 (Act No. 61 of 1973), between Saambou Bank Limited and New Republic Bank Limited ("NRB") and its creditors was sanctioned by the High Court of South Africa on 24 November 1999, and registered by the Registrar of Companies of 29 November 1999, the Minister of Finance has, in terms of the provisions of section 69 (4) of the Banks Act, 1990 (Act No. 94 of 1990), with effect from 24 November 1999, withdrawn the appointment of Mr P. J. Strydom, attached to the firm Ernst & Young, Chartered Accountants (S.A.), as curator of NRB.
