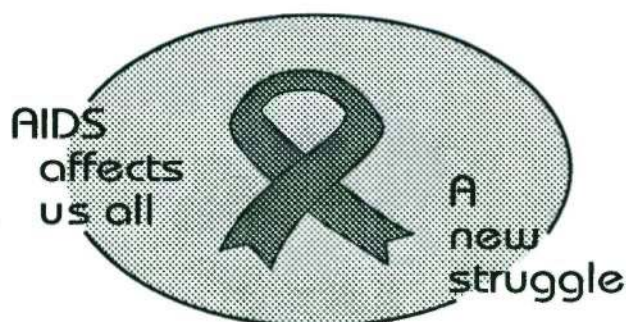

NOTICE OF THE INDEPENDENT BROADCASTING AUTHORITY'S DECISIONS REGARDING THE APPLICATION BY THE SOUTH AFRICAN BROADCASTING CORPORATION (SABC) FOR AMENDMENT OF ITS PUBLIC SOUND BROADCASTING LICENCE AND CONSEQUENTIAL AMENDMENTS

The Independent Broadcasting Authority hereby gives notice in accordance with section 52 (4) of the Independent Broadcasting Authority Act, no 153 of 1993, as amended, that it has decided as follows in respect of the application by SABC for the amendment of its Public Sound Broadcasting Licence, the amendment of Sentech's Signal Distribution Licence and the amendment of Radio Pretoria's Temporary Community Sound Broadcasting and Signal Distribution Licences:

A new transmitter operated by Sentech for the SABC to be installed at Middleburg on a frequency of 107.4 MHz to carry UKHOZI FM;
--

The transmitter operated by Sentech for the SABC at Dullstroom to change from the present frequency of 107.6 MHz to 107.7 MHz, all other technical parameters to remain unchanged. This transmitter carries the services of IKWEKWEZI FM.

The transmitter operated by RADIO PRETORIA from the Balfour site to change from the present frequency of 107.5 MHz to 107.6 MHz, all other technical parameters to remain unchanged.
--

This application forms the second phase of the SABC's application to upgrade its public broadcasting service language stations to reach 80% of the people who speak the principal languages of the respective stations. The SABC filed its application on 26 August 1998. In an effort to expedite the delivery to under-serviced language groups, the Authority decided on 19 May 1999 to consider the SABC's application in two phases. The first phase was granted and it came into effect on 1 June 1999. Details of the first phase were published in *Government Gazette* No. 20850 Notice No. 346 of 1 February 2000. Details of the application for the second phase were also published in the same publication.

The effective date of the above amendments would be the date of this publication.
