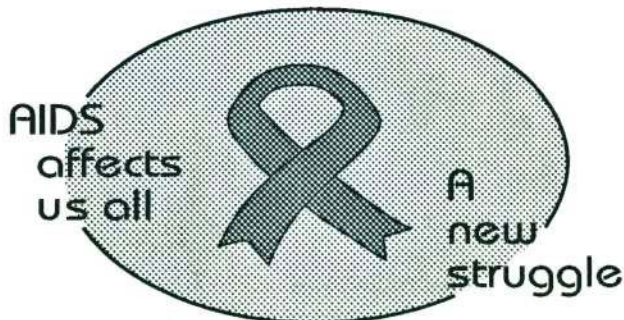

APPLICATION FOR AN AMENDMENT OF A COMMUNITY SOUND BROADCASTING LICENCE: OVERVAAL STEREO

The Independent Broadcasting Authority hereby gives a notice in accordance with the provisions of section 52(2)(a) of the Independent Broadcasting Authority Act, No.153 of 1993 (the Act), as amended, that an application has been received, in terms of section 52(1)(c) of the Act, from Overvaal Gemeenskap Trust, broadcasting as Overvaal Stereo in Free State Province, to amend its licence conditions by increasing its Effective Radiated Power (ERP) from 200watts to 5000watts.

The application, the relevant schedules and any written representations received pursuant thereto are available for inspection by any interested parties during office hours of the Authority.

The effective date of the amendment would be the date on which the Authority's decision on the amendment would be published.

NOTICE 2084 OF 2000**INDEPENDENT BROADCASTING AUTHORITY****PROPOSED AMENDMENT OF A COMMERCIAL SOUND BROADCASTING
LICENCE: PUNT OP MEDIUMGOLF**

The Independent Broadcasting Authority (the Authority), acting in accordance with the provisions of Section 52(2)(a) of the Independent Broadcasting Authority Act 153 of 1993 (the Act), as amended, hereby gives notice that it intends amending the commercial sound broadcasting licence of Punt op MediumGolf (Johannesburg) in accordance with the provisions of section 52(1)(a) of the Act. The proposed amendment would, if effected, result in Punt op MediumGolf (Johannesburg) broadcasting on frequency 1332 kHz.

On 17 May 1999, Punt op MediumGolf (Johannesburg) submitted an application to amend amongst other things, its frequency from 1332 kHz to 729 kHz. The application was published in Government Gazette no. 20143 dated 01 June 1999. A hearing into the application was conducted on 05 August 1999. Notice of intention to hold such a hearing was published in Government Gazette no. 20270 dated 30 June 1999.

Subsequent to the hearing, the Authority decided, on the strength of information provided by Punt op MediumGolf (Johannesburg), to grant the application to change the frequency from 1332 kHz to 729 kHz. The Authority's decision was published in Government Gazette no. 20489 dated 20 September 1999. However, the Applicant subsequently indicated that the use of frequency 729 kHz would not be feasible. Therefore, the Authority intends amending Punt op MediumGolf (Johannesburg)'s licence conditions, in the interest of orderly frequency management, to allow the licensee to broadcast on its former allocated frequency of 1332 kHz.

The effective date of the amendment would be the date on which the Authority's decision on the amendment would be published.
