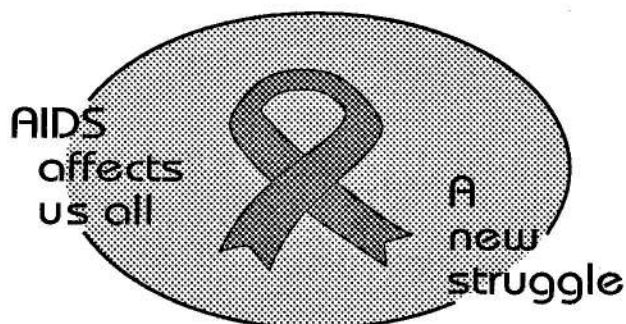

MUNICIPAL DEMARCATION BOARD NOTICE IN TERMS OF SECTION 6 OF THE MUNICIPAL STRUCTURES ACT, 1998 (AS AMENDED)

In terms of section 6 of the Municipal Structures Act, 1998 (Act No.117 of 1998) the Municipal Demarcation Board, after having consulted the Minister and the MECs responsible for local government in the provinces, hereby declares the part of the area that must have municipalities of both category C and category B, as district management area as reflected in the attached Map No. 27.

Map No 27 published in Government Gazette 20972 of 10 March 2000 is hereby withdrawn.
