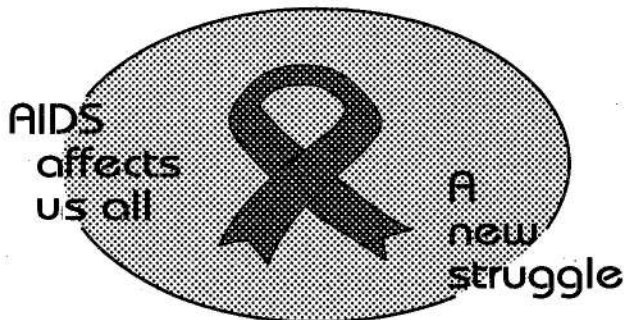

INDEPENDENT BROADCASTING AUTHORITY

APPLICATION TO AMEND BROADCASTING LICENCE: SOUTH AFRICAN BROADCASTING CORPORATION (SABC) - SABC TV 1 & 2 - GANYESA

The Independent Broadcasting Authority hereby gives notice, in accordance with the provisions of section 52 of the Independent Broadcasting Authority Act, No. 153 of 1993, (the Act) that an application has been received in terms of section 52 of the Act, for amendments to the South African Broadcasting Corporation's (SABC) television broadcasting licence. The amendment if granted, would enable several areas in the North West Province to receive the services of SABC 1 & 2 as they currently only receive the services of BOP TV.

The application to amend the licence would result in the Authority enabling the SABC to provide the services of SABC 1 and 2 to the population in and around Ganyesa and Taung. The re-allocation of the channels and services is proposed as follows:

1. Channel 42 and 46, presently at the Ganyesa site to be re-allocated to the Piet Plessis transmitter site.
2. Channel 22, 26, 30, 34 presently allocated to Piet Plessis to be re-allocated to Ganyesa.
3. Allocate channels 22,26 and 30 at Ganyesa to SABC 1, SABC2 (which would be new services in the area) and BOP TV respectively, operating at 30 000 watts ERP each.
4. Channels 47 and 51, presently not allocated in the area, to be allocated to Taung.
5. Move the service of BOP TV at Ganyesa from channel 42 to channel 30.
6. Operate SABC 1 and 2, at Taung (which will be new services) at 1 700 watts ERP.

NOTICE 2248 OF 2000**APPLICATION TO AMEND BROADCASTING LICENCE: SOUTH AFRICAN BROADCASTING CORPORATION (SABC) - SABC TV3**

The Independent Broadcasting Authority hereby gives notice, in accordance with section 52 of the Independent Broadcasting Authority Act, No. 153 of 1993, (the Act) that an application has been received in terms of section 52(2)(a) of the Act, for amendments to the South African Broadcasting Corporation's (SABC) television broadcasting licence. The amendment if granted, would enable the SABC to expand the existing SABC3 footprint in high-density largely metropolitan areas.

The expansion if approved will increase the SABC3 footprint to reach 76.6% of the available population. The expansion of the SABC3 footprint will however not increase the SABC's market share but will offer existing viewers more choices. The proposed expansion involves power upgrades, at the following sites:
