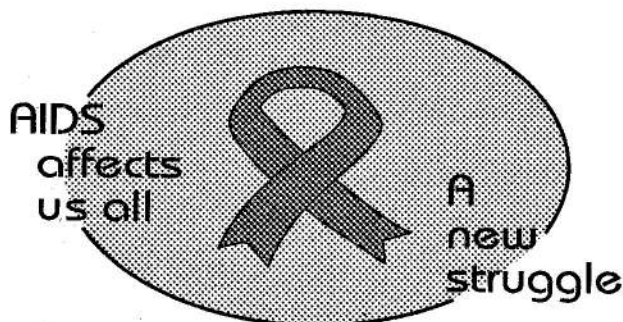

NOTICE 2252 OF 2000

AMENDMENT OF THE RULES OF THE GOVERNMENT EMPLOYEES PENSION FUND

Under the powers vested in me under section 29 and 6A of the Government Employees Pension Law, 1996 (Proclamation No. 21 of 1996), I hereby amend the Rules of the Government Employees Pension Law, 1996, as set out in the Schedule.

SCHEDULE

Definitions

In this Schedule, unless the content indicates otherwise,

- 1.1 “commencement date” shall mean the date on which this Schedule comes into operation;
- 1.2 “the Rules” shall mean the Rules made in terms of the Government Employees Pension Law, 1996 (Proclamation No. 21 of 1996).

Amendment of rule 10 of the Rules

- 2. Rule 10 of the Rules is hereby amended by the insertion of the following rule 10.5 after rule 10.4:

“10.5 a period which relates to a waiting period of a previous fund or the Temporary Employees Pension Fund, where such waiting period is, in the opinion of the Board, discriminatory to members.”

Amendment of rule 11 of the Rules

- 3. Rule 11 of the Rules is hereby amended by-

- 3.1 the insertion of the following rule 11.7 after rule 11.6:

“11.7 If additional pensionable service is recognised in terms of rule 10.5, no amount shall be payable to the Fund if the additional financial obligation on the Fund due to such recognition of service, is not in

excess of a specific amount as calculated by the actuary. Such amount shall be an amount agreed upon after negotiations and agreement within the relevant bargaining structures of the Public Service."

3.2 the insertion of the following rule 11.8 after rule 11.7:

"11.8 The amount of any financial obligation on the Fund which exceeds the specific amount referred to in rule 11.7 shall be paid by the employer to the Fund."

Commencement date

4. The provisions of this Schedule shall come into operation on the date of publication.
