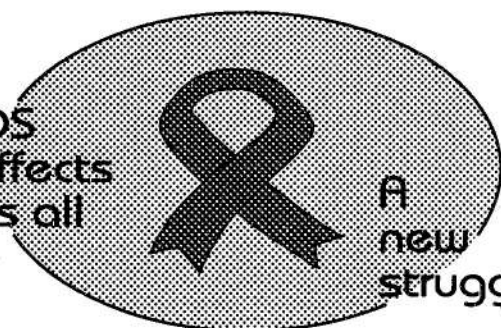

GENERAL NOTICE ALGEMENE KENNISGEWING

NOTICE 2422 OF 2000

THE SOUTH AFRICAN COUNCIL FOR TOWN AND REGIONAL PLANNERS

The South African Council for Town and Regional Planners has in terms of section 28(1) of the Town and Regional Planners Act, 1984 (Act No. 19 of 1984), amended the Rules published in *Government Gazette* No. 15093 of 3 September 1993, as set out in the Schedule hereto.

SCHEDULE

The Rules published in *Government Gazette* No. 15093 of 3 September 1993, are hereby amended :

- (a) By the substitution for rule 7.6.1 of the following rule :

“7.6.1 A registered town and regional planner or town and regional planning technician may only practice, other than as a sole proprietor –

- (a) In partnership; or
- (b) as a director of a private company registered in terms of the Companies Act, 1973 (Act No. 61 of 1973); or
- (c) as a member of a close corporation registered in terms of the Close Corporations Act, 1984 (Act No. 69 of 1984),

which performs town and regional planning work, on condition that :

- (a) The prior written approval of the Council to do so has been obtained; and
- (b) all the partners, shareholders and directors or close corporation members, as the case may be, are to be exclusively from the professions of town and regional planners or town and regional planning technicians, land surveyors, quantity surveyors, architects or engineers, all duly registered in terms of the relevant legislation pertaining to their professions, or such other persons as the Council may approve; and
- (c) the names of all the partners, directors or close corporation members, appear on all documentation bearing the institution's name, issued to any third parties and in the case of all town planners and regional town planners, their names are followed respectively by the titles TRP(SA) or TRPT(SA); and
- (d) a written undertaking be given by the town and regional planner or town and regional planning technician, in favour of such person or bodies, as may be required by the Council and worded according to the requirements stipulated by the Council, confirming that –
 - (i) all town and regional planning work undertaken by such institution will be under the control of; and
 - (ii) the responsibility in respect of such work will be carried by

the town and regional planner or town and regional planning technician.”.

- (b) By the deletion of rules 7.6.2 and 7.6.3; and
- (c) by renumbering the existing rules 7.6.4 to 7.6.11 as follows :
 - (i) Rule 7.6.4 to become rule 7.6.2
 - (ii) Rule 7.6.5 to become rule 7.6.3
 - (iii) Rule 7.6.6 to become rule 7.6.4
 - (iv) Rule 7.6.7 to become rule 7.6.5
 - (v) Rule 7.6.8 to become rule 7.6.6
 - (vi) Rule 7.6.9 to become rule 7.6.7
 - (vii) Rule 7.6.10 to become rule 7.6.8; and
 - (viii) Rule 7.6.11 to become rule 7.6.9.

KENNISGEWING 2422 VAN 2000**DIE SUID-AFRIKAANSE RAAD VIR STADS- EN STREEKBEPLANNERS**

Die Suid-Afrikaanse Raad vir Stads- en Streekbeplanners het ingevolge artikel 28(1) van die Wet op Stads- en Streekbeplanners, 1984 (Wet No. 19 van 1984), die Reëls gepubliseer in *Staatskoerant* No. 15093 van 3 September 1993, gewysig soos in die Bylae hierby uiteengesit.

BYLAE

Die Reëls gepubliseer in *Staatskoerant* No. 15093 van 3 September 1993, word hierby gewysig :

- (a) Deur reël 7.6.1 deur die volgende reël te vervang :

“7.6.1 ‘n Geregistreerde stads- en streekbeplanner of stads- en streekbeplanningtegnikus mag slegs praktiseer, anders as ‘n alleen-eienaar –

- (a) in vennootskap; of

- (b) as ‘n direkteur van ‘n privaat maatskappy geregistreer ingevolge die Maatskappywet, 1973 (Wet No. 61 van 1973);
of

- (c) as ‘n lid van ‘n beslote korporasie geregistreer ingevolge die Wet op Beslote Korporasies, 1984 (Wet No. 69 van 1984),

wat stads- en streekbeplanningwerk verrig, op voorwaarde dat :

- (a) Die voorafskriftelike toestemming om so te doen, van die Raad verkry is; en
- (b) al die vennote, aandeelhouders en direkteure of lede van die beslote korporasie, na gelang van die geval, uitsluitlik van die professie van stads- en streekbeplanners of stads- en streekbeplanningtegnici, landmeters, bourekenaars, argitekte of ingenieurs moet wees, almal behoorlik geregistreer ingevolge die betrokke wetgewing met betrekking tot hulle professies, of sodanige ander persone wat die Raad mag goedkeur; en
- (c) die name van al die vennote, direkteure of lede van die beslote korporasie op al die dokumentasie wat die instansie se naam bevat, uitgereik aan derde persone, verskyn en in die geval van stadsbeplanners en streekstadsbeplanners, hulle name deur die titels SS(SA) of SST(SA) onderskeidelik gevolg word; en
- (d) 'n skriftelike onderneming deur die stads- en streekbeplanner of stads- en streekbeplanningtegnikus gegee word ten gunste van sodanige persoon of liggame soos vereis word deur die Raad en bewoord is in ooreenstemming met die vereistes wat die Raad neerlê, wat bevestig dat –
 - (i) alle stads- en streekbeplanningwerk onderneem deur so 'n instansie onder beheer sal wees van; en
 - (ii) die verantwoordelikheid ten opsigte van sodanige werk gedra sal word deur

die stads- en streekbeplanner of die stads- en streekbeplanningtegnikus.”.

(b) Deur reëls 7.6.2 en 7.6.3 te skrap; en

(c) die bestaande reëls 7.6.4 tot 7.6.11 soos volg te hernoem :

- (i) Reël 7.6.4 word reël 7.6.2
 - (ii) Reël 7.6.5 word reël 7.6.3
 - (iii) Reël 7.6.6 word reël 7.6.4
 - (iv) Reël 7.6.7 word reël 7.6.5
 - (v) Reël 7.6.8 word reël 7.6.6
 - (vi) Reël 7.6.9 word reël 7.6.7
 - (vii) Reël 7.6.10 word reël 7.6.8
 - (viii) Reël 7.6.11 word reël 7.6.9.
