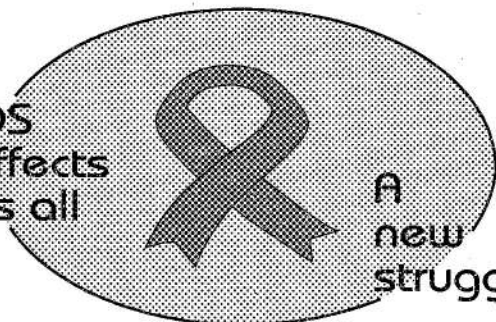

AMENDMENT OF SCHEDULE 1 OF THE PUBLIC SERVICE ACT, 1994 (PROCLAMATION No. 103 OF 1994)

Under the powers vested in me by section 7 (5) (a) (i) of the Public Service Act, 1994 (Proclamation No. 103 of 1994), I hereby amend, with effect from 1 July 2000, Schedule 1 of the said Act, by the insertion of the words "**Department of Social Development**" and "**Director-General: Social Development**" after the words "Department of Safety and Security" and "Director-General: Safety and Security" where they appear in columns 1 and 2 respectively, and the deletion of the words "**Department of Welfare**" and "**Director-General: Welfare**" where they appear in columns 1 and 2 of Schedule 1, respectively.

WYSIGING VAN BYLAE 1 VAN DIE STAATSDIENSWET, 1994 (PROKLAMASIE No. 103 VAN 1994)

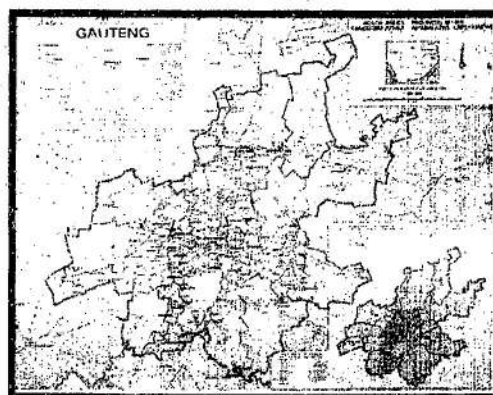
