That only passengers in possession of through tickets to or from points beyond Pretoria and/or Johannesburg may be conveyed, and no local passengers may be conveyed between Pretoria and Johannesburg, both points inclusive. 2. That the passengers be in possession of tickets for conveyance further than Johannesburg en route on an Intercity service. *Service 9: Johannesburg — Nelspruit:* *Forward route:* Johannesburg (Leyds Street Terminus) N1 to Pretoria, N4 to Witbank, Middelburg, Nelspruit. *Route return:* As for forward route in reverse direction. *Alternative route forward:* Johannesburg (Leyds Street Terminus) — R22 to Witbank, then N4 as for forward route above. *Alternative route return:* As alternative route forward in reverse direction. *Restrictions:* No intermediate passengers within any Municipality or between Johannesburg and Pretoria. Stops and routes through towns and cities as directed by the Local Municipal Authorities. *Service 10: Johannesburg — Nelspruit/Komatipoort:* *Route forward:* Johannesburg (Leyds Street Terminus) via Harrison Street, Wolmarans Street, Viljoen Street, Smit Street, M1 North, N1 to Pretoria, N4 to Witbank, Middelburg, Nelspruit, Komatipoort. *Route return:* As for forward route, entering Johannesburg at Braamfontein off-ramp Smit Street, Loveday Street and terminus in Leyds Street. *Alternative route return:* As alternative route forward in reverse direction. *Restrictions:* No intermediate passengers within any Municipality or between Johannesburg and Pretoria. Stops and routes through towns and cities as directed by the Local Municipal Authorities. *Service 11: Johannesburg — Durban:* *Route forward:* Johannesburg, Leyds Street, Frederick Street, Simmonds Street, Village Road, M2 and N3 Durban via Harrismith, and when required also Heidelberg, Villiers, Warden, Harrismith, Ladysmith, Estcourt, Mooi River, Pietermaritzburg, Western Freeway, Commercial Road, Soldiers Way, Pine Street, Brickhill Road, West Street, Marine Parade, Durban. *Route return:* Durban Marine Parade, Rutherford Street, Point Road, Brickhill Road, Pine Street, Western Freeway, N3 then as forward route in reverse to M2, then Rissik Street, Wolmarans Street, Loveday Street, Leyds Street, Johannesburg. *Alternative routes forward:* (a) As forward route to Heidelberg, then R23 to Ladysmith via Newcastle, National Road N3 to Durban as forward route. (b) Johannesburg Leyds Street, Harrison Street, Marshall Street, John Page Drive, Jules Street, Stanhope Street, R29, Johann Rissik Road, Germiston, M46, Boksburg, M46, Commissioner Street, M43, R29, Benoni, M45, Brakpan, M45, R554, R51, Springs, R51, Nigel, R51, Heidelberg, N3 (south) then as per existing

Municipality. *Service 22: Johannesburg — Richards Bay:* From terminus at Leyds Street, Johannesburg via Harrison Street, Wolmarans Street, Viljoen Street, Smit Street, M1 South, M2 East and N2 to Heidelberg, then R23 to Standerton, Volksrust and Newcastle. Then via R68 past Dundee and Nqutu to Melmouth. Then via R34 to Empangeni and Richards Bay, returning via the same route, entering Johannesburg via M2 West, M1 North, Braamfontein off-ramp, Smit Street, Loveday Street to terminus in Leyds Street. Routes through towns and cities may be changed as directed by the Local Authorities. *Restriction:* Subject to the condition that no intermediate passengers may be conveyed between Newcastle and Richards Bay, both points inclusive. *Service 23: Johannesburg — Port Elizabeth:* Route between Johannesburg and Port Elizabeth via existing route to Colesberg, then via R57 to Middelburg, R32 to Cradock, then R32 and R63 to Bedford, Adelaide, Port Beaufort R67, Grahamstown and N2 to Port Elizabeth, returning via the same route. *Alternative route:* Between Johannesburg and Port Elizabeth via existing route to Colesberg, then via R57 to Middelburg, R32 to Cradock, then R32 and R63 to Bedford, R350 to Grahamstown and N2 to Port Elizabeth, returning via same route. *Restriction:* No passengers may be picked up or set down between Grahamstown and Port Elizabeth, both points inclusive. *Service 24: Johannesburg — East London:* Route: Between Johannesburg and East London via existing route to Queenstown, then via R67 to Fort Beaufort and Grahamstown, then N2 via King William's Town to East London, returning via the same route. *Restriction:* No passengers may be picked up or set down between Grahamstown and East London, both points inclusive. *Service 25: Johannesburg — Wild Coast Sun.* Route forward: Johannesburg, Leyds Street, Frederick Street, Simmonds Street, Village Road, M2 and N3 to Durban via Harrismith, and when required also Heidelberg, Villiers, Warden, Harrismith, Ladysmith, Estcourt, Mooi River, Pietermaritzburg, Durban. From Durban via N2 to Amanzimtoti, Scottburgh, Hibberdene, Port Shepstone, then on R61 via St Michaels on Sea, Uvongo, Margate, Ramsgate, Southbroom and Port Edward to Wild Coast Sun Hotel. Route return: Return to Durban from Wild Coast Sun Hotel as per forward route, then N3, then as forward route in reverse to M2, then Rissik Street, Wolmarans Street, Loveday Street, Leyds Street (Johannesburg). *Note:* Routes through towns as directed by the Local Municipal Authority. *Alternative route:* As alternative forward route in reverse. The conveyance authorised herein shall be subject to the following condition: *Restriction:* No local passengers to be conveyed within the Municipal areas of the towns along the route. *Service 26: Johannesburg — Empangeni — Durban:* Route: (i) Johannesburg, Leyds Street, Harrison Street, Marshall Street, John Page Drive, Jules Street, Stanhope Street, R29, Johann Rissik Road, Germiston, M46, Boksburg, M46, Commissioner Street, M43, R29, Benoni, M45, Brakpan, M45, R554, R51, Springs, R29, Devon, Leandra, Kinross, Evander, Secunda, Trichardt, Bethal, Ermelo, Piet Retief, then R33 to Vryheid, R34, Melmouth, Nkwalini, R34 Empangeni, N2/M4, Melmouth, Nkwalini, R34 Empangeni, N2/M4 via Gingindlovu, Stanger, Ballito, Umhlanga Rocks to Durban, returning via same route. (ii) Johannesburg, Leyds Street, Harrison Street, Market Street, R24, R22, Boksburg off-ramp, R21, Boksburg, M36, Commissioner Street, M43, R29, Benoni, M45, Brakpan, M45, R554, R51, Springs, R29, Devon, Leandra, Kinross, Evander, Secunda, Trichardt, Bethal, Ermelo, Piet Retief, then R33 to Vryheid, R34, Melmouth, Nkwalini, R34 Empangeni, N2/M4 via Gingindlovu, Stanger, Ballito, Umhlanga Rocks to Durban. Returning via same route. (iii) Johannesburg, Leyds Street, Harrison Street, Marshall Street, End Street, Heidelberg Road, M46, R77, N17, Boksburg off-ramp, R21, Boksburg, M46, Commissioner Street, M43, R29, Benoni, M45, Brakpan, M45, R554, R51, Springs, R29, Devon, Leandra, Kinross, Evander, Secunda, Trichardt, Bethal, Ermelo, Piet Retief, then R33 to Vryheid, R34, Melmouth, Nkwalini, R34 Empangeni, N2/M4 via Gingindlovu, Stanger, Ballito, Umhlanga Rocks to Durban. Returning via same route. *Time table:* As and when required. *Tariff:* By agreement. *Service 27: Cape Town — East London:* Route: Between Cape Town and East London via N2 to Caledon, Swellendam, Riversdale, Mossel Bay, George, Knysna, Port Elizabeth, Grahamstown and King William's Town to East London, returning via the same route. *Alternative route:* Between Cape Town and Port Elizabeth via N1 to Worcester then via R15 to Robertson, Ashton and Swellendam, then via existing route to Port Elizabeth on the N2, returning via same route. *Time table:* As and when required. *Tariff:* By agreement. *Service 28: Johannesburg — White River:* Route: Between Johannesburg and White River along existing route to Nelspruit, namely M1 North, N1 to Pretoria, N4 to Witbank, Middelburg and Nelspruit, and then to White River via Route R40, returning via same route. *Time table:* As and when required. *Tariff:* By agreement. *Note:* 1. On both routes no intermediate passengers may be conveyed within any Municipality. 2. No intermediate passengers may be conveyed between Nelspruit and White River, both points inclusive. *Special Services 29:* 1. Passengers for religious sport and educational purposes within a radius of 160 (one hundred and sixty) kilometres from the Randfontein General Post Office, with the provision that the journey be commenced within 24 (twenty four) hours after completion of the forward journey. 2. Passengers for religious, sport and educational purposes within a radius of 160 (one hundred and sixty) kilometres from the Carletonville General Post Office, with the provision that the journey be commenced within 25 (twenty four) hours after completion of the forward journey. 3. Organised parties or persons and their personal effects, jointly attending a religious gathering, funeral or tribal function, or to jointly take part in a picnic, concert, dance competition, or game or other form of amusement or to jointly attend a camp, or other gathering within the Magisterial districts of Alberton, Balfour, Benoni, Boksburg, Brakpan, Delmas, Germiston, Heidelberg (Tvl), Johannesburg, Krugersdorp, Nigel, Oberholzer, Pretoria, Randfontein, Roodepoort, Springs, Vanderbijlpark and Vereeniging and those portions of the Magisterial districts of Heilbron, Sasolburg and Parys within a radius of twenty miles from Vereeniging Main Post Office as well as between points within the aforementioned areas and points within the Municipal area of Fochville, subject to the provision that: (a) All passengers (except in cases of illness and similar occurrences) will be returned to the same point of commencement of such trips. (b) No passengers will be picked up en route for conveyance to the point of departure or any other intermediate point. 4. Pupils or students from any educational institution on organised educational journeys with supervising staff from Johannesburg to places of educational interest in Natal to the Natal Border via



the National Road N3, N16 and N5, returning via same route. 5. Persons and their personal luggage undertaking a specific tour for educational purposes, religious gatherings or taking part in picnics, concerts, competitions, games or other forms of amusement from points within the Magisterial districts or Municipal areas of Johannesburg, Krugersdorp, Randfontein, Westonaria, Oberholzer, Fochville and Vereeniging to points within the Republic of South Africa and return. 6. Groups of persons and their personal effects by means of a motor vehicle which has been chartered for a group of persons travelling together on organised tours commencing from points within the Municipal area of Krugersdorp, Westonaria, Carletonville and Fochville to points of interest within the Republic of South Africa and return. The authority defined above shall be subject to the following conditions: (1) Once the vehicle has been chartered for a specific tour, the holder of this public permit shall not be allowed to sell vacant seats on the vehicle to any person for that tour. (2) Apart from the conveyance authorised in this public permit, the holder thereof shall not make known generally whether by means of notice published in a newspaper or in any other manner his intention to undertake a particular journey over any particular route. (3) All persons shall be returned to that point of commencement of the tour. This restriction shall not apply to a person conveyed on a journey on which he will use another form of conveyance. The name of such person and the point of his embarkation shall be reflected in the manifest referred to in condition 6 hereunder. (a) Name and address of public permit holder. (b) Number of public permit. (c) Registration number of vehicle. (d) Date and time of commencement and expected date of completion of journey. (e) Points between which journey is to be undertaken. (f) Name and address of charterer. (g) Signature of holder of public permit or person authorised to sign on his behalf. (h) Carrying capacity of vehicle. (4) The vehicle and the original of such entry shall be posted within 24 hours after commencement of the journey to the Secretary for Transport, Private Bag X193, Pretoria. The office copy of the entry shall be kept by the holder and held available for inspection by an authorised officer. (5) If no persons were conveyed over a period of 30 (thirty) days or if conveyance of persons took place only within a radius of 160 kilometres a nil return for the period must be submitted. (6) Not more than one vehicle shall be used at any one time from the areas mentioned above. The conditions contained herein shall be subject to review at any time. *Authority on all routes:* 1. Co-ordination if necessary of any routes having a portion of a common route or terminus. 2. Save for restrictions imposed, to operate services on any authorised route to and from intermediate points at times when necessary and as approved by the Local Authorities. 3. Deviation from authorised routes when forced to do so by any fortuitous and temporary blockage or obstruction on the said route preventing the use thereon or any portion thereof, of the vehicle to which this permit relates, or by the existence on that route or that portion thereof, of conditions which would render such use dangerous to the vehicle or to any passengers being conveyed therein or to operate over any other route as proposed by the Local Municipal Authority from time to time. 4. Interchangeability of all vehicles over approved routes, time tables, tariffs and restrictions. 5. Time tables as and when required. *Children's Fares:* Applicable to all routes up to third birthday free of charge. Up to twelfth birthday half adult charge, fractions of a cent to count as one cent. 1. Where not otherwise specified fares to be "by agreement". 2. Express fares on all long distance routes not to exceed R5,00 more than the authorised fare. *Special authority:* 1. To charge less than the authorised fare at the discretion of Greyhound Coach Lines (Pty) Ltd. 2. To charge through fares on connecting services. *Additional authority: Alternative routes:* 1. Passengers and their personal effects, and food and drink for consumption by passengers: (i) Between Pretoria and Heidelberg in order to connect with existing intercity routes to and from Durban departing from terminus in Pretoria via the Fountains Circle and Route R21 to Johannesburg International Airport, then via R21 and N12 to the Tom Jones Street off-ramp, then via R29 and M45 to Route R554 and R51 to Springs, continuing on R51 to Nigel and then R42 to the N3 at Heidelberg, returning via same route. (ii) Between Johannesburg and Heidelberg in order to connect with existing intercity routes to and from Durban departing from terminus in Johannesburg via Route R24 to Johannesburg International Airport, then as per Route (i) above to the N3 at Heidelberg, returning via the same route. NB: Routes and stops in towns and cities en route as per agreement with the relevant Local Authorities. *Tariff:* By agreement. *Time table:* As and when required.
