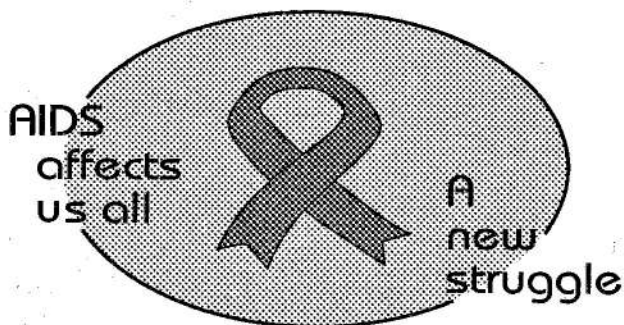

THE HEALTH AND WELFARE SECTOR EDUCATION AND TRAINING AUTHORITY (HWSETA) – INVITATION FOR NOMINATIONS

The Minister of Labour has in terms of Chapter 3 Section 9 of the Skills Development Act, 1998 (Act No 97 of 1998) established the Health and Welfare Sector Education and Training Authority (HWSETA) in order to develop a skilled workforce, appropriately educated, trained and empowered to render quality services to meet the health and welfare needs of all South Africans. In terms of clause 9(3)(a) of the HWSETA Constitution nominations are invited to establish the HWSETA Board.

 - Provincial Health (2 vacancies);
 - National Welfare (1 vacancy);
 - Provincial Welfare (2 vacancies);
- (b) Representing Organised employers (6 vacancies);
- (c) Representing Organised labour (10 vacancies);
- (d) Representing the statutory health councils (1 vacancy); and
- (e) Representing the levy-exempt sector (1 vacancy).
