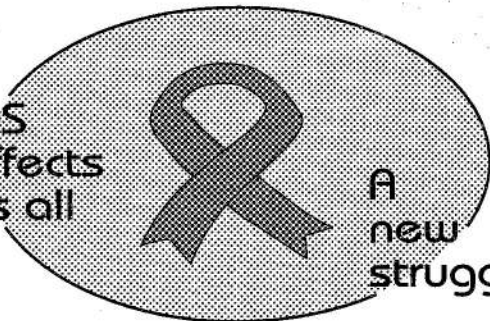

## INDEPENDENT COMMUNICATIONS AUTHORITY OF SOUTH AFRICA

### APPLICATION TO AMEND BROADCASTING LICENCE: SOUTH AFRICAN BROADCASTING CORPORATION (SABC)

The Independent Communications Authority of South Africa (ICASA) gives notice, in accordance with section 52 of the Independent Broadcasting Authority Act, Act No. 153 of 1993, that an application has been received in terms of section 52 for amendments to the South African Broadcasting Corporation's (SABC) licence. The amendment if granted, would result in the expansion of the SABC's television services including Bop TV, by way of self-help relay stations as set out in the Schedule below.

The self-help stations would provide a service to remote areas that are not covered by the national public service broadcasting network. In most cases, the self-help stations proposed are additions to existing sites in order to expand the number of services available in that area.
