

The Competition Commission hereby gives notice, in terms of Rule 26 (8)(a)(iii), that on 14 July 2000, Richway Retail Properties Ltd (Richway) on behalf of Whirlprops filed a notification with the Competition Commission in terms of section 13 of the Competition Act, No 89 of 1998. The aforesaid notification is in respect of the proposed acquisition of Walmer Park Shopping Centre (Walmer Park), which is owned and controlled by Gutsche Family Investments (Pty) Ltd (Gutsche).

Richway is involved in the business of developing, leasing and investing in retail properties while Gutsche is involved leasing and investing in office and retail properties. On implementation of the proposed transaction, Walmer Park Shopping Centre will be wholly owned and controlled by Richway.

The Competition Commission is evaluating and assessing the proposed transaction.
