

### NOTICE 100 OF 2000

#### STOCK EXCHANGES CONTROL ACT, 1985

#### AMENDMENT OF THE RULES OF THE JSE SECURITIES EXCHANGE SOUTH AFRICA

1. In terms of section 12 (6) of the Stock Exchanges Control Act, 1985 (Act No. 1 of 1985), it is hereby notified that the JSE Securities Exchange South Africa has applied to the Registrar of Stock Exchanges for the approval to make amendments to its rules, as set forth in the Schedule hereto.
2. In terms of section 12 (7) of the said Act all interested persons (other than members of the Securities Exchange) who have any objections to the proposed amendments are hereby called upon to lodge their objections with the Registrar of Stock Exchanges, PO Box 35655, Menlo Park, 0102, within a period of 30 days from the date of publication of this notice.

#### AMENDMENTS OF THE RULES OF THE JSE SECURITIES EXCHANGE SOUTH AFRICA

##### 1. PROPOSED AMENDMENTS TO SECTION 5 – TRANSACTIONS, TRADING PROCEDURES AND DISPUTES

###### **5.95 Delivery of Securities between members and other persons**

- 5.95.1 Where securities and other items are not subject to settlement through a settlement system, such deliveries shall [may] take place on any trading day from 07h30 to 14h00 [08h30 on any trading day to 15h00 on the same trading day] and shall be accepted by the recipient.
- 5.95.2 This rule shall be binding in respect of deliveries between members and in respect of deliveries between a member[s] and any other person[s] who enters into transactions on the JSE including an agent acting on behalf of such a person.

###### **5.96 Notice of intention to deliver securities**

- 5.96.1 If a member buys securities on behalf of a person and such person including an agent acting on behalf of such a person is required in terms of Section 22(1)(b) of the Act to pay to the member the purchase price in cash against offer of these securities, the member shall on the day of receipt of the securities and by no later than 13h30 give prior notice to such person of the intended delivery on that day.
- 5.96.2 If a member sells securities on behalf of a person including an agent acting on behalf of such a person who is not a member and the member is required to pay such person against offer of these securities, such person shall on the day of delivery of the securities and by no later than 13h30 give prior notice to the member of the intended delivery on that day.

5.95.1 Waar sekuriteite en ander items nie onderworpe is aan vereffening deur 'n vereffeningstelsel nie, moet [mag] sodanige lewerings plaasvind op enige verhandelingsdag vanaf 07h30 tot 14h00 [08h30 op enige verhandelingsdag tot 15h00 op dieselfde verhandelingsdag] en moet die ontvanger hierdie lewering aanvaar.

5.95.2 Hierdie reël is bindend en geld vir lewerings tussen lede en met betrekking tot lewerings tussen 'n lid [lede] en enige ander persoon [persone] wat transaksies op die JSE aangaan insluitend 'n agent wat namens so 'n persoon handel.

**5.96 Kennisgewing van voorneme om sekuriteite te lever**

5.96.1 Indien 'n lid sekuriteite namens 'n ander persoon aankoop, insluitend 'n agent wat optree namens so 'n persoon, word daar ingevolge artikel 22(1)(b) van die Wet, van so 'n persoon vereis om die aankoopprys in kontant teen die aanbieding van sekuriteite aan die lid te betaal. Die lid moet op die dag van ontvangs van die sekuriteite en teen nie later as 13h30 vooraf kennisgewing aan so 'n persoon gee van die voorgenome lewering op daardie dag.

5.96.2 Indien 'n lid sekuriteite namens 'n ander persoon verkoop, insluitend 'n agent wat namens so 'n persoon optree en wat nie 'n lid is nie, en die lid word vereis om so 'n persoon te betaal teen 'n aanbod van sekuriteite, moet so 'n persoon op die dag van lewering van die sekuriteite en teen nie later as 13h30 vooraf kennisgewing aan die lid gee van die voorgenome lewering op daardie dag.
