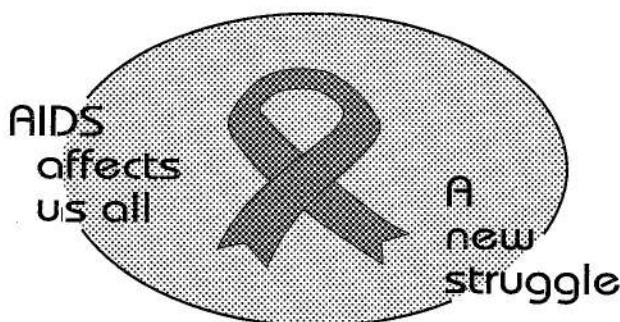

UNEMPLOYMENT INSURANCE ACT, 1966

INCREASE OF THE MAXIMUM RATE OF EARNINGS BY VIRTUE OF WHICH A PERSON QUALIFIES AS A CONTRIBUTOR TO THE UNEMPLOYMENT INSURANCE FUND

Under section 2(2)(d) of the Unemployment Insurance Act, 1966 (Act No. 30 of 1966), I, **MEMBATHISI MPHUMZI SHEPHERD MDLADLANA**, Minister of Labour hereby amend the rate of earnings referred to in Government Notice No. 20500 of 15 October 1999, from *ninety three thousand two hundred and eighty eight rand* (R93 288) per annum to *ninety seven thousand one hundred and eighty eight rand* (R97 188) per annum with effect from 1 January 2001.
