#### **REVIEW OF THE SUGAR ACT, 1978**

It is hereby made known that Department of Trade and Industry has decided to review the Sugar Act, 1978. The revision will be aimed at fostering a competitive environment that will contribute to the optimal development of the industry, within the accepted framework of the Strategy for the Sugar Sector in SACU and SADC context.

The South African Sugar Industry, as a major producer of sugar for the export market, operates in an environment where global production and supply patterns are severely affected by producer and export support measures and preferential trade arrangements. The effect of these distortions on the domestic industry is recognized in the **Strategy for the optimal development of the South African Sugar Industry within SACU and SADC context** and for the basis for intervention in the following areas of domestic sugar production and supply—

Customs tariff protection for the domestic industry against imports at disruptively low prices. A new dollar-based tariff regime for the industry was implemented at the end of September 2000. This revised system will no longer provide for tariff adjustments on basis of increases in the domestic sugar price. The domestic pricing mechanism that formed the basis for the previous system has also been discontinued;

support for initiatives aimed at the optimal development of the SADC sugar industry. A SADC sugar arrangement aimed at supporting joint development initiatives in the regional sugar industry has been negotiated within the SADC Trade Protocol and implemented on 1 September 2000. This agreement provides preferential access for non-SACU SADC sugar producers to the SACU market, as well as cooperation in some areas of common interest;

**export marketing arrangements.** Roughly half of the South African industry's sugar production is annually exported to the world market, where prices are determined on basis of policy-induced rather than market-driven production. The DTI supports the single channel export marketing of sugar, primarily due to the distorted nature of the international sugar trade—but also due to the importance of sugar exports by South Africa and by other members of SADC;

equitable sharing of industry proceeds between cane growers, millers and refiners. Due to the interdependence imposed through the dynamics of sugar production and marketing between growers, millers and refiners, the need for a structured arrangement regarding proceeds sharing between the parties is recognized.

The review of the Act will primarily concentrate on the last two elements of intervention as currently provided for in the Act, ie Equality of treatment of growers, millers and refiners (provision for proceeds sharing between growers and millers) and Regulations and control of production, marketing and exportation of sugar, as well as provisions for implementation of these elements.

The objective of the review will be to establish a positive legal position with regard to intervention of this sector, catering only for approved elements for government intervention rather than supporting an "enabling" position that sanctions regulatory intervention by the industry itself.

In terms of regulation 3 (b) (i) of the Regulation publish in Notice No. R. 1352 in *Government Gazette* No. 20606 dated 12 November 1999, a person using water as contemplated in section 21 of the National Water Act, 1998 (Act No. 36 of 1998), must submit the necessary forms to the responsible authority to register that use when requested to do so by means of a notice published in the *Government Gazette*.

I, Johannes Malherbe van Aswegen, in my capacity as Regional Director: Mpumalanga, of the Department of Water Affairs and Forestry, under delegated powers of the Minister of Water Affairs and Forestry, who is the responsible authority for the Olifants Water Management Area, hereby request that all persons using water as set out in this Notice must submit the necessary information on the appropriate forms to register that water use at the address and on or before the date as set out in this Notice.

#### Interpretation

- 1. In this Notice, unless the context shows that another meaning is intended, any expression to which a meaning has been assigned in the National Water Act, 1998 (Act No. 36 of 1998) (for example aquifer, water course and water resource) shall have that meaning, and—
- (i) "Olifants Water Management Area" means the Olifants Water Management Area as set out in Government Notice
  No. 1160 in Government Gazette No. 20491 dated 1 October 1998;
- (ii) "the Act" means the National Water Act, 1998 (Act No. 36 of 1998); and
  - (iii) "water use" means-
    - (a) taking water from a water resource as contemplated in section 21 (a) of the Act;
    - (b) storing water as contemplated in section 21 (b) of the Act;
    - (c) impeding or diverting the flow of water in a watercourse as contemplated in section 21 (c) of the Act;
    - (d) engaging in the use of land for afforestation which has been or is being established for commercial purposes, which is known as a stream flow reduction activity as contemplated in section 21 (d) of the Act;
    - (e) engaging in-
      - (i) irrigation of any land with waste or water containing waste generated through any industrial activity or by a waterwork;
    - (ii) an activity aimed at the modification of atmospheric precipitation;
    - (iii) a power generation activity which alters the flow regime of a water resource;
    - (iv) intentional recharging of an aquifer with any waste or water containing waste,
      - which is known as a controlled activity as contemplated in section 21 (e) of the Act;
      - (f) discharging waste or water containing waste into a water resource through a pipe, canal, sewer or other conduit as contemplated in section 21 (f) of the Act;
      - (g) disposing of waste in a manner which may detrimentally impact on a water resource as contemplated in section 21 (g) of the Act;
      - (h) disposing in any manner of water which contains waste from, or which as been heated in, any industrial or power generation process as contemplated in section 21 (h) of the Act;
      - altering the bed, banks, course or characteristics of a watercourse as contemplated in section 21 (i) of the Act;
      - (j) removing, discharging or disposing of water found underground if it is necessary for the efficient continuation of an activity or for the safety of people as contemplated in section 21 (j) of the Act; and
      - (k) using water for recreational purposes as contemplated in section 21 (k) of the Act.

#### Area of applicability

2. This Notice is only applicable to water uses in the Olifants Water Management Area.

#### Water uses that should be registered

- 3. Subject to the provisions of item 5 and 6, all water uses in the Olifants Water Management Area must be registered in terms of this Notice, except a water use that—
  - (a) is permissible under Schedule 1 of the Act;
  - (b) is permissible in terms of a general authorisation issued under section 39 of the Act and it is in terms of the provisions of that general authorisation required to be registered with the appropriate responsible authority, provided that it is so registered;
  - (c) is authorised by a licence under the Act and it is in terms of the provisions of the licence required to be registered with the appropriate responsible authority, provided that it is so registered;
  - (d) has been dispensed with a licence requirement under section 22 (3) of the Act and it is in terms of the provisions of the dispensation required to be registered with the appropriated responsible authority, provide that is so registered.

#### Exclusions

4. The following are excluded from registering, as they are not water uses:

An activity of a person due to a water use with a waterwork belonging to another person (the water use of the other person must be registered and not the activity of the person), provided that if the first mentioned person also uses water (a water use) other than the activity, then that water use must also be registered. This could be the following but are not limited to—

- (a) irrigation, household usage and stock watering by members of a water user association with water taken from a water resource and supplied with a waterwork belonging to that association while some of the members also take water with privately owned waterworks from a water resource for irrigation, in which case the water user association must submit the necessary forms for registering the taking of water from a water resource for the irrigation, household and stock watering by the members of the association while the members concerned must also submit the necessary forms for registering the taking of water for irrigation with the privately owned waterworks;
- (b) using of water for any purpose including drinking, bathing, gardening and manufacturing, with water taken and supplied with a waterwork belonging to a water services provider such as a water board or a local authority; in which case the water services provider must submit the necessary forms for registering the taking of water from a water resource;
- (c) irrigation and household usage with water supplied with canals and pipelines from a government waterwork, while some of the irrigators also take water with privately owned waterworks from a water resource for irrigation, in which case the Department of Water Affairs and Forestry must submit the necessary forms for registering the taking of water from a water resource for the irrigation and household while the irrigators concerned must submit the necessary forms for registering the taking of water for irrigation with the privately owned waterworks.

#### Taking water from a water resource

5. The extent of the water use, taking water from a water resource, as contemplated in section 21 (a) of the Act that should be registered in terms of this Notice, is as follows:

Any taking of water if-

- (a) more than 50 cubic metres of water on any given day is taken on a separately registered property or parcel of land from a water resource, excluding an aquifer; or
- (b) more than 10 cubic metres of water on any given day is taken on a separately registered property or parcel of land from an aquifer.

#### Storing of water

6. The extent of the water use, storing of water, as contemplated in section 21 (b) of the Act that should be registered in terms of this Notice, is as follows:

Any storing of water of-

- (a) the water is stored in a water course;
- (b) more than 10 000 cubic metres of water is stored on a separately registered property or parcel of land outside a water course.

In Report No. 3679 the Board recommended, among other things, that the duties on certain fabric tariff subheadings be increased from 20% to 22%, which is equal to the end-rate of duty on fabric at the end of the phase-down of textile duties on 1 September 2000. The intention was to achieve uniformity in the rate of duty. ## PUBLICATION OF A DECISION IN TERMS OF SECTION 11(7) OF THE PAN SOUTH AFRICAN LANGUAGE BOARD ACT, 1995 (ACT NO. 59 OF 1995)

- WHEREAS the Board received a complaint from Messrs. Levi Lebea and Johannes Masemola, who represent concerned parents interested in the reinstitution of Sepedi and isiNdebele as languages of instruction in schools in the Majaneng Circuit, Temba District, to the effect that –
  - (a) the establishment of the former homelands led to Sepedi and isiNdebele being phased out as languages of instruction in Majaneng, whereas Majaneng is the place where the Royal homestead of the Southern Ndebele people is situated; and
  - (b) Setswana is now the only medium of instruction in schools attended by children who speak various different languages, including Sepedi and isiNdebele;
- 2. AND WHEREAS the Board investigated the complaint in terms of section 11(4) of the Pan South African Language Board Act, 1995 and found -
  - (a) in respect of the complainants -
    - (i) that they conducted their own survey in 18 schools in the District, which survey reflects the number of learners whose first language is isiZulu & isiNdebele combined, and the number of learners whose first language is Sepedi; and
    - (ii) that they tried to engage Mr. Matsei, the District Manager of Education: Majaneng District, to launch a pilot project toward the realisation of their objective, without any success;
    - (iii) that they allegedly applied to the Department of Education, North West Province, to adopt single medium instruction (in isiNdebele) in a school where parents could enrol their children; and
  - (b) in respect of the Department –

- that Mr. Matsei, the District Manager: Education, gave certain undertakings to the complainants but ultimately did not have the support of the Director-General and the MEC to commit the Department to a pilot project;
- (ii) that it conducted its own survey in 13 of the schools identified by the complainants, the results of which conflict with the results of a survey undertaken by the complainants; and
- (c) in respect of the language policy of the Department of Education, North West Province
  - (i) that the National Education Policy Act, 1996 (Act No. 27 of 1996) recognises the right of every learner to be instructed in the language of his or her choice where reasonably practicable;
  - (ii) that the South African Schools Act, 1996 (Act No. 84 of 1996) makes provision that the governing body of a public school may determine the language policy of that school;
  - (iii) that the North West Schools Education Act, 1998 (Act No. 3 of 1998) makes provision that the governing body of the school determines language policy subject to the provincial policy as determined by the MEC;
  - (iv) that the criterion set by the provincial policy for the introduction of a language as a language of instruction is that a minimum number of 30 learners is required to introduce parallel medium instruction, considering factors such as
    - (aa) provisioning of posts;
    - (bb) accommodation;
    - (cc) the ability of teachers to teach the language concerned; and
    - (dd) the cost involved to introduce such a language.

### 3. NOW THEREFORE, THE BOARD HEREBY FINDS –

- that the request of the language communities concerned is a legitimate request which must be considered in the context of the North West Schools Education Act, 1998;
- (b) that the Department declined the request on the basis of a general numbers and- resources argument only;
- (c) that it has not been proven conclusively that the number requirement for parallel medium instruction has been met in the case of isiNdebele, but that the requirement may be met if a single medium institution is established for isiNdebele-speaking children;

- (d) that factors such as provisioning of posts, accommodation, the ability of teachers to teach the language concerned and the cost involved to introduce isiNdebele have not received sufficient consideration;
- (e) that is has been proven conclusively that the requirements for parallel medium instruction have been met in the case of Sepedi; and
- (f) that factors such as provisioning of posts, accommodation, the ability of teachers to teach the language concerned and the cost involved to introduce Sepedi have not received sufficient consideration.
  - 4. THE BOARD HEREBY INFORMS the complainants, the National Department of Education and the Provincial Department of Education
    - (a) that the Board will do a survey concerning the number of isiNdebele-speaking students in the District; and
- (b) that the Board reserves the right to make a finding on this matter.
- 5. THE BOARD HEREBY INSTRUCTS the MEC of North West Province to consider the request for a pilot project in earnest and with reference to all the criteria referred to in the provincial policy.
  - 6. THE BOARD HEREBY INSTRUCTS the Department of Education of North West Province to publish the decision of the MEC regarding the request of the complainants, together with the reasons for the decision, in the Government Gazette and the Provincial Gazette.
