LOCAL GOVERNMENT: MUNICIPAL SYSTEMS REGULATIONS, 2001

Under section 120 of the Local Government: Municipal Systems Act, 2000 (Act No. 32 of 2000), I, Fholisani Sydney Mufamadi, after consultation with organised local government representing local government nationally, hereby make the regulations in the Schedule.

SCHEDULE

Definitions

1. In these regulations a word or phrase to which a meaning has been assigned in the Local Government: Municipal Systems Act, 2000 (Act No. 32 of 2000), has that meaning and, unless the context otherwise indicates-

"the Act" means the Local Government: Municipal Systems Act, 2000;

Prescribed periods

2. The prescribed period referred to in-

- (a) section 25(1) of the Act is 14 months and 23 days (i.e. by 28 February 2002);
- (b) section 25(3)(a) of the Act is ten months;
- (c) section 27(1) of the Act is eight months and 26 days (i.e. by 1 September 2001);
- and
- (d) section 28(1) of the Act is nine months and 26 days (i.e. by 1 October 2001).

Prescribed amount of gifts received by councillor

3. (1) Gifts received by a councillor must be declared in terms of item 7(1) of Schedule 1 to the Act where-

- (a) the value of a gift exceeds R350; and
- (b) the value of gifts received from a single source in any calendar year exceeds R350.

(2) A declaration of gifts received by a councillor must-

- (a) contain a description of such gift or gifts, as the case may be; and
- (b) indicate the value and source of such gift or gifts, as the case may be.

Short title

4. These regulations are called the Local Government: Municipal Systems Regulations, 2001, and take effect on the date of publication hereof.

“die Wet” die Wet op Plaaslike Regering: Munisipale Stelsels, 2000;

Voorgeskrewe tydperke

2. Die voorgeskrewe tydperk bedoel in-
- (a) artikel 25(1) van die Wet is 14 maande en 23 dae (d.w.s teen 28 Februarie 2002);
 - (b) artikel 25(3)(a) van die Wet is 10 maande;
 - (c) artikel 27(1) van die Wet is agt maande en 26 dae (d.w.s teen 1 September 2001);
en
 - (d) artikel 28(1) van die Wet is nege maande en 26 dae (d.w.s teen 1 Oktober 2001).

Voorgeskrewe bedrag van geskenke deur raadslid ontvang

3. (1) Geskenke wat deur 'n raadslid ontvang is, moet ingevolge item 7(1) van Bylae 1 by die Wet verklaar word waar-

- (a) die waarde van 'n geskenk R350 oorskry; en
- (b) die waarde van geskenke wat van 'n enkele bron in enige kalender jaar ontvang is, R350 oorskry.

(2) 'n Verklaring van geskenke wat deur 'n raadslid ontvang is, moet-

- (a) 'n beskrywing van sodanige geskenk of geskenke, na gelang van die geval, bevat; en
- (b) die waarde en bron van sodanige geskenk of geskenke, na gelang van die geval, aandui.

Kort titel

4. Hierdie regulasies heet die Plaaslike Regering: Munisipale Stelsels Regulasies, 2001, en tree in werking op die datum van publikasie hiervan.
