### BOARD NOTICE 54 OF 2001

FINANCIAL MARKETS CONTROL ACT, 1989

#### AMENDMENT OF RULES OF THE BOND EXCHANGE OF SOUTH AFRICA

1. In terms of section 17(3) of the Financial Markets Control Act, 1989 (Act No. 55 of 1989), it is hereby notified that the Bond Exchange has applied to the Registrar of Financial Markets for approval of amendments to its Rules, as set forth in the Schedule hereto.
2. In terms of section 17(3) of the said Act all interested persons (other than members of the Bond Exchange of South Africa) who have any objections to the proposed amendments and additions are hereby called upon to lodge their objections with the Registrar of Financial Markets, PO Box 35655, Menlo Park, 0102, within a period of 30 days from the date of publication of this notice.

#### PROPOSED AMENDMENT OF BOND EXCHANGE RULES (SECTION 7 - SETTLEMENT)

##### Amendment of Rule 7.1.3

- 7.1.3 settlement agents shall be obliged to commit to settlement by the time specified by the Executive Committee from time to time -

7.1.3.1 in respect of a nett settlement run, to every account that a settlement agent is satisfied is funded with the required scrip or cash, as the case may be, and, where an account is not fully funded, to all those trades for which the funding is sufficient, and

7.1.3.2 for every trade that is not satisfactorily funded, to identify and move such trade to another settlement run on that day.

##### Amendment of Rule 7.2.4

- 7.2.4 [the settlement shall be a nett] settlement [and] shall take place on every business day at the specified settlement times as determined by the executive committee from time to time.

##### Amendment of Rule 7.3

- 7.3 Where a settlement agent declines to settle the [nett] settlement position of a member or a client, the affected member and the appointed settlement agent shall forthwith advise the chief executive officer, in writing, of that fact: Provided that such a potential settlement default shall be managed by the chief executive officer in accordance with rule 7.7. [and a failure to resolve the problem within the period determined by the executive committee from time to time shall be deemed to constitute an event of default.]

**Amendment of Rule 7.7****7.7 Rectifying settlement shortages**

- [7.7.1]** Where a member or client is short of scrip or fails to submit settlement instructions to the appointed settlement agent, the settlement agent and the affected member shall notify the chief executive officer, in writing, of this fact [by no later than 09:00 South African standard time on settlement day,] and shall provide all information as requested by the chief executive officer, who may, at his sole discretion, instruct any member to enter trades, including scrip lending and substitution, or do or not do any other thing reasonably necessary or desirable to rectify the settlement shortage in question.
- [7.7.2]** A member shall request permission, in writing, from the chief executive officer to enter own account trades or trades on behalf of the client in order to rectify the short position resulting from the non-performance of the member or client in terms of rule 7.7.1.
- 7.7.3** The chief executive officer may, at his sole discretion, open the system reporting window for those members only who need to rectify their specific short position by means of concluding trades, including but not limited to, buy and sell back trades, same day trades, equal and opposite trades or securities lending transactions.]

1. (ARTIKEL 7 – VEREFFENING)****Wysiging van Reël 7.1.3**

- 7.1.3 vereffeningsagente is verplig om hulle te verbind tot die vereffening op die tyd soos gespesifieer deur die Uitvoerende Komitee van tyd tot tyd –
- 7.1.3.1 met betrekking tot 'n netto vereffeningslopie, in elke rekening dat 'n vereffeningsagent tevreden is met die fondse per die vereiste aandelebewys of kontant, na gelang van omstandighede, en waar 'n rekening nie ten volle befonds is nie, veral daardie transaksies ten opsigte waarvan die befondsing voldoende is, en
  - 7.1.3.2 vir elke transaksie wat nie voldoende befonds is nie, te identifiseer en om sodanige transaksie te skuif na 'n ander vereffeningslopie op daardie dag.

- 7.3 Waar 'n vereffeningsagent weier om die [netto] vereffeningsposisie van 'n lid of 'n kliënt te vereffen, moet die geaffekteerde lid en die aangestelde vereffeningsagent die Uitvoerende Hoofamptenaar onverwyld skriftelik in kennis stel van sodanige feit: op voorwaarde dat sodanige moontlike versuim tot vereffening in ooreenstemming met reel 7.7 deur die Uitvoerende Hoofamptenaar bestuur word **om die probleem op te los binne die periode**

**soos bepaal deur die Uitvoerende Komitee van tyd tot tyd sal beskou word as 'n geval van versuim].**

#### Wysiging van Reël 7.7

##### 7.7 Aanspreek van Vereffeningstekortkominge

- [7.7.1] Waar 'n lid of kliënt 'n tekort het van 'n aandelebewys of versuim om vereffeninginstruksies aan die aangestelde vereffningsagent te gee, moet die vereffningsagent en die betrokke lid die Uitvoerende Hoofbeampte skriftelik in kennis stel van sodanige feit [**nie later nie as 09:00 Suid-Afrikaanse standaard tyd op die vereffendingsdag**] en moet alle inligting beskikbaar stel soos aangevra deur die Uitvoerende Hoofbeampte, wat geheel na eie goeddunke, opdrag kan gee aan enige lid om transaksies aan te gaan, insluitende die uitleen van aandelebewyse en plaasvervanging, of om enige iets anders wat redelik noodsaklik of wenslik is te doen of nie te doen nie om die betrokke vereffeningstekortkoming te verbeter.
- [7.7.2] 'n Lid moet skriftelike toestemming van die Uitvoerende Hoofbeampte vra om eie rekening transaksies of transaksies namens 'n kliënt te doen om die kort posisie te herstel wat veroorsaak word deur die nie-nakoming van die lid of kliënt ingevolge reël 7.7.1.
- 7.7.3 Die Uitvoerende Hoofbeampte mag na eie goeddunke, die verslaggewing venster van die stelsel open vir daardie lede wie hulle spesifieke kort posisies moet wysig deur middel van die voltrekking van transaksies, insluitende maar nie beperk tot, koop- en verkoop keersy transaksies, dieselfde dag transaksies, gelyke en teenoorgestelde transaksies of effekte uitleen transaksies].
