NOTICE 1466 OF 2001

INDEPENDENT COMMUNICATIONS AUTHORITY OF SOUTH AFRICA

NOTICE OF DECISION TO PERMIT EXPERIMENTAL DIGITAL TERRESTRIAL TELEVISION (DTT) TRANSMISSION BY: ELECTRONIC MEDIA NETWORK LIMITED (M-NET), SENTECH (PTY) LTD (SENTECH) AND ORBICOM (PTY) LTD (ORBICOM)

1. The Independent Communications Authority of South Africa (the Authority) hereby gives notice, in accordance with the provisions of section 13 read with sections 2(k) and (p) of the Independent Broadcasting Authority Act, No. 153 of 1993 as amended, (the Act) that it has granted to M-Net, Sentech and Orbicom permission to conduct experimental Digital Terrestrial Television (DTT) transmissions.

BACKGROUND

2. M-Net applied for authorisation to conduct experimental DTT transmissions. The Authority's predecessor, the Independent Broadcasting Authority, had granted to Sentech on 15 April 1999, a temporary amendment to its signal distribution licence to conduct DTT test transmissions in the Gauteng area from the Brixton tower. The Authority granted Orbicom authorisation to conduct DTT test transmissions in the Gauteng area on 6 October 2000. Orbicom was permitted to conduct the tests between the period 9 October 2000 to 8 April 2001 from the sites situated at Sunninghill and Kyalami. Authorisation in respect of Helderkruijn was granted on 23 February 2001.

THE DECISION

3. The Authority has decided to grant the authorisation requested by M-Net. The temporary amendment to Sentech provided for it to be revoked, which option the Authority has now exercised. However, the Authority has also decided to issue an authorisation in its place and to amend the authorisation granted to Orbicom, in order to standardise such authorisations and to complement the provisions therein. The authorisations are for a period of one-year, from 14 May 2001 to 13 May 2002 (and would be renewable upon request) but would be succeeded by a DTT licensing dispensation in due course. The authorisation to M-Net will also be for a period of one year (renewable upon request), which period is the same as that determined for Orbicom and Sentech stated above.

4. The authorisation of channels to be carried on DTT test transmissions has been limited to television channels already licensed for analogue terrestrial transmission. The television channels authorised to date for this purpose are the following: BOP-TV, CSN, M-Net, SABC 1, SABC 2 and SABC 3. Both Orbicom and Sentech have been authorised to conduct DTT test transmission on one multiplex each according to specified technical parameters, frequencies and locations.
5. The tests, in respect of Orbicom, are to be conducted in accordance with the following specifications:

CONDITIONS OF AUTHORISATION

7. The authorisation to conduct the test transmissions are provided subject to the following conditions:
- 7.1 No guarantee is provided of protection against interference by other users of the frequency spectrum, such as analogue television transmission;
- 7.2 Interference must not be caused to other users;
- 7.3 No exclusive right is conveyed, even within the specified duration of its validity;
- 7.4 No other party, except for Sentech, Orbicom and M-Net, may be involved in the tests without prior notification to the Authority;
- 7.5 The Authority reserves the right to amend, suspend, or withdraw the authorisations as it sees fit;
- 7.6 The authorisations shall not be used by either M-Net, Sentech or Orbicom as an entitlement to be granted a licence in future;
- 7.7 The Authority reserves the right to revoke the authorisations should there be any interference to existing transmitters due to the tests;

- 7.8 A copy of the results must be forwarded to the Authority within a period of three months from the end of each authorisation period. The Authority may use the results of the test transmissions in its planning for DTT.
