ITEMS FOR INCLUSION AS ADDENDA TO THE NATIONAL POLICY ON THE CONDUCT OF THE SENIOR CERTIFICATE EXAMINATIONS

- I, Kader Asmal, Minister of Education, after consultation with the Council of Education Ministers, hereby determines national policy in terms of section 3 (4) (I) of the National Education Policy Act, 1996 (Act No. 27 of 1996), relating to curriculum frameworks, core syllabuses and education programmes, learning standards, examinations and the certification of qualifications, that.
 - (a) items be included as addenda to the National Policy on the Conduct of the Senior Certificate Examinations; and
 - (b) these addendum be published in the Government Gazette.

The items to be included as addenda to the National Policy on the Conduct of the Senior Certificate Examinations will read as follows:

- "1. "When candidates need to answer only a selected number of questions from those given in a question paper, the marker should mark only the required number of questions in the order in which they appear in the answer script and delete the remaining answers. An instruction to this effect should appear on the question paper to indicate to the candidate what marking procedure will be followed."
- "2. A period of ten minutes before the official commencement of the examination will be allowed for reading time over and above the reading of any other instructions that may be necessary."
- "3. All marks on mark sheets and any other official documents must be entered in ink. NO pencil marks will be allowed."



On 8 March 2000 the Board on Tariffs and Trade (the Board) recommended that definitive anti-dumping duties be imposed on inner tubes for tyres, classifiable under tariff subheadings 4013.10 and 4013.90.90, and that these anti-dumping duties be imposed retroactive to the date of the provisional payments, that is 19 November 1999. This recommendation was published in the Government Gazette Notice No.21209, on 19 May 2000 in the following amounts:

A request has since been received from Dunlop Pty Ltd for the removal of the antidumping duty on tubes, as they have terminated the production of tubes in the SACU. As there will no longer be any local manufacturer of tubes, Dunlop Pty Ltd requested the removal of the anti-dumping duties on tubes originating in Korea.

The Board therefore invited comments on the proposed withdrawal of the duty as mentioned above and published its intention in *Government Gazette* No. 22255 on 4 May 2001.

After considering comments from interested parties, the Board made a final determination, as contained in its Report No. 4126, to recommend that the duty be terminated, which was accepted by the Minister of Trade and Industry


