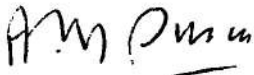

**DECLARATION OF AN EXISTING PROVINCIAL ROAD BETWEEN EMPANGENI
AND RICHARDS BAY AS A NATIONAL ROAD (TO BE KNOWN AS THE JOHN
ROSS HIGHWAY)**

By virtue of Section 40(1)(a) of the South African National Roads Agency Limited and National Roads Act, 1998 (Act No 7 of 1998), I hereby declare that the portion of existing road between Empangeni and Richards Bay, as more fully described in the annexure hereto, of which proclaimed Main Road 496, as proclaimed by Administrator's Notice 483 of 6 October 1983 forms part, shall be a National Road.

(National Route: Empangeni to Richards Bay known as the John Ross Highway)

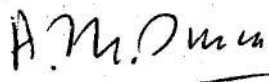
