ACT

To amend the National Parks Act, 1976, so as to bring the South African National Parks within the ambit of the definition of “association not for gain” contained in section 1 of the Value-Added Tax Act, 1991; and to provide for matters connected therewith.

BE IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

Amendment of section 18 of Act 57 of 1976, as amended by section 10 of Act 43 of 1986 and section 8 of Act 52 of 1992

1. Section 18 of the National Parks Act, 1976, is hereby amended by the insertion after subsection (2) of the following subsection:

“(2A) Upon the winding-up or liquidation of the board it shall donate or transfer its remaining assets, after the satisfaction of its liabilities, to some other society, association or organisation with objects similar to its own.”.

2. This Act is called the National Parks Amendment Act, 2001.

Tot wysiging van die Wet op Nasionale Parke, 1976, ten einde die Suid-Afrikaanse Nasionale Parke binne die trefwydte te bring van die woordskrywing van “vereniging sonder winsoogmerk” vervat in artikel 1 van die Wet op Belasting op Toegevoegde Waarde, 1991; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

DAAR WORD BEPAAL deur die Parlement van die Republiek van Suid-Afrika, soos volg:—

Wysiging van artikel 18 van Wet 57 van 1976, soos gewysig deur artikel 10 van Wet 43 van 1986 en artikel 8 van Wet 52 van 1992

- 5 **1.** Artikel 18 van die Wet op Nasionale Parke, 1976, word hierby gewysig deur die volgende subartikel na subartikel (2) in te voeg:

“(2A) By die ontbinding of likwidasie van die raad moet hy sy bates wat na voldoening van sy verpligtinge oorbly, gee of oormak aan ’n ander vereniging, genootskap of organisasie met oogmerke soortgelyk aan sy eie.”.
