The Independent Communications Authority of South Africa hereby gives notice, in accordance with the provisions of section 41(6) of the Independent Broadcasting Authority Act, No. 153 of 1993 (the Act) as amended, that an application has been received in terms of the provisions of section 44 of the Act for the renewal of the commercial television broadcasting licence of Electronic Media Network Limited (M-Net).

SCHEDULE

1. M-Net is licenced to broadcast 24h00 per day as a commercial national pay-television broadcast service to provide an entertainment service.
2. M-Net is licenced to provide two separate channels namely, the M-Net Channel and the Community Service Network Channel. M-Net also provides an unencoded signal on its M-Net Channel only during the period 17h00 and 19h00 each day.
3. M-Net's commercial national pay-television broadcast service is due to expire on 31 March 2002.
