INDEPENDENT COMMUNICATIONS AUTHORITY OF SOUTH AFRICA

APPLICATION TO AMEND BROADCASTING LICENCE: UMOYA COMMUNICATIONS (PROPRIETARY) LIMITED

The Independent Communications Authority of South Africa hereby gives notice in accordance with the provisions of section 52(2)(a) of the Independent Broadcasting Authority Act No. 153 of 1993, (the Act) as amended, that an application has been received in accordance with the provisions of section 52(1)(c) of the Act, for an amendment to the broadcasting licence of Umoya Communications (Pty) Ltd broadcasting as Radio Algoa.

The application if granted, would result in:

1. The closure/termination of the following transmitters, which are stated in Schedule B2 of the licence, conditions. The affected transmitters identified are:
 - 1.1 Hankey;
 - 1.2 Andrieskraal;
 - 1.3 Paul Sauer Dam;
 - 1.4 Patensie;
 - 1.5 Willowmore; and
 - 1.6 Uniondale.
2. The termination/closure of the BRFM transmitter split service as stated in clause 4 of Schedule C of the licence conditions.

The application, the relevant schedules and any written representations received pursuant thereto are open for inspection by interested parties during office hours of the Authority.

The effective date of the proposed amendments would, if granted, be the date on which the Authority's decision thereon would be published.
