**1. Schutte Family Association (H4/3/1/3927)**

*Arms:* Gules, between two lions rampant respectant, the raised forepaw of each holding a sheaf of three arrows, points to chief and in base a drawn bow fesswise and arrow palewise Or; a chief Argent.

*Motto:* ALTO PETERE

**2. Highveld Hunters and Game Conservation Association (H4/3/1/3966)**

*Badge:* A cartouche fesswise Argent, bordered Gules, charged with a lynx's face proper.

**3. Voortrekker Monument and Nature Reserve (H4/3/1/3976)**

*Badge:* The façade of the Voortrekker Monument, in umbra Sable.

**4. Clan Laing Society (H4/3/1/3985)**

*Arms:* Argent, three piles conjoined in point Sable, the central pile charged with a saltorel flory of the first; a chief Argent.

*Motto:* VIGILANDO MUNIO

**5. Ehlanzeni District Municipality (H4/3/2/687)**

*Arms:* On an Nguni oxhide shield Sable, in the dexter flank pied at random to base Argent, in chief a demi-bezant with eleven rays issuant to chief Or, therebeneath ten pairs of thongs fesswise in pale counterchanged. Behing the shield a spear and knobkierie erect proper.

*Supporters:* Two turtle doves proper.

*Special compartment:* One a mount Vert, two ears of wheat, the slips in saltire, Or.

*Motto:* SIMUNYE

**6. Moshwaneng Local Municipality (H4/3/2/692)**

*Arms:* On a traditional Tswana shieldform Or, a kudu head and neck couped affrontée proper, and in base a fess wavy Azure charged with another Argent, all within a bordure Vert. The shield ensigned of a rustic mural crown proper, charged with a bar Azure bearing another Argent.

*Motto:* AD BENEFICIUM OMNIUM

**7. Kgalagadi District Municipality (H4/3/2/693)**

*Arms:* Per fess Azure and Gules, a cross of chemical symbols for iron fitchy, Or, surmounted in base by a fountain. The shield ensigned with a mural crown Or, the battlements heightened with palisades Argent.

*Supporters:* Two kori bustards proper.

*Special compartment:* Sanddunes proper.

*Motto:* BY SERVING WE GOVERN

**8. Capricorn District Municipality (H4/3/2/705)**

*Arms:* Per fess, Vert and Or, two pickaxes in saltire, per fess Argent and Vert, surmounted in chief by a demi-sunflower issuant proper, conjoined in base to a demi-cogwheel Sable. The shield ensigned with a mural crown Or, the battlements heightened with palisades Argent.

*Supporters:* Two ground hornbills proper.

*Special compartment:* A compartment Vert, the upper edge heightened with a flattened mountain range.

*Motto:* RE ŠOMELA SETŠHABA

**9. City of Tshwane Metropolitan Police Service (H4/3/2/721/1)**

*Badge:* On an oval shield, the lower part pointed and the upper edge voided in the shape of half an oval fesswise; Argent, issuant from the respective lower dexter and sinister edges of the shield each, four piles conjoined in fess point Azure, surmounted by a faceted star of ten points Azure, charged with a hurt, fimbriated Or, thereupon an eagle's claw Or, armed Argent; in chief a martial eagle with wings displayed Or; over the piles and the lower points of the martial eagle's wings, an open wreath of leaves the stems in base in saltire Or.

**10. City of Tshwane Metropolitan Police Service (H4/3/2/721/1)**

*Flag:* A rectangular yellow flag, proportion 2:3, in the centre charged with a faceted ten pointed blue star, thereupon a yellow roundel charged with the head of a Black Eagle; issuant from the lower dexter and sinister sides respectively two blue piles conjoined to the central point behind the star; issuant from the dexter and sinister baseline respectively two blue piles also conjoined to the central point behind the star.

**1. Schutte Familiebond (H4/3/1/3927)**

*Wapen:* In rooi, tussen in die skildhoof twee toegewende klimmende leeus, in hul verhewe kloue elk 'n bundel van drie pyle, 'n regopgeplaaste pyl, en 'n gespande boog dwarsbalksgewys geplaas, alles goud; 'n silwer skildhoof.

*Wapenspreuk:* ALTO PETERE

**2. Hoëveld Jagters- en Wildbewaringsvereniging (H4/3/1/3966)**

*Wapen:* 'n Silwer ovaal dwarsbalksgewys en blou omsoom, daarop 'n aansiede rooikatkop van natuurlike kleur.

*Spesiale kompartement:* Op 'n groen grond, twee goue koringare, die stingels skuinskruislings.

*Wapenspreuk:* SIMUNYE

*Wapen:* Deursnede van blou en rooi, 'n goue spitsvoetige kruis bestaande uit chemiese simbole vir yster, in die skildvoet daaroorheen, 'n fontein. Die skild oortop met 'n goue muurkroon, aan die kantele verhoog met silwer palissades.

*Skildhouers:* Twee gompoue van natuurlike kleur.

*Spesiale kompartement:* Sandduine van natuurlike kleur.

*Wapenspreuk:* BY SERVING WE GOVERN

#### 8. Capricorn Distriksmunisipaliteit (H4/3/2705)

*Wapen:* Deursnede van groen en goud, twee skuisgekruiste pikke, deursnede van silwer en groen, daaroorheen, in die skildhoof 'n halwe uitkomende sonneblom van natuurlike kleur, en in die skildvoet 'n aanstotende halwe swart tandrat. 





**NOTICE OF FINAL TERMINATION OF AN INVESTIGATION INTO THE  
ALLEGED SUBSIDISED EXPORT OF POLYMERS OF VINYL CHLORIDE  
(PVC) BASED ROLL GOODS ORIGINATING IN/OR IMPORTED FROM INDIA**

The Board on Tariffs and Trade (the Board) gave public notice of its investigation into the alleged subsidised export of PVC roll goods originating in/or imported from India in *Government Gazette* No. 21483 dated 25 August 2000 (Notice No. 2939 of 2000).

On the basis of the information available the Board made a preliminary determination to recommend that the investigation be terminated.

The Board's Report No. 4139, explaining the preliminary determination, was forwarded to all interested parties.

No comments were received in respect of the preliminary report.

In the final determination it was found that PVC based roll goods were being exported at subsidised prices into the SACU market, that the SACU industry suffered material injury, and that there was a causal link between the dumping and the material injury experienced by the SACU industry. However, in the light of the magnitude of the anti-dumping duties imposed against India, it was concluded that no countervailing duties should be imposed on PVC based roll goods originating in/or imported from India.

The Board therefore made a final determination, as contained in its Report No. 4159, to recommend the termination of the investigation. The recommendation was accepted by the Minister of Trade and Industry (Minister).

The investigation has therefore been terminated.



**BOARD NOTICE 48 OF 2002**

The South African Council for the Property Valuers Profession, under section 37 of the Property Valuers Profession Act, 2000 (Act No. 47 of 2000), hereby makes the rules in the Schedule.

**SCHEDULE****Definitions**

1. In these rules any word or expression to which a meaning has been assigned in the Property Valuers Profession Act, 2000, shall bear that meaning and, unless the context otherwise indicates-
  - (i) "the Act" means the Property Valuers Profession Act, 2000 (Act No. 47 of 2000); and
  - (ii) "supervisor" means a professional person without restrictions who has been approved by the council to supervise, control and counter-sign the work in property valuation of a candidate.

**PART I****NOMINATION PROCEDURE**

Sections 3 and 4

**Invitation**

2. When the council invites nominations for the appointment of members in accordance with section 4(1) of the Act, it shall be done by notice in the *Gazette* and any newspaper the council considers necessary, but at least in a leading newspaper in each province.

**Format**

3. A nomination for appointment in terms of section 3(1)(a), (b) or (c) of the Act shall -
  - (a) be in writing;
  - (b) state the name of the person being nominated (hereinafter referred to as "the nominee");
  - (c) state whether the nomination is being made in respect of section 3(1)(a), (b) or (c) of the Act;
  - (d) in the case of a nominee registered in terms of section 20, read with sections 19 and 43 of the Act, state the category in which the nominee is registered, as well as the nominee's registration number;
  - (e) state -
    - (i) the name of the registered person, voluntary association, educational institution, department or other institution of the State, or member of the public, as the case may be, making the nomination (hereinafter referred to as "the nominator"); and
    - (ii) the nominator's postal, business, residential and e-mail addresses, as well as his or her telephone and facsimile numbers;
  - (f) be signed by the nominator;

- (g) be countersigned by the nominee to denote his or her acceptance of the nomination;
- (h) be accompanied by -
  - (i) a relevant but brief *curriculum vitae* of the nominee, also stating the nominee's postal, business, residential and e-mail addresses, as well as his or her telephone and facsimile numbers;
  - (ii) a declaration, signed by the nominee, to the effect that he or she is not disqualified from membership in terms of section 6(1) of the Act; and
- (i) be submitted by registered post to the Registrar, P O Box 114, MENLYN 0063, within 60 days from the date of the invitation or notice referred to in section 4(1) or (2) of the Act.

## PART II

### REGISTRAR: PERFORMANCE AGREEMENT

Section 8(2)

#### Performance Agreement

- 4. The performance agreement contemplated in section 8(2) of the Act shall be as set out in Annexure A.

## PART III

### PERIOD OF VALIDITY OF REGISTRATION

Section 11(b)

#### Validity of Registration

- 5. (1) A registration in terms of section 20(2) of the Act as a professional, a candidate or a person referred to in rule 6 shall be valid for a period of five years from the date of such a registration.
- (2) The period of validity of a registration referred to in subrule (1) shall be endorsed on all registration certificates issued in terms of the said section 20(2).
- (3) A registration in terms of the said section 20(2) effected between the effective date, being 31 August 2001, and the commencement date of this rule, shall, for the purposes of subrule (1) and rule 17, be deemed to have been effected on the date of commencement of this rule.
- (4) For the purposes of the register of registered persons referred to in section 11(c) of the Act and rule 17, a registered person must without delay notify the council in writing of any change of his or her postal, business and E-mail addresses, as well as his or her telephone, cell phone and facsimile numbers. (See rule 23, *infra*.)

**PART IV  
SPECIFIED CATEGORIES OF REGISTRATION**

**Specified Categories**

6. Subject to the provisions of paragraphs (a), (b) or (c) of section 19(1) of the Act, the council may, in terms of paragraph (d) of the said section 19(1), register a person in the following specified categories -
- (a) valuer assistant; or
  - (b) valuer technician;
  - (c) assessor; or
  - (d) appraiser.

**PART V  
APPLICATION FORM  
Section 20(1)**

**Application Form**

7. An application for registration in terms of the Act shall be made on the form approved by the council from time to time.

**PART VI  
EXAMINATIONS  
Section 20(2)**

**Prescribed Examination**

8. The examinations contemplated in section 20(2) of the Act are:
- (a) As an academic qualification -
    - (i) the National Diploma in Real Estate (Property Valuation);
    - (ii) the National Diploma in Property Valuation; or
    - (iii) the National Diploma in Valuation; and
  - (b) As a test of practical competence, proficiency and experience -
    - (i) the Council Examination for Professional Valuers;
    - (ii) The Council Examination for Professional Associated Valuers; or
    - (iii) The Council Examination for Specified Categories referred to in rule 6.

**Foreign Examination**

9. In addition to the information and documents referred to in respect of academic qualifications in the prescribed application form, an applicant wishing to be registered in a category referred to in section 19(1) of the Act, and who is in possession of a foreign examination or academic qualification, must submit the following information in respect thereof to the council:
- (a) Curriculum of the course leading to such examination or qualification and a detailed syllabus of each subject in the course;
  - (b) duration of the course; and
  - (c) any other relevant information concerning the course.

**PART VII****REGISTRATION CERTIFICATES**

Section 20(2)

**Registration Certificates**

10. All registration certificates in terms of the Act shall be in the format set out in Annexure B.

**PART VIII****SCOPE, VARIETY, NATURE AND STANDARD OF PRACTICAL EXPERIENCE**

Section 20(2)(a)(iii)

**Practical Experience**

11. (1) Subject to the provisions of section 20(2)(a)(i) and (ii) of the Act and subrule (2), the council shall register an applicant in the category of professional if the council is satisfied that the applicant -
- (a) has attended a practice orientated workschool approved by the council and has passed the examination conducted at the end thereof;
  - (b) has passed a practical examination approved by the council or the Council Examination referred to in rule 8(b)(i) or (ii), as the case may be; and
  - (c) has gained practical experience of work in property valuation in the Republic as set out in this Part.
- (2) Persons registered as candidate valuers with effect from 1 May 2002 are not required to do the practical examination referred to in subrule (1), but will have to pass the Council's Examination referred to in rule 8(b)(i) or (ii), as the case may be.

**Scope, Variety, Nature and Standard**

12. It is the responsibility of a person who desires to be registered as professional associated valuer without restrictions, and his or her supervisor, to ensure that such person gains a sufficient scope, variety, nature and standard of practical experience of work in property valuation by having him or her exposed to as many of the following as possible:

(a) Purposes of property valuations:

- (i) purchase and sale;
- (ii) rental determination;
- (iii) financial institutions (bonds and security);
- (iv) investments;
- (v) leasebacks;
- (vi) Land Bank;
- (vii) expropriation;
- (viii) endowment;
- (ix) compensation related to town-planning schemes;
- (x) rating;
- (xi) deceased estates;
- (xii) financial statements; and
- (xiii) insurance; and

(b) types of properties:

- (i) vacant single residential land;
- (ii) vacant general residential land (flats);
- (iii) single dwellings;
- (iv) blocks of flats;
- (v) individual flats (sectional title);
- (vi) share block schemes;
- (vii) timeshare schemes;
- (viii) leasehold;
- (ix) vacant business land;
- (x) business properties;
- (xi) vacant industrial land;
- (xii) industries and warehouses;
- (xiii) potential township land;
- (xiv) partially developed townships;
- (xv) agricultural holdings;
- (xvi) servitudes;
- (xvii) land on which mines are situated;
- (xviii) farms; and
- (xix) special type properties, eg schools, churches, abattoirs.

**Assessment**

13. (1) To assess the practical experience of work in property valuation of an applicant for the purposes of section 20(2)(a)(iii) of the Act, the relative credits or weights assigned to the various cells in Annexure C, shall be applied to the number of property valuations indicated and substantiated by the applicant in the various cells in his or her application form submitted by him or her and shall be processed electronically to determine a total

credit or weight, which, together with the various types of properties valued by the applicant for different purposes of property valuations shall form the basis for assessment.

- (2) In determining the resultant credit or weight for any cell, all property valuations above 100 in that particular cell shall be ignored, and the total credit or weight referred to in subrule (1) shall be the sum of the resultant credits or weights for the various cells, divided by 100.

#### **Application of Assessment Outcome**

14. As a general norm, the minimum outcome reached in the assessment referred to in rule 13, shall -

- (a) in the case of registration as a professional valuer, be a credit or weight of 80 and 9 types of properties valued for four purposes of property valuation;
- (b) in the case of registration as a professional associated valuer without restrictions, be a credit or weight of 50 and eight types of properties valued for four purposes of property valuation;
- (c) in the case of registration as a professional associated valuer with restrictions, be a credit weight of 25 and one type of property valued for one purpose of property valuation.

#### **PART IX**

##### **AUTHORISED TITLES FOR SPECIFIED CATEGORY** Section 22(2)

###### **Titles**

15. A person registered in a specified category referred to in rule 6, must use the title applicable to his or her category of registration.

#### **PART X**

##### **RENEWAL OF REGISTRATION** Section 23

###### **Renewal of Registration**

16. For the purposes of section 23(1) of the Act, the Registrar shall at least six months prior to the expiry date of a registration referred to in rule 5, cause a written notice to be given to a registered person requesting him or her to apply at least three months prior to the expiry date of his or her registration, in the prescribed manner to the council for the renewal of his or her registration. (See rule 23, *infra*.)

**PART XI****COMPLAINT**  
Section 29(1)**Lodging of Complaint**

17. (1) Any person who feels aggrieved by an act or omission on the part of a registered person may lodge a complaint with the council.
- (2) A complaint shall -
  - (a) be in writing and in the form of an affidavit or an affirmation;
  - (b) contain the full name, business and postal addresses of the complainant;
  - (c) detail the specific act or omission relating to the alleged improper conduct which the registered person is charged with;
  - (d) include all supporting evidence relating to the complaint;
  - (e) identify witnesses who may be able to provide evidence in support of the complaint;
  - (f) indicate the complainant's willingness to -
    - (i) assist an investigation committee with the investigation or with the obtaining of material information in respect of the matter concerned; and
    - (ii) appear before a disciplinary tribunal at the time and place specified in a subpoena, to be questioned or to produce a book, document or object; and
  - (g) be signed by the complainant or by his or her duly appointed representative.
- (3) The council may of its own accord refer any information which comes to its notice and which *prima facie* indicates improper conduct on the part of a registered person to an investigating committee.

**PART XII****DISCIPLINARY TRIBUNAL**  
Section 31**Designation of Chairman**

18. The council shall designate a chairperson for a disciplinary tribunal appointed in terms of section 31 of the Act.

**PART XIII****DISCIPLINARY HEARING**  
Section 32**Conduct of Proceedings at Disciplinary Hearing**

19. (1) The chairperson of a disciplinary tribunal shall read the charge to the defendant and the defendant must then admit or deny the charge brought against him or her.
- (2) If the defendant admits the charge, the disciplinary tribunal may find the charge proved without hearing evidence or after hearing such evidence as it may deem necessary.

- (3) If the defendant denies the charge, the disciplinary tribunal shall proceed to hear evidence concerning the charge.

**Subpoena**

20. The subpoena in terms of section 32(2)(b)(i) of the Act shall be in the format set out in Annexure D.

**PART XIV****GENERAL****Amendment of rule 10 of Valuers' Rules**

21. Rule 10 of the Valuers' Rules is hereby amended by the deletion of subrules 10.1, 10.2 and 10.4.

**Repeal of rules 2, 3, 7 and 8 of Valuers' Rules**

22. Rules 2, 3, 7 and 8 of the Valuers' Rules are hereby repealed.

**Short title and commencement**

23. These rules shall be called the Rules for the Property Valuers Profession and shall, except for rules 5 and 16, commence on 1 May 2002.

**BOARD NOTICE 49 OF 2002**  
**HEALTH PROFESSIONS COUNCIL OF SOUTH AFRICA**

**RULES RELATING TO CONTINUING EDUCATION AND TRAINING IN OPTOMETRY  
AND DISPENSING OPTICIANS**

The Health Professions Council of South Africa has, in terms of section 26 of the Health Professions Act, 1974 (Act No. 56 of 1974), made the rules set out in the Schedule.

**SCHEDULE**

**DEFINITIONS**

1. In these rules "the Act" means the Health Professions Act, 1974 (Act No. 56 of 1974), and, unless inconsistent with the context -

"board" means the Professional Board for Optometry and Dispensing Opticians established by Government Notice R.75 of 16 January 1998;

"continuing professional development" means the continuing education and training referred to in section 26 of the Act and prescribed in terms of these rules;

"practitioner" means an optometrist or a dispensing optician registered in terms of the Act.

**REQUIREMENTS**

2. Any practitioner whose name on 1 April 2002 appears on the register of optometrists or the register of dispensing opticians kept in terms of section 18 of the Act, shall be required to comply with the conditions of continuing professional development laid

down in these rules as a prerequisite for such practitioner to retain his or her registration in terms of the Act.

3. Any person who, after 1 April 2002, registers for the first time in terms of the Act as an optometrist or a dispensing optician in any category of independent practice or public service, excluding a person who is registered for non-clinical purposes, shall be required to comply with the conditions of continuing professional development laid down in these rules, which shall be a prerequisite for such practitioner to retain his or her registration in terms of the Act.

4. A practitioner whose name had been erased from the register of optometrists or the register of dispensing opticians or who is registered for non-clinical purposes, shall be subject to compliance with any condition(s) which the board may specify prior to the restoration of the name of such practitioner to the relevant register for the purpose of rendering clinical services.

5. For the purpose of continuing professional development -

(a) every optometrist shall be required to accumulate at least 25 points within any one year, provided that any points accumulated during one year in excess of 25 points may be forwarded to the subsequent year only;

(b) every dispensing optician shall be required to accumulate at least 15 points within any one year, provided that any points accumulated during one year in excess of 15 points may be forwarded to the subsequent year only:

Provided further that, if the practitioner does not accumulate the prescribed minimum in any one year, he or she shall be permitted to obtain as many points as required in the subsequent year.

6. The points prescribed in rule 5 shall be accumulated by way of different educational or developmental activities accredited by the board in any of the following categories of activities:

(1) Organisational activities.

- (2) Small group activities.
- (3) Individual activities.
- (4) Any other activities or category of activities which the board may accredit from time to time.

7. During any one year, not more than 80% of the points may be obtained in any one category.

8.(1) In complying with the requirements, at least 2 points shall have to be obtained by every practitioner in professional ethics annually.

(2) During any one year, a maximum of 5 points may be obtained in non-clinical but health related activities.

9. Deferment of compliance with the requirements of continuing professional development may only be granted by the board on application to individual practitioners on submission of adequate reasons and subject to such requirements as the board may determine.

10. In the event of a practitioner not complying with the conditions specified in these rules within the prescribed period of time, the board may impose any one or more of the following conditions, namely –

- (a) grant the practitioner deferment for one extra year; or
- (b) require the practitioner to follow a remedial programme of continuing education and training as specified by the board; or
- (c) require the practitioner to write an examination as determined by the board; or

- (d) register the practitioner in a category of registration which shall provide for supervision regarded as appropriate by the board; or
- (e) register the practitioner in a category of registration restricted to non-clinical practice; or
- (f) erase the practitioner's name from the relevant register.
