UNIVERSITY OF THE WESTERN CAPE AMENDMENT OF STATUTE

The Council of the University of the Western Cape has, with the approval of the Minister of Education, under section 32 of the Higher Education Act, 1997 (Act No. 101 of 1997), made the amendments of the Statute set out in the Schedule hereto.

SCHEDULE

1. *General explanatory note:*

- [] Words in bold type in square brackets indicate omissions from existing enactments.
— Words underlined with a solid line indicate insertions in existing enactments.

2. In the Schedule, unless the context otherwise indicates, the expression "the Statute" means the Statute of the University of the Western Cape promulgated by Government Notice No. R.1300 of 15 June 1990, as amended by Government Notice No. R.335 of 3 March 1995; Government Notice No. 678 of 26 May 1999 and Government Notice No. 33 of 11 January 2002.

3. Paragraph 16P.1 of the Statute is amended by the insertions in paragraph 16P.1.8 of the following words:

16P.1.8 the directors of the different schools, centres and institutes of the University and such directors or heads of similar structure as decided upon by the council on the recommendation of the senate;

4. Paragraph 16U.1 of the Statute is amended by:

(a) omissions and insertions in paragraph 16U.1.1 of the following words:

16U1.1 [the chairperson of the senate, who shall be the chairperson] the rector, who shall be the chairperson;

(b) the omission of paragraph 16U1.2:

[16U1.2 the rector;];

(c) the correct renumbering of the following paragraphs:

[16U.1.3] 16U.1.2 the vice-rector, or if more than one vice-rector has been appointed, the vice-rectors;

- [16U.1.4] 16U.1.3 the registrar, or if more than one registrar has been appointed, the registrars;
- [16U.1.5] 16U.1.4 the executive director, or if more than one executive director has been appointed, the executive directors;
- [16U.1.6] 16U.1.5 the deans; and

(d) the insertion of paragraph 16U.1.6:

16U.1.6 the director of the division for lifelong learning.

5. Paragraph 18.6 is amended by insertions of the following words:

18.6 Notice of a meeting of the convocation with a short statement of the business to be considered, is placed by the secretary of the convocation in one local newspaper and one national newspaper at least 30 days before the day appointed for such meeting, or, alternatively and if practicable and feasible, such notice may be sent by the secretary of the convocation to each member to his or her registered address as it appears on the roll of the convocation at least 14 days before the day appointed for such meeting.

6. Paragraph 22.1 is amended by insertions and omissions of the following words:

22.1 Whenever the convocation has to elect a member of the council in terms of paragraph 16C1.10, the secretary of the convocation shall, by way [of a written notice which shall be posted not less than three months] of a notice placed in one local newspaper and one national newspaper at least two months before the date set by the council for the election, invite each member of the convocation to nominate in writing a person for a election a member of the council.

- [16C.1.12] 16C.1.11 een lid van georganiseerde besigheid in die Republiek van Suid-Afrika, deur sodanige organisasie verkies, met dien verstande dat, indien meer as een sodanige organisasie bestaan, die raad kan bepaal welke van die organisasies so 'n persoon mag verkies;

- [16C.1.16] 16C.1.15 een persoon, deur die Premier van die Provincie van Wes-Kaapland aangewys; en
- [16C.1.17] 16C.1.16 minstens vier en hoogtens agt addisionele persone, soos ingevolge paragraaf 16G bepaal mag word.
