**DELEGATION OF POWERS UNDER THE WORLD HERITAGE CONVENTION ACT, 1999
(ACT NO. 49 OF 1999)**

I, Mohammed Valli Moosa, Minister of Environmental Affairs and Tourism, hereby under the powers vested in me by section 43(1)(a) of the World Heritage Convention Act, 1999 (Act No. 49 of 1999) delegate the powers, fully described hereunder, to the incumbent and future incumbent of the undermentioned post in the Department of Environmental Affairs and Tourism.

| 13(1) | To authorise and ratify land claims negotiations and settlement agreements entered into or to be entered into by the Greater St. Lucia Wetland Park Authority over state land and/or private land forming part of or affecting World Heritage Sites. | Director-General |

| 17(1) | To ratify the employment contracts of members of the Executive Staff Component, for employment periods up to three years, and the temporary or permanent secondment of staff to the Greater St. Lucia Wetland Park Authority. This delegated power shall automatically lapse on the establishment of a board for the Greater St. Lucia Wetland Park Authority. | Director-General |

| 17(2) | To ratify the employment contract of the Chief Executive Officer appointed for the Greater St. Lucia Wetland Park Authority by the Minister. | Director-General |
| 31(1) | To transfer, with the concurrence of the responsible Minister and the Minister of Finance, immovable property belonging to the State, including but not limited to any immovable property under the control of the Department of Defence, to the Greater St. Lucia Wetland Park Authority. | Director-General |
| 31(3) | To ratify agreements entered into by the Greater St. Lucia Wetland Park Authority with landowners, including organs of state, for the acquisition of immovable property or rights in land for the purpose of incorporating such property or rights into the Greater St. Lucia Wetland Park. | Director-General |
| REGULATIONS 18(5) | To sign the Management Agreement and Schedule A thereto entered into by the Greater St. Lucia Wetland Park Authority, the KwaZulu-Natal Tourism Authority and the KwaZulu-Natal Nature Conservation Services as prescribed by regulation 18 in Government Notice 1193, published under the World Heritage Convention Act, 1999 (Act No. 49 of 1999) Government Gazette 21779 on 24 November 2000. | Director-General |
