THE INDEPENDENT COMMUNICATIONS AUTHORITY OF SOUTH AFRICA HEREBY GIVES NOTICE OF PUBLIC HEARINGS TO BE HELD IN TERMS OF PROVISION 4.1.1 (b) OF THE GENERAL NOTICE ISSUED BY THE MINISTER IN TERMS OF SECTION 35A OF THE TELECOMMUNICATIONS ACT (ACT NO. 103, 1996) AS AMENDED.

The Independent Communications Authority of South Africa hereby gives notice that public hearings will be held in relation to the applications for the 19% equity stake for the Second Network Operator. 
