

The Board on Tariffs and Trade (the Board) gave public notice of its investigation into the alleged subsidised export of PVC roll goods originating in or imported from India in *Government Gazette* No. 21483 dated 25 August 2000 (Notice No. 2939 of 2000).

On the basis of the information available the Board made a preliminary determination to recommend that the investigation be terminated.

The Board's Report No.4139, explaining the preliminary determination, was forwarded to all interested parties.

No comments were received in respect of the preliminary report.

In the final determination it was found that PVC based roll goods were being exported at subsidised prices into the SACU market, that the SACU industry suffered material injury, and that there was a causal link between the subsidisation and the material injury experienced by the SACU industry. However, in the light of the magnitude of the anti-dumping duties imposed against India, it was concluded that no countervailing duties should be imposed on PVC based roll goods originating in or imported from India.

The Board therefore made a final determination, as contained in its Report No. 4159, to recommend the termination of the investigation. The recommendation was accepted by the Minister of Trade and Industry.

The investigation has therefore been terminated.
