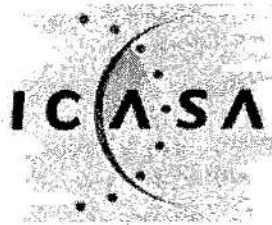

NOTICE TO THE PUBLIC REGARDING THE WITHDRAWAL OF FREQUENCIES 89.1 MHz AND 107.5MHz AND ITS REPLACEMENT BY FREQUENCIES 107.5 MHz AND 90.4MHz IN THE WESTERN CAPE PROVINCE TYGERBERG AND CAPE TOWN SENTECH SITES RESPECTIVELY

The Independent Communications Authority of South Africa hereby gives notice that in the interest of orderly frequency management and in order to ensure that there is no unacceptable level of interference as required by section 29 of the Independent Broadcasting Authority Act, 153 of 1993, as amended:

1. Frequency 89.1 MHz is hereby withdrawn from licence area 46A of the Western Cape;
2. That the aforesaid frequency is hereby replaced by frequency 107.5 MHz for community sound broadcasting services at the Tygerberg Sentech site with a maximum effective radiated power of 5 kilowatts;

3. That the frequency 107.5MHz, which is categorised for commercial sound broadcasting service is hereby withdrawn from the Cape Town Sentech site and is hereby replaced with the frequency 90.4MHz;
4. That CCFM (a four year community sound broadcasting licensee in licence area 46A of the Western Cape) has been assigned 107.5 MHz frequency with a maximum effective radiated power of 250W
5. That these amendments to the frequency plan as previously published shall take effect from date of publication of this notice.
