The Minister for Justice and Constitutional Development intends introducing the Criminal Procedure Amendment Bill, 2002, in the National Assembly shortly. The explanatory summaries of the Bill is hereby published in accordance with Rule 241(c) of the Rules of the National Assembly.

The Bill aims to substitute sections 309B and 309C of the Criminal Procedure Act, 1977 (Act No. 51 of 1977), so as to further regulate appeals against decisions of the lower courts.
