APPLICATION FOR REGISTRATION OF HERALDIC REPRESENTATIONS AND OBJECTIONS THERETO

The undermentioned bodies and persons have applied in terms of section 7 of the Heraldry Act, 1962 (Act No. 18 of 1962), for registration of their heraldic representations. Anyone wishing to object to the registration of these heraldic representations on the grounds that such registrations will encroach upon rights to which he or she is legally entitled should do so within one month of the date of publication of this notice upon a form obtainable from the State Herald, Private Bag X236, Pretoria, 0001.

1. **Applicant: Matzikama Municipality (H4/3/2/695)**

Arms: Per chevron embowed Vert and Argent, in chief dexter a bunch of grapes Argent slipped and leaved Or, sinister a daisy slipped and leaved Or, in base five barrulets wavy Azure surmounted with a crayfish proper; on a chief Azure, a representation of the Maskam mountain Or.

Crest: A mural crown Vert, the wall consisting of two rows of bricks Or, masoned Sable.

Mantling: Vert and Argent.

Motto: PROSPERITAS PER LABOR

2. **Applicant: Lejweleputswa District Municipality (H4/3/2/699)**

Arms: Per fess Azure and Argent, on a fess enhanced Gules, a sun Argent, in chief a spoked demi-cogwheel issuant Or; in base, on a chevron embowed Azure, four barrulets wavy Argent, between dexter a shovel and a pickaxe in saltire proper, and sinister a maize cob Or, slipped and leaved Vert; at honour point a protea flower Gules seeded Argent. The shield is ensigned of a rustic mural crown Brunâtre, masoned Sable, heightened on the crenellations and crenelles with representations of bound wooden palisades.

Supporters: On either side a dove with wings displayed Argent.

Special compartments: A compartment consisting of representations of goldmine dumps proper.

Motto: TOGETHER WE CAN BUILD

3. **Applicant: Namakwa District Municipality (H4/3/2/704)**

Arms: Per fess enhanced wavy Azure and Or, in chief above a barrulet wavy Argent, a daisy proper between two faceted diamonds Argent, and in base on a mount Vert two springbok rampant addorsed proper. The shield is ensigned of a rustic mural crown Brunâtre masoned Sable, charged with a bar Argent, thereupon another Azure.

Supporters: On either side a pygmy falcon proper statant on a compartment Murray.

Motto: IGÄHOSIB

4. **Applicant: Gariiep Municipality (H4/3/2/709)**

Arms: Per pale serpentine Vert and Argent, over the partition line a bar per pale serpentine counterchanged, in chief a bell Argent with sixteen rays issuant Or, and in base a blue crane proper.

Motto: UNITED WE STAND, DEVIDED WE FALL

5. **Applicant: Ga-Segonyana Municipality (H4/3/2/711)**

Arms: Per saltire Argent and Vert, a saltire per saltire Sable and Or, between in chief a sun Gules, in the dexter and sinister flanks respectively a bull and a merino ram head caboshed Argent, and in base a tree proper; over all at fess point, a fountain. The shield is ensigned of a mural crown Or.

Motto: PROSPERITY

6. **Applicant: Endumeni Municipality (H4/3/2/719)**

Arms: Per chevron Argent and Or, in fess two barrulets gemelles wavy Azure, surmounted in the shield flanks by two wildebeest addorsed rampant Sable, over the partition two spears in saltire Gules, points Argent, in chief on a chevron couped in the form of the Indumeni peak Azure, a miner's lamp Or, and in base below a bull's head caboshed proper, three barrulets Vert. The shield is flanked by two guineafowl feathers proper and ensigned by a coronet consisting of a circlet Or, embellished with lozenges Sable (seven visible), heightened of four maize cobs Argent, leaved Or (three visible), alternated with as many ears of wheat Or.

Motto: TOGETHER IN PROSPERITY

7. **Applicant: Amahlati Municipality (H4/3/2/723)**

Arms: Per fess dancetty enhanced fir tree topped Argent and Vert, in fess two aloe trees Or, flowered Gules and in base on a chevron Argent, a base Vert, thereupon a traditional Xhosa hut proper; a chief dancetty Azure; the whole within a bordure Gules. Behind the shield two spears in saltire surmounted by a traditional staff erect proper.

Motto: TOGETHER FOR PROSPERITY

8. **Applicant: Nquthu Municipality (H4/3/2/733)**

Arms: On a traditional oxhide shield Argent and Brunâtre at random proper, a bar enhanced Sable, the upper edge in the form of the Isandlwana mountain, embellished with a traditional crocodile tooth necklace Argent. Behind the shield representations of a traditional axe (isizenze) and Cetshwayo's staff in saltire, surmounted by a traditional staff erect, the upper and covered with five leather thongs palewise, three Sable and two Argent alternating.

Ondergenoemde instansies en persone het kragtens artikel 7 van die Heraldiekwet, 1962 (Wet No. 18 van 1962), aansoek gedoen om die registrasie van hulle heraldiese voorstellings. Enigeen wat teen die registrasie van hierdie heraldiese voorstellings beswaar wil aanteken op grond daarvan dat sodanige registrasie inbreuk sal maak op regte wat hom of haar wettiglik toekom, moet dit binne een maand na die datum van publikasie van hierdie kennisgewing doen op 'n vorm wat van die Staatsheraldikus, Privaatsak X236, Pretoria, 0001, verkrygbaar is.

1. **Aansoeker: Matzikama Munisipaliteit (H4/3/2/695)**

Wapen: Ingeboë kepersgewys verdeel van groen en silwer, in die skildhoof regs 'n silwer driuwetros goud gestengel en geblaar, links 'n madelief gestengel en geblaar van goud, en in die skildvoet vyf golwende blou dwarsbalke, daaroorheen 'n kreef van natuurlike kleur; op 'n blou skildhoof 'n weergawe van die Maskamberg van goud.

Helmtteken: 'n Groen helmkroon, die muur bestaande uit twee rye goue stene, swart gemessel.

Dekklede: Groen en silwer.

Wapenspreuk: PROSPERITAS PER LABOR

2. **Aansoeker: Lejweleputswa Distriksmunisipaliteit (H4/3/2/699)**

Wapen: Deursnede van blou en silwer, op 'n verhoogde rooi dwarsbalk 'n silwer son, in die skildhoof 'n gespeekte uitkomende halwe goue tandrat; in die skildvoet 'n geboë blou keper, daarop vier silwer golwende streepbalke tussen regs 'n skuinsgekruiste skopgraaf en pik van natuurlike kleur en links 'n goue mieliekop, groen geblaar; op die erepunt 'n rooi proteablom silwer gesaad. Die skild is oortop van 'n rustieke bruin muurkroon, swart gemessel, die kantele en kanteelkepe verhoog voorstelling van gebinde palissadehoutpale.

Skildhouders: Aan beide kante 'n silwer duif met gespreide vlerke.

Spesiale kompartement: 'n Kompartement bestaande uit voorstellings van goudmynhope van natuurlike kleur.

Wapenspreuk: TOGETHER WE CAN BUILD

3. **Aansoeker: Namakwa Distriksmunisipaliteit (H4/3/2/704)**

Wapen: Golwend deursnede van blou en goud, in die skildhoof bokant 'n golwende silwer streepbalk 'n goue madeliefblom tussen twee gefasetteerde silwer diamante, en in die skildvoet op 'n groen grond twee toegewende klimmende sprinbokke van natuurlike kleur. Die skild is oortop van 'n rustieke bruin muurkroon, swart gemessel, belaa met 'n silwer dwarsbalk, daarop 'n ander van blou.

Skildhouders: Aan beide kante 'n dwergvalk van natuurlike kleur, staande op 'n maroen grond.

Wapenspreuk: IGÄ!IOSIB

4. **Aansoeker: Gariep Munisipaliteit (H4/3/2/709)**

Wapen: Slangsnitgewys gedeel van groen en silwer, oor die snylyn heen 'n paal slangsnitgewys verdeel van die een in die ander, in die skildhoof 'n silwer klok daaromheen sestien uitkomende goue strale, en in die skildvoet 'n bloukraanvoël van natuurlike kleur.

Wapenspreuk: UNITED WE STAND, DEVIDED WE FALL

5. **Aansoeker: Ga-Segonyana Munisipaliteit (H4/3/2/711)**



BOARD ON TARIFFS AND TRADE**NOTICE OF FINAL DETERMINATION OF AN REVIEW INTO THE ANTI-DUMPING DUTY ON CARBON BLACK ORIGINATING IN OR IMPORTED FROM EGYPT**

The Board on Tariffs and Trade (the Board) gave public notice of its investigation into the review of the anti-dumping duty originating in or imported from Egypt in *Government Gazette* No.22414 dated 29 June 2001 (Notice No. of 1587). The scope of the investigation was published to cover the anti-dumping duty and the allegation of duty absorption only, therefore injury and causality were excluded.

In the final determination it was found that duty absorption took place between 1997/98 and 2000. However, the Board made a final recommendation that the existing anti-dumping duty of 15.7 per cent on carbon black originating in or imported from Egypt, classifiable under tariff subheading 28.03, be kept unchanged since there was a lack of imports.

The Petitioner requested that the anti dumping duties be extended for five years , but Article 11.3 of the Anti-Dumping Agreement provides that an anti-dumping duty may only remain in place for a maximum of 5 years since the imposition thereof or since the last review that covered both dumping and injury. As this review covered only dumping, the request was rejected.

The Board therefore made a final determination, as contained in its Report No 4189, and recommended that the existing anti-dumping duty on carbon black originating in or imported from Egypt, be kept unchanged. The recommendation was accepted by the Minister of Trade and Industry.

On 05 February 2002, the Board on Tariffs and Trade (the Board) formally initiated a review of the anti-dumping duties on aluminum hollowware originating in or imported from Egypt and originating in the PRC and imported from Hong Kong and/or the PRC, through Notice No. 177 of *Government Gazette* No. 23092.

After considering comments from the interested parties submitted to the Board in respect of this review investigation, the Board made a final determination that the expiry of the duty was likely to lead to continuation or recurrence of dumping and material injury.

The Board therefore recommended to the Minister of Trade and Industry that the anti-dumping duties on aluminum hollowware originating in or imported from Egypt and originating in the PRC and imported from Hong Kong and/or

the PRC be maintained. The Board's recommendation was approved by the Minister of Trade and Industry.
